# SENATE BILL NO. 1167 SD 1 RELATING TO AGRICULTURAL ENTERPRISES

Chairperson Creagan and Members of the Committee:

Thank for the opportunity to testify on Senate Bill 1167 SD1 relating to agricultural enterprises. This bill establishes a new agricultural enterprise program within the Hawaii Department of Agriculture and makes an appropriation. The Department strongly supports this measure.

This bill is intended to allow agricultural enterprises on lands under the jurisdiction of the Department. The Department's Ag Park program and the Non-Ag Park program focus on actual, physical farming activity on the land. Limited ancillary activity is allowed only under very narrow conditions and circumstances. Moreover, strict eligibility requirements as a bonafide farmer must be met to hold any long-term lease under both programs. However, the agricultural industry must adapt to rapid developments in technology and methodology in agriculture and aquaculture to attain the food sustainability goals of the State. The Department needs flexibility in its disposition of public lands to support those changing conditions by allowing and encouraging the use of innovative agricultural models to optimize productivity, supporting and promoting agriculture through farmers markets, food hubs and processing facilities, animal feed mills, etc., and enabling or providing agricultural educational training. The business of agriculture is far broader than simply the growing



of an organism. This program recognizes that the business of agriculture is just as important to the growth of agriculture as the production of the crop itself.

The original version of measure included the establishment of funding for the following three (3) new positions within the agricultural resource management division of the Department: one full-time equivalent (1.0 FTE) engineer V position (SR26); one full-time equivalent (1.0 FTE) property manager V position (SR24); and one full-time equivalent (1.0 FTE) information technology (Band C) position (SR24). The Department believes the additional positions are critical to effectively implement the program and ensure that it can properly address the production needs of the State's numerous small farmers and meet our food sustainability goals.

The Department respectfully recommends the following amendments:

- 1. Reinstate the three positions and funding of \$600,000 contemplated in the original version of the measure;
- 2. Appropriate \$600,000 as seed and development funding for establishment and initial operation of the program;
- 3. Clarify the Agribusiness Development Corporation's authority to disallow proposed actions under this program by revising Section -3(b) as follows:
  - "(b) The agribusiness development corporation may disallow any action taken pursuant to subsection (a) that it determines will conflict or interfere with its scope of responsibilities, or is more appropriately conducted by the agribusiness development corporation, provided:
    - The agribusiness development corporation shall notify the department of any disallowance in writing within sixty days of receiving notice from the department;
    - 2. Tenant financed improvements under this program shall not be subject to disallowance;
    - Upon disallowance, the agribusiness development corporation shall assume the development rights and obtain management jurisdiction to build the improvements contemplated by the action and commence construction within three years from the date of disallowance; and

4. Development rights and management jurisdiction for the action shall revert to the department if the agribusiness development corporation has not commenced construction within three years of the date of disallowance.

Upon receipt of the agribusiness development corporation's notice of disallowance, the department shall desist from taking action, subject to the conditions above."
