The Department of Environmental Services of the City and County of Honolulu (ENV) strongly supports the goals of the Aloha + Challenge and submits the following comments on the subject bill.

Waste-to-energy should be included among the solid waste management strategies identified in this bill to reduce solid waste prior to disposal. The City's H-POWER waste-to-energy facility processes 700,000 tons of waste per year, reducing the volume of waste by up to 90% prior to landfill disposal. Additionally, H-POWER is capable of generating up to 90 megawatts of reliable, renewable power for Oahu, reducing Hawaii's dependence on imported oil and advancing the State's commitment to achieving 100% renewable energy by 2045.

My name is Murray Clay and I am Managing Partner of the Ulupono Initiative, a Hawai'i-based impact investment firm that strives to improve the quality of life for the people of Hawai'i by working toward solutions that create more locally produced food; increase affordable, clean, renewable energy; and better manage waste and fresh water resources. Ulupono believes that self-sufficiency is essential to our future prosperity and will help shape a future where economic progress and mission-focused impact can work hand in hand.

**Ulupono supports SB 1242 SD 2 HD 1**, which updates the Department of Health's solid waste management goals to align with the Aloha+ Challenge, because it aligns with our goal of reducing waste in Hawai'i.

As an island state, Hawai'i is responsible for handling and diverting its waste streams. Waste goals help to unify a shared outcome expectation amongst various stakeholders.
