Title of Bill: SB 0012 RELATING TO TEACHER HOUSING.

Purpose of Bill: Authorizes the Hawaii housing finance and development corporation to

develop and implement a housing voucher program for full-time teachers employed by the department of education or at a public

charter school.

Department's Position:

The Department of Education (Department) supports SB 114, with comments.

SB 12 aligns with Goal 2 of the Department's Strategic Plan of focusing on increasing the pipeline of new teachers entering the education profession and increasing teacher retention rates.

Housing subsidy vouchers can be a tool to increase the Department's teacher retention, especially in hard-to-fill geographic areas. According to a 2016 report by the Learning Policy Institute, housing incentives was one factor for teachers who left the profession in their consideration in returning to the field of education. The financial assistance provided through the voucher program may help to ease some of the financial burden, magnified by high cost of living in Hawaii.

The Department also notes that hard-to-fill schools may also employ half-time teachers. Based on the proposed language, only those individuals working as full-time (1.0 FTE) teachers would be eligible for the home assistance program. Further, should the committee proceed with this measure, the Department requests consideration for a blank appropriation at this time, to further discuss the funding that may be necessary for a housing voucher program.

Dear Chairs Kidani and Chang and Members of the Committees,

The Special Education Advisory Council (SEAC), Hawaii's State Advisory Panel under the Individuals with Disabilities Education Act (IDEA), strongly supports the intent of S.B. 12 which creates a housing voucher program for full time teachers.

As you know, Hawaii suffers from a chronic shortage of qualified teachers for our public school students. The shortage is most acute for special education teachers who teach some of our most vulnerable students. This school year, only 84% of special education teaching positions were filled by individuals who had completed a state approved teacher education program. Of those teachers, a fair percentage have only general education training.

Retention of qualified teachers is also a growing problem. Last school year saw the most common reason cited by exiting teachers (38%) was moving out of state. We know from exit surveys that the high cost of living (and in particular, housing) was a major factor in the decision to leave Hawaii.

Given the critical personnel shortage to adequately serve the needs of special education students, we ask that your committees consider designing the voucher program to prioritize hard-to-fill teaching positions.

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus supports SB 12, relating to teacher housing, which authorizes the Hawai'i Housing Finance and Development Corporation to develop and implement a housing voucher program for full-time teachers employed by the department of education or at a public charter school.

Currently, Hawai'i teachers experience the lowest salaries for their profession in the nation, when those salaries are adjusted for the cost of living. At the same time, island housing and rental prices are continuing to skyrocket. According to the Honolulu Board of Realtors, the median single-family home price in Honolulu hit a record \$812,500 in September of 2018, for example, while an analysis of rental values performed by ATTOM Data Solutions released earlier this year found that Honolulu's rentals are the second-least affordable in the country relative to wages.

The average Hawai'i public school teacher earns approximately \$58,000, which, on O'ahu qualifies as "low income", per the U.S. Department of Housing and Urban Development. Until teacher pay is significantly increased—as it should be—we believe housing assistance may help curb Hawai'i's teacher shortage crisis, which now stands at 1,029 positions statewide.

Given that this measure provides vouchers for teacher housing, OCCLP supports this measure as teacher housing may be considered as part of teachers' competitive wage based on National standards while taking into consideration our State's cost of living

For these reasons, the OCCLP supports and urges the passage of SB 12 out of the Committee on Education and the Committee on Housing.
