On the following measure: S.B. 1329, RELATING TO THE SALARY OF THE PUBLIC UTILITIES COMMISSIONERS

Chair Baker and Members of the Committee:

My name is Catherine Awakuni Colón, and I am the Director of the Department of Commerce and Consumer Affairs (DCCA or Department). The Department supports this bill.

The purpose of this bill is to align the salary of: (1) the Public Utilities

Commission (PUC or Commission) chair with the highest pay tier of a supervising
deputy attorney general; and (2) the other PUC commissioners with the lowest pay tier
of the first deputy attorney general.

The Commission protects the public interest by overseeing and regulating public utilities to ensure they provide reliable service at reasonable and just rates. In particular, the PUC: regulates all registered public utility companies operating in the State; reviews and approves rates, tariffs, charges, and fees; determines the allowable rate of earnings in establishing rates; issues guidelines concerning the general

management of utility businesses; and acts upon requests for the acquisition, sale, disposition, or other exchange of utility properties. Given the Commission's complex scope of work, it is important that the State raise the salaries of the PUC chair and commissioner to attract and retain the most qualified candidates for these positions. In addition, this measure would help mitigate the significant travel expenses of candidates who are residents of a county other than the City and County of Honolulu. By raising the salaries of the PUC chair and commissioners, the State may be able to attract qualified candidates from neighbor islands and diversify the PUC's representation.

DESCRIPTION: Aligns the salary of the public utilities commission chair with the highest pay tier of a supervising deputy attorney general. Aligns the salary of the other PUC commissioners with the lowest pay tier of the first deputy attorney general.

POSITION:

The Public Utilities Commission is in **support** of this measure and offers the following comments for consideration.

COMMENTS:

The Public Utilities Commission ("Commission") is in support of this measure, which would provide an increase in compensation for members of the Commission.

The Commission regulates all chartered, franchised, certificated, and registered public service companies operating in the State of Hawaii that provide electricity, telecommunication, gas, private water and sewage, motor and water carrier transportation services and other entities as required by law. During fiscal year 2017-2018, the Commission regulated 1,806 public utilities and other entities in the Hawaii with revenues totaling more than \$2.5 billion. In carrying out its duties, the Commission issued a total of 862 decisions and orders during the fiscal year.

In recent years, the Commission's workload has grown substantially, particularly in the electricity sector where complex issues relating to the State's 100% Renewable Portfolio

Standard and other energy policies continue to be investigated. By permitting a salary increase for Commissioners, the State may be able to continue to attract qualified candidates to serve on the Commission in the future.
