#### RELATING TO CESSPOOLS

Senate Bill (S.B.) No. 1370: establishes the Cesspool Compliance Grant Program within the Department of Hawaiian Home Lands to assist lessees in upgrading or converting a cesspool on Hawaiian home lands to a septic system or aerobic treatment unit system, or connecting a cesspool to a sewerage system; creates the Cesspool Compliance Grant Program Special Fund that would generate revenues through legislative appropriations; appropriates an unspecified sum of general funds in FY 20 for deposit into the special fund; and appropriates an unspecified sum of special funds in FY 20 and FY 21 to implement the cesspool grant program.

As a matter of general policy, the department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program

and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to S.B. No. 1370, it is difficult to determine whether the proposed special fund would be self-sustaining, or why the program cannot be implemented under the general fund appropriation process.

The Department of Taxation (Department) provides the following comments regarding S.B. 1370 for your consideration.

S.B. 1370 establishes a grant program and special fund to assist lessees on Hawaiian home lands with cesspool upgrade, conversion, or connection costs. It also provides that a recipient of such grant is not eligible for the cesspool upgrade, conversion, or connection income tax credit and vice versa. The measure is effective upon approval and applies to taxable years beginning after December 31, 2018.

The Department supports the concept of a grant program because it believes that grants are far more preferable than tax credits in assisting taxpayers that are truly in need of the assistance. The Department is able to administer the change to the cesspools tax credit as proposed by this measure with its current effective date.

- 1 **Fiscal Implications:** This measure may impact the priorities identified in the Governor's
- 2 Executive Budget Request.
- 3 **Department Testimony:** We appreciate and support the intent of this initiative, but defer to the
- 4 Governor's Executive Budget Request for the Department of Health's (Department)
- 5 appropriations and personnel priorites. Cesspools are a major source of pollution to Hawaii's
- 6 waters. There are approximately 88,000 cesspools in the State, discharging approximately
- 7 53 million gallons of untreated sewage into the ground water every day. Ground water flows
- 8 into drinking water sources; since ninety-five percent of all drinking water in Hawaii comes from
- 9 ground water sources, this cesspool pollution can potentially harm human health.
- There is an urgent need to protect the public health and environment with cesspool
- upgrades as soon as feasible. These upgrades can be to connect to sewer, septic systems or any
- other individual wastewater systems that comply with the Department's Chapter 11-62, Hawaii
- 13 Administrative Rules.
- The cost of cesspool upgrades is high, averaging \$20,000 and \$30,000. The Department
- is open to various forms and strategies of financial support for homeowners who upgrade.
- Expanded tax credits and grants are two possible options that would help homeowners afford the
- phasing out of cesspools.

- Although this measure addresses a small part of the overall problem with cesspools by
- 2 establishing a grante program for the Department of Hawaiian Home Land properties, we
- 3 consider this to be a step in the right direction.

Dear Chair Gabbard, Chair Shimabukuro, and Committee Members,

I thank you for the opportunity to provide testimony in support of SB 1370, establishing in the Department of Hawaiian Home Lands a cesspool compliance grant program.

Without some form of cost mitigation mechanism similar to that offered to the cesspool upgrade, conversion, or connection income tax credit, the financial impacts of the conversion requirements by 2050, as required by HRS 342D-72, will be a major burden on Hawaiian Home Lands beneficiaries. As the original leases expire over the next 30 years, DHHL will need to find new ways to encourage full compliance with this law. SB 1370 is a step in the right direction.

This bill is in line with the purpose of the Hawaiian Homes Commission Act of 1920 (Section 101(b)(5): "Providing financial support and technical assistance to native Hawaiian beneficiaries of this Act so that by pursuing strategies to enhance economic self-sufficiency and promote community-based development, the traditions, culture, and quality of life of native Hawaiians shall be forever self-sustaining.")

Again, I thank you for hearing this bill and I urge its passage through your Joint Committee.

EXECUTIVE SUMMARY: Establishes a cesspool compliance grant program to assist beneficiaries on Hawaiian home lands. Prevents duplication with the cesspool upgrade, conversion or connection income tax credit.

SYNOPSIS: Adds a new section to chapter 342D, HRS, establishing a cesspool grant program and special fund. Provides that the Department of Hawaiian Home Lands (DHHL) shall be exempt from section 235-116 and may periodically share with the department of taxation the cesspool compliance grant recipient's tax identification number and other information necessary to ensure cesspool compliance grant recipients do not also claim the cesspool upgrade, conversion, and connection income tax credit established in section 235-16.5.

Amends section 235-16.5, HRS, which now provides for the tax credit, to provide that a taxpayer may claim either the grant or the tax credit, but not both. Taxpayers who already have claimed the tax credit will be ineligible for the grant.

EFFECTIVE DATE: Upon approval.

STAFF COMMENTS: The proposed grant program and the existing tax credits duplicate each other to a degree, so it makes sense to prevent double dipping.
