#### In consideration of SENATE BILL 1526, SENATE DRAFT 1 RELATING TO CONSERVATION ENFORCEMENT

Senate Bill 1526, Senate Draft 1 proposes to appropriate funds for one DOCARE DLNRTip app administrator position and software upgrades and app enhancements to improve the DLNRTip application. The Department of Land and Natural Resources (Department) supports this measure, provided that its passage does not replace or adversely impact the priorities identified in the Executive Budget request.

This request would make an appropriation of funds to upgrade the DOCARE DLNRTip app and establish an app administrator position resulting in enhanced collection and distribution of information for in progress and changing incidents requiring a law enforcement response. The Department believes this will benefit by creating positive interaction with the public and increase opportunities for information gathering.
