Statement of **MIKE MCCARTNEY** Director Department of Business, Economic Development, and Tourism before the SENATE COMMITTEE ON JUDICIARY AND SENATE COMMITTEE ON WAYS AND MEANS Tuesday, February 26, 2019 10:05 AM State Capitol, Conference Room 211 In consideration of SB 1529, SD 1 RELATING TO THE HAWAII ENERGY AND CLIMATE CHANGE OFFICE.

Chairs Rhoads and Dela Cruz, Vice Chairs Wakai and Keith-Agaran and Members of the Committees.

The Department of Business, Economic Development, and Tourism (DBEDT) offers comments on SB 1529, SD 1, which establishes the Hawaii State Energy Office and the Deputy Director of Energy, amends and transfers the duties of the Energy Resources Coordinator from the DBEDT Director to the Deputy Director of Energy. It also repeals the Energy Security Special Fund and directs that fees from variances under Hawaii Revised Statutes (HRS) Section 196-6.5 be deposited to an unspecified fund and that the renewable energy facilitator position be funded by a different source. Moreover, the Hawaii State Energy Office would be funded by general revenues of an unspecified amount.

The environmental response, energy, and food security tax through the energy security special fund has been an important source of funding for DBEDT's energy operations. It is imperative that current funding levels be at least maintained for DBEDT to continue its operations in support of Hawaii's clean energy initiatives.

DBEDT notes that creating another office takes careful planning and consideration of not only the employees but also budgetary issues. Without such planning, it would be premature to create another office as being proposed by this measure. We are open to discussion and dialogue with the Chairs of the committees to hear your concerns.

We respectfully ask that the Legislature please minimize any negative impacts to the Governor's budget priorities.

We note the title of this measure refers to the Hawaii Energy and Climate Change Office but there is no mention of such in the current form of this bill. Thank you for the opportunity to offer testimony on this bill.
