S.B. 2005 RELATING TO VOTING

Senate Committee on Transportation

The Department of Transportation (DOT) supports with amendments, S.B. 2005.

Pursuant to Section 286-172, Hawaii Revised Statutes, the Director of Transportation has the authority to determine the distribution of the personal information contained in the driver license and civil identification statewide traffic records system. The Federal Drivers Privacy Protection Act, 18 U.S.C. §2721, prohibits the release and use of data to any government agency except when used to carry out its function. Similarly, Section 92F-19, Hawaii Revised Statutes, limits the disclosure of government records to any other agency unless it is necessary for the performance of the requesting agency's duties and functions. Therefore, we do not support giving the chief election officer full access to the driver license and State ID file as proposed in SECTION 1 (d) of the bill. This will result in a direct conflict with Federal and existing State laws.

A Memorandum of Agreement (MOA) between the DOT and Office of Elections was signed by both parties on August 2017. Sections 1, 2, 5 and 6 are addressed in the agreement. Therefore, the bill only needs to include Sections 3, 4 and 7.

Further, should there be a need to modify the voter registration form, DOT and the Office of Elections will continue to work collaboratively as they have already demonstrated with the current application forms to ensure the driver's license application form and civil identification card application form reflects any State or Federal legislated requirements.

Chair Inouye and members of the Senate Committee on Transportation, thank you for the opportunity to testify in support of Senate Bill No. 2005. This bill requires that any person who is eligible to vote and applies for a new or renewal motor vehicle driver license, provisional license, or instruction permit, or a new, renewal, or duplicate identification card be automatically registered to vote if that person is not already registered to vote unless the applicant affirmatively declines to be registered to vote; and authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver license or identification card information to election officials and the statewide voter registration system.

This bill will increase the opportunities for members of our community to register to vote, as it requires the applicant to directly address the question of whether they want to register to vote or to opt out as part of the driver license and identification card application process.

Additionally, this bill ensures the accuracy of the voter registration rolls by electronically transmitting voter registration data between the driver license and identification card database and the statewide voter registration system. The electronic sharing of data between driver licensing officials and election officials will help to ensure timely compliance with the National Voter Registration Act and the Help America Vote Act. 52 USC §21083(a)(5)(B) & 52 USC §20504.

Finally, as we transition to elections by mail, we would propose the bill be amended to remove the references to requesting a permanent absentee ballot as Testimony on SB 2005 – Relating to Voting January 29, 2020 Page 2

all voters will automatically be sent a ballot to their mailing address associated with their voter registration.

Chair Inouye and members of the Senate Committee on Transportation, thank you for the opportunity to testify in support of Senate Bill 2005. This bill will require that any person who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification card be automatically registered to vote if that person is not already registered to vote, unless the applicant affirmatively declines to be registered to vote. It would also authorize access to and electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver's license or identification card information to election officials and the statewide voter registration system.

This bill will help to ensure the accuracy of the voter registration rolls by electronically sharing data between driver licensing officials and election officials. This will not only support timely compliance with laws on the federal level (National Voter Registration Act and the Help America Vote Act), but will also provide additional opportunities to ensure voter's addresses are up to date – a critical component of the implementation of Act 136 (SLH 2019), voting by mail.

Additionally, this bill will provide another opportunity for individuals to register to vote, by requiring that they address the matter as part of the driver license and identification card application process. Providing opportunities to register to vote during other civic and routine activities, such as obtaining a license or identification, can help increase voter registration and reduces barriers to participation in the election process.

Please also consider the proposed amendments suggested by the Office of Elections to remove references to requesting a permanent absentee ballot. Beginning in 2020, all voters will be sent a ballot to their mailing address associated with their voter registration, pursuant to Act 136 (SLH 2019).

Chair Inouye and Committee Members:

Thank you for the opportunity to submit testimony in support of Senate Bill No. 2005. This Bill would require that any person who is eligible to vote and applies for a new or tries to renew their motor vehicle driver's license, provisional license, or instruction permit, or tries to obtain a new, or renews, or obtains a duplicate identification card, they will be automatically registered to vote if they are not already registered to vote unless they affirmatively decline to be registered to vote. Additionally, the Bill authorizes access to an electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver's license or identification card information which would be provided to election officials and the statewide voter registration system.

The Bill will establish an efficient and reliable means for transferring voter registration information from the examiner of drivers to the county clerks, and will also simplify the registration process for individuals obtaining a new or renewing a Hawai'i driver license, provisional license, instruction permit, or State identification card. Requiring applicants to affirmatively decline to register vote will ensure that only the registration information from individuals wishing to register will be transmitted to the respective county clerk.

Since the State of Hawai'i will be transitioning to elections administered primarily by mail beginning with the 2020 Elections, we propose eliminating references to a permanent absentee ballot as this concept is no longer applicable.

Chair Inouye, Vice-Chair Harimoto, and Committee Members:

The League of Women Voters of Hawaii strongly supports SB 2005. Seventeen states and the District of Columbia have passed this reform¹, and last year 10 bills were introduced in Hawaii with widespread support. The demand signal from the public is clear - they want "Opt-Out" Automatic Voter Registration (AVR).

"Opt-Out" AVR builds upon Congress's findings in the National Voter Registration Act of 1993 that 1) voting is a fundamental right and 2) it is the duty of governments to promote the exercise of that right². This bill empowers voters by letting them affirmatively choose whether their information is used to update their registration, or to register them at all, when they interact with the Department of Motor Vehicles "Opt-Out" AVR will promote - but not mandate - registration by making it convenient and cost-effective.

"Opt-Out" AVR would also help the state keep the voter registration rolls more accurate. The same proven and secure processes are used to update a voter's information. The measure complements voting by mail, since accurate registration information avoids errors in ballot delivery and reduces demand for registration services at Voter Service Centers. The savings in time and money add up quickly

Language in the bill provides that applicants for a Provisional driver's license be automatically registered to vote. Our understanding is that such licenses are issued to citizens 16 years of age, but not yet 18. It appears that the intent of including provisional licenses was to permit drivers under 18 to preregister to vote, since they are not currently old enough to vote. The League supports this "Automatic Pre-Registration.

"Opt-Out" AVR reinforces those facts by providing a secure, convenient, and cost-effective way to get and keep voters registered. It does not guarantee that turnout will rise, but it will remove a barrier to that turnout.

Common Cause Hawaii is testifying in support of SB 2005, which would provide that any person who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification card be automatically registered to vote if that person is not already registered to vote unless the applicant affirmatively declines to be registered to vote. SB 2005 would also authorize the electronic transmission of information and databases "maintained or operated by the counties or the department of transportation containing driver's license or identification card information to election officials and the statewide voter registration system. SB 2005 is known as Automatic Voter Registration ("AVR").

Common Cause Hawaii supports AVR as a much-needed voter modernization tool for Hawaii. AVR will benefit Hawaii in several ways.

One, AVR will modernize our voter registration system to make it more accurate and secure. When a person goes to the County of Department of Motor Vehicles and does not "opt-out" of being a registered voter, the person's information and data are automatically transferred between the County Department of Motor Vehicles and the State Office of Elections. This does not mean that a U.S. citizen will be "automatically" registered to vote by simply enacting AVR. It will still be necessary for a U.S. citizen to interact with a government official through the DMV—and not decline voter registration—to be registered to vote.

Two, AVR is cost-effective. AVR has been estimated, according to one evaluation, to possibly save approximately \$1 million statewide in each election cycle by eliminating paper-based registrations and decreasing undeliverable mail related to registration issues.

Three, AVR encourages good policy and governance through the promotion of a more inclusive society in accordance with UN Sustainable Development Goal #16. AVR is a vital step to making sure that all Hawaii US citizens have an equal voice in the political process by allowing voters to automatically register to vote when they interact with DMV.

Aloha, we are testifying on behalf of the AVR Hawaii Coalition in support of SB 2005, which provides for the voter registration of any U.S. Citizen who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification unless t hey decline to be registered to vote. This bill also authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation to election officials.

While mail-in voting will certainly enable registered voters to more conveniently exercise their right to vote, it won't ensure that voters are registered at the proper address so that they can receive their ballot or increase voter registration. Hawaii's voter rolls still need to be accurate, secure, and complete for voting by mail to function properly, improving our voter participation rates.

• SB 2005 will give voters the opportunity to register to vote or update their address at the same time they complete their driver license application or application for a state identification card. They will also have the opportunity to decline to register to vote. For any applicant who does not decline, the driver licensing office then transmits application information securely and electronically to election officials. Please be assured that no U.S. citizen is "automatically" registered to vote simply by the passing of this legislation. It will be necessary for the U.S. citizen to interact with a government official—and not decline voter registration—to be registered to vote or to update their address.

• Any person who does not want to register to vote or to update their address simply ticks a checkbox on the application to decline. No information will be transmitted for any person who ticks the decline checkbox. "Automatic" simply refers to the transfer of information and data between the County Department of Motor Vehicles and the State Office of Elections for those who want to vote.

If voting is the cornerstone of Democracy, voter registration is its bedrock. 'A 'ohe hana nui ke alu 'ia – no task is too big when done together by all. Please support SB 2005.

Dear Senators,

Young Progressives Demanding Action (YPDA) advocates for public policies that reflect the values of young people throughout the State of Hawai'i. One of those values is that an open democracy is a necessary component to ensuring a healthy society that is free of oppression.

Too often, the the economic and social realities of life make participating in the democratic and civic processes unnecesarily burdinsome for average citizens. Between working multiple jobs, studying to earn a degree to help us get ahead, taking care of our families—both keiki and aging kupuna—and allowing for the necessary level of social interactions we need to stay connected with our communities, young people in particular find it challenging to participate.

Young people have much to offer by way of ideas and solutions to the 21st century's most pressing problems. But too often our voice is not heard in the public policy discourse. Young people should have a seat at the table because identifying and implementing the best solutions requires a diverse set of view points and ideas be included from the beginning. When young people—or any group with much to contribute to policy discussions—are unable to participate, and go unheard, our interests are not considered and we lose out. And that's bad for all of society, because it prevents the healthy development of a new generation of leaders and problem-solvers who will need to take over the reins at some point. Don't we want our future leaders to have a solid foundation from which to build the solutions of tomorrow?

This is issue gets at the very heart of why YPDA was founded to begin with. We saw the tragic result of an election process that failed to bring young people into the electoral process—that failed to capture the imaginations and hopes of what has become the largest single voting bloc in the country. Apathy is the biggest challenge we face in mobilizing young people to patricipate. Te result of that apathy in 2016—not just among young people, but among far too

many eligible voters who did not participate—is a dangerous administration that puts into place policies that actively harm people and planet in the name of enriching the ultra-rich even further. We are determined to do everything we can to ensure that apathy is overcome so that the inclusive values of our generation are represented in policy and implemented by administrators who share those values. We over come apathy, in part, through aggressive outreach. But we also do everything we can to cut out barriers and unnecessary steps to make participating as simple, easy and clear as possible.

Hawai'i has a perennially underperforming voter participation rate, but it wasn't always like that, and it doesn't have to be going forward. There exist multiple opportunities to change the current paradigm, boost voter turnout, and strenegthen our democracy as a result. Last year, this legislature tooks a bold step in the right direction by expanding Hawai'i's Vote By Mail program to the entire state for the 2020 election cycle. The passage of Automatic Voter Registration would be another bold step in the right direction.

Automcatic Voter Regsitration won't eliminate voter apathy—that will require the hard work of organizing. But it will eliminate one barrier to participation. It's a quick and easy step—low-hanging fruit—that the state can take this year that will have dramatic results. How do we know? Because in other jurisdictions, implentatation of Automatic Voter Registration policies have made huge differences in participation rates. One early-adopting jursidiction (Oregon), now has a 90 percent registration rate, and blew the rest of the country out of the water for voter participation in the 2018 midterm elections—68 percent compared to the national average of 49 percent. (Read more: https://www.sightline.org/2018/12/13/voter-turnout-oregon-tops-charts-2018-midterms).

Oregon also demonstrated that Automatic Voter Registration increases the diversity of voters too by enfranchising the very demographic groups that have the hardest time making time to participate in the process: young people, struggling working class families, minorities—all of whom need to have an electoral voice and a seat at the policy table if we are to develop well-rounded, inclusive solutions to our problems that have genuine community buy-in.

If we are serious when we say that we value democracy, then let us show that we are willing to take action to live up to are values. Let us demonstrate that we mean what we say when we insist that a healthy democracy is the only practical defense against tyranny. To live up to that value, we must make sure that we provide access to democracy for groups who struggle to find time to engage with the process. We lose out as a society when potential solutions to our porblems are not heard. We lose out as a society when apathy keeps people from participating.

Planned Parenthood Votes Northwest and Hawaii ("PPVNH") writes in strong support of S.B. 2005 to modernize our voter registration system to make it more accurate and secure. S.B. 2005 will provide for the voter registration of any U.S. Citizen who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification unless they decline to be registered to vote.

This bill also authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation to election officials.

While mail-in voting will certainly enable registered voters to more conveniently exercise their right to vote, it won't ensure that voters are registered at the proper address so that they can receive their ballot or increase voter registration. Hawaii's voter rolls still need to be accurate, secure, and complete for voting by mail to function properly, improving our voter participation rates.

SB 2005 will give voters the opportunity to register to vote or update their address at the same time they complete their driver license application or application for a state identification card. They will also have the opportunity to decline to register to vote. For any applicant who does not decline, the driver licensing office then transmits application information securely and electronically to election officials. Please be assured that no U.S. citizen is "automatically" registered to vote simply by the passing of this legislation. It will be necessary for the U.S. citizen to interact with a government official— and not decline voter registration—to be registered to vote or to update their address.

Any person who does not want to register to vote or to update their address simply ticks a checkbox on the application to decline. No information will be transmitted for any person who ticks the decline checkbox. "Automatic" simply refers to the transfer of information and data between the County Department of Motor Vehicles and the State Office of Elections for those who want to vote.

If voting is the cornerstone of Democracy, voter registration is its bedrock. Thank you for your support for this important measure.

Dear Chair Inouye, Vice Chair Harimoto, and members of the Committee:

Thank you for the opportunity to provide testimony in **SUPPORT** of **SB 2005**, which would automatically register eligible citizens to vote when they apply for or renew their Hawai'i Drivers' License or State ID, unless they choose to opt out.

According to the United States Election Project, fewer than 4 in 10 of Hawai'i's voting-eligible population voted in the 2018 general election, yet again placing us last in the nation.¹

The logistical barriers to registering to vote are especially high for our low-income neighbors, since they are less likely to have the time or flexibility in their schedules to register in person or via mail or to have internet access to register online.

Automatic Voter Registration (AVR) would help overcome those barriers. The data shows that AVR improves the likelihood that people will vote by minimizing bureaucracy and requiring less time and effort from eligible voters. Implementing AVR would:

- Save the state of Hawai'i a lot of money. It costs almost 30 times more to process a paper application versus an electronic one. For the 2016 election, the labor costs to process paper forms totaled over half a million dollars.
- Make elections more secure and accurate with frequent updates to the voter rolls.
- Make voting more convenient for seniors, voters in rural areas, and working and military families who move frequently.

We need to act to get more than 4 in 10 of our eligible voters to vote in our elections. Hawai'i should join the 16 other states and the District of Columbia that have already approved AVR.

The American Civil Liberties Union of Hawai'i ("ACLU of Hawai'i") writes in support of, with a suggested amendment to, S.B. 2005, which would automatically register eligible people to vote or update voter information when they apply for or renew a state identification card or driver's license, with the option to decline registration.

Hawai'i has the lowest voter turnout in the country. Hawai'i should aggressively seek out solutions to increase voter enrollment and participation, such as automatic voter registration. With the correct safeguards in place, automatic voter registration helps remove barriers to registration for eligible voters, updates voter registration rolls, and leads to more efficient elections.

To further strengthen this measure, the ACLU of Hawai'i respectfully requests that the measure be amended to apply the same process to other forms or applications submitted to a government office, such as applications for public assistance and intake forms at jails. Limiting automatic voter registration to applications to renew or obtain a driver's license or State I.D. may disadvantage marginalized communities who are less likely to obtain licenses or I.D.s. Chair Inouye, Vice-Chair Harimoto, and Members of the Committee:

Hawai'i Health & Harm Reduction Center (HHHRC) <u>strongly supports</u> SB 2005, which provides for automatic voter registration (AVR) for anyone eligible to vote who applies for a new, renewal, or duplicate driver's license or state identification, with an opt-out provision. This measure also expressly authorizes access to relevant databases by to office of elections.

HHHRC supports measures that facilitate increased voter registration and participation. HHHRC works with many individuals who are impacted by poverty, housing instability, and other social determinants of health. Making voter registration automatic, particularly when combined with an all-mail election, would give many currently not inclined to participate in the electoral process a tangible opportunity to exercise their right to vote.

As noted by the Brennan Center for Justice (BCJ), automatic voter registration reforms that have an optout provision where agencies transfer voter registration information electronically to elections officials "<u>increase registration rates, clean up the voter rolls, and save states money</u>." BCJ also notes that 16 states and D.C. have approved the policy, with over a third of all Americans living in a jurisdiction that features AVR of some kind.

This is an important measure that will foreseeably expand registration and voter participation. It builds upon reforms, including vote-by-mail, enacted by the Hawai'i Legislature and signed into law in recent years. Ideally, Hawai'i would be among those seven states where voter information is provided to elections officials by other social service agencies. Earlier this month New York's state Senate passed a measure that would create an AVR system that includes its DMV and its Department of Health.

The United States is a democratic republic governing system, meaning that officials that create and pass laws are elected into office. Hawaii has a low voter turnout with people 18 and over making up 78.6% of Hawaii's population in 2018 - of that population only 115,406 registered to vote, that is a 9.67% registration for general elections. That does not count those incarcerated at the time, but such a low fraction is still significant. I support SB 2005 because I believe making it easier for communities like mine to vote is a good thing for them and for Hawaii. By making the transfer of information for voter registration automatic when one goes to the DMV, the process becomes more convenient and keeps voter polls updated. People are free to say NO if they do not want to have their information transmitted to the Office of Elections. That is important.
