#### **Department's Position:**

The Department of Education (Department) supports SB 2063 related to establishing the Hawai'i After-School Program for Youth for children in grades six through eight.

The Department's Community Engagement Branch is responsible for the administration, compliance, and monitoring of federal and state-funded quality out-of-school time programs: Afterschool Plus (A+), 21st Century Community Learning Centers (21CCLC), Uniting Peer Learning, Integrating New Knowledge (UPLINK), and Resources for Enrichment, Athletics, Culture and Health (REACH). The Department recognizes the increase in demand for quality out-of-school time programs for working families in Hawai'i.

A single funding source to support quality care and learning in the out-of-school time will help to support alignment of the regular school day to the out-of-school time space, increase student access that build character, self-esteem and prevents risky behaviors through a variety of educational activities that increase student outcomes.

Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association <u>supports SB 2063</u>, relating to after-school programs. This bill would establish the Hawai'i After-School program for youth within the Department of Education community engagement branch to provide after school programs for children for grades sixth through eighth.

This bill would establish more after school programs for our middle school students. This is an age when students need safe, enjoyable activities after the school day is finished but currently have a limited number of after-school activities available to them. We also know that many of their parents and guardians work two to three jobs that run late, and they may not be able to be home for their children until later. Furthermore, seventy-two per cent of parents surveyed in Hawaii agree that afterschool programs help working parents to keep their jobs. After school programs are not only important for homework help, but they offer extracurricular activities and social activities that benefit our students after school. HSTA recognizes that there are over 1,355 students who are homeless across the state that would also benefit from after school programs for their children in middle school. Homeless students have a unique set of needs than their housed peers and these after school programs would be greatly beneficial for them as well.

More after school programs would help ensure that students who are in middle school are able to thrive and get the most out of their educational career and allow their parents to work and not worry about their children as their children will be in a safe, enjoyable after school program until they can come home.

Dear Chair Kidani and Vice Chair Mercado Kim, and Committee Members:

The Hawai'i Afterschool Alliance supports Senate Bill 2063, which seeks to establish the Hawaii After-School Program for Youth within the Department of Education community engagement branch to provide after school programs for children in grades six through eight.

The State of Hawai'i, twenty-eighth legislature, 2016, requested the Hawai'i Department of Education (HIDOE) to convene a working group to review after-school programs in Hawai'i's public middle and intermediate schools. This working group, formed by experts in the field, submitted its finding and recommendations to the Legislature. The group came to the conclusion that there is an immediate need to increase the funding for out-of-school programs in the state of Hawai'i to provide services to all the children and youth that need and/or would like to participate in program. Out-of-school programs work as a safety net to support students' success by creating a safe environment where they can thrive. The group also highlighted the importance of focusing on transportation, on athletics and on accommodation for students with special needs. Transportation is needed to grant the students safe return home when the out-of-school program ends. The group also included athletics (intramural, extramural and interscholastic) as an important component of the development of the out-of-school programs. The document produced by the group also emphasized that the out-of-school programs have enough resources and capacity to serve and support students with special needs.

In conclusion, the Hawai'i Afterschool Alliance supports SB 2063 and respectfully urges the passage of this bill so that students in Hawai'i have the support they need to participate in a high-quality out-of-school programs. Thank you for the opportunity to testify.

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) appreciates the intent of the measure and provides comments.

<u>PURPOSE</u>: The purpose of the bill is to establish the Hawaii After-School Program for Youth within the Department of Education community engagement branch to provide after school programs for children in grades six through eight. Appropriates funds.

DHS regulates programs that are operating as child care facilities, including programs for children that are in the 6<sup>th</sup> grade. If the after-school programs as proposed are providing care, which is defined by section 346-151, Hawaii Revised Statutes (HRS), as "... those situations where a person or organization has agreed to assume and has been entrusted with the responsibility for the child's supervision, development, safety, and protection apart from the parent or guardian," then the program may be operating a child care facility, which is defined as "a place maintained by any individual, organization, or agency for the purpose of providing care for children with or without charging a fee at any time. It includes a family child care home, group child care home, and group child care center."

If the proposed after-school program operated by a private provider is not exempt

from licensure by DHS, as allowed under section 346-154(a), HRS, then the private provider will also need to be licensed by DHS as a child care facility when the after-school program is caring for children attending elementary schools.

If the DOE will be responsible for licensing or certifying the after-school program directly, then the proposed program would not need to be licensed by DHS, in accordance with section 346-152(a) (3), HRS.

Additionally, DHS currently has a contract with the DOE to fund the A+ Program services with Temporary Assistance for Needy Families (TANF) funding for families that meet Purpose Two of TANF, to end the dependence of low-income employed families by promoting job preparation, work and marriage. The Department claims this expenditure on behalf of the State the A+ subsidies towards the State's TANF Maintenance of Effort (MOE) requirement in accordance with 45 Code of Federal Regulations section 263.1. Eligibility screening is required to ensure State TANF MOE claims are limited to expenditures incurred for TANF-eligible families.

DHS also contracts with the DOE for the Uniting Peer Learning, Integrating New Knowledge (UPLINK) Program. UPLINK is an existing after-school program for intermediate and middle school students in grades 6, 7, and 8. The State Fiscal Year 2019 funding for the UPLINK Program, totaling \$3,171,000 in Federal TANF funds, is provided by DHS and administered by the DOE through an agreement established in 2006. Beginning school year 2018-2019, 30 out of 53 (56%) intermediate and middle schools provide UPLINK.

#### RELATING TO AFTER-SCHOOL PROGRAMS

The department has concerns with the creation of the Hawai'i After-School Program for Youth Special Fund (HASPYSF).

Senate Bill (S.B.) No. 2063 establishes the Hawai'i After-School Program for Youth within the Department of Education's Community Engagement Branch to provide after-school programs for children in grades six through eight; and the HASPYSF. The measure appropriates an unspecified sum of general funds for deposit into the special fund for FY 21, and the special fund would generate revenues through legislative appropriations and fees.

As a matter of general policy, the department does not support the creation of any special fund that does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work, and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and

the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to S.B. No. 2063, it is difficult to determine whether the proposed special fund would be self-sustaining or why the program cannot be implemented under the general fund appropriation process.

I am writing in support of SB 2063. The hours of 3pm - 6pm each day is the most dangerous time for Middle School Students in Hawaii. During this time, a large percentage of students are unsupervised because adults in their families have to work long hours simply to survive.
