Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports this bill.

This measure amends HRS §11-340(c) to make clear that the increased fine (not to exceed \$300 per day) for the late-filing of preliminary reports only applies to the reports due ten days before a primary, general, or special election. This measure is necessary due to the additional preliminary reports mandated by the Legislature last session. The Commission urges this Committee to pass this measure without amendments.

¹ The companion bill is H.B. No. 1705, which has been extensively amended in HD 1. As such, the Commission prefers the language in S.B. No. 2146.

Common Cause Hawaii supports SB 2146, which would clarify that preliminary primary and preliminary general reports are due 10 days before the primary or general election.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization dedicated to reforming government and strengthening democracy through improving our campaign finance system with laws that amplify the voices of everyday Americans by requiring strong disclosures and making sure everyone plays by the same commonsense rules.
