In consideration of SENATE BILL 2188, SENATE DRAFT 1 RELATING TO WILDLIFE OFFENSES

Senate Bill 2188, Senate Draft 1 proposes to require that animal parts, products, or items containing prohibited animal parts or products involved in the commission of wildlife trafficking or certain hunting offenses shall be considered contraband to be forfeited to and disposed of by the State. The Department of Land and Natural Resources supports this measure and offers the following comments.

Section 183D-5(b)(1), Hawaii Revised Statutes (HRS), states that a first conviction for a covered offense shall result in a mandatory fine of not less than \$200, or by imprisonment of not more than one year, or both. Including the proposed contraband and forfeiture language into Section 183D-5(b)(1), HRS, makes the penalty much more operative in the real world. When the products from, and implements used in, the commission of wildlife trafficking are seized, the criminal activity is more effectively hampered than when violators are simply fined or imprisoned. Removing trafficked products from the market is a step in the right direction towards ending wildlife trafficking. Including the confiscation of firearms for any subsequent violation within five years would be a further deterrent.

RE: S.B. 2188, H.D. 1; RELATING TO WILDLIFE OFFENSES.

Chair Rhoads, Vice Chair Keohokalole, and members of the Senate Committee on Judiciary, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") **strongly supports** S.B. 2188, S.D. 1. This bill is part of the Department's 2020 legislative package.

Prior to the passage of Act 125 (2016), Hawaii was one of the nation's largest markets for ivory and other wildlife products. Since its passage, Hawaii joined New York and California as one of the three largest ivory markets to enact statutes banning the sale of such products¹. Despite these great strides, loopholes in our laws have allowed unscrupulous brick and mortar stores and online sellers to retain these products long enough to continue selling them on the black market, even after law enforcement has successfully identified and prosecuted them. The purpose of S.B. 2188, S.D. 1 is to strengthen Hawaii's laws, by empowering law enforcement and our courts to order that these contraband items be forfeited, and decrease the amount of contraband ivory in circulation.

Currently, section §183D-5(b)(1), Hawaii Revised Statutes (Wildlife Trafficking Prohibited) does not expressly allow for the forfeiture and disposal of wildlife contraband upon a first conviction. Therefore, despite the Department's efforts to remove these illegal items from circulation, and after successfully locating and prosecuting someone for selling an illegal ivory product, our courts are left no other option but to return all additional pieces of ivory that were confiscated during the initial arrest. These returned items typically "disappear" thereafter, most likely placed back into circulation on the black market or internet, avoiding further detection or prosecution by law enforcement. S.B. 2188, S.B. 1 creates the mechanism and tools by which our courts may forfeit those additional items before they can be returned to the stream of commerce, and stop the cycle of illegal trafficking on those items.

Dear Honorable Committee Members:

Please support SB2188. The fur industry is cruel to animals and is an environmental nightmare.

Over 100 million animals are killed annually for their fur. Most comes from animals like foxes, mink and raccoon dogs, who are factory-farmed solely for their fur.

Animal cruelty is the norm in the fur industry. On fur factory farms, undomesticated animals are locked in cramped, wire cages for their entire lives, deprived of the ability to engage in natural behaviors. They're killed in horrific ways—such as crude gassing anal or genital electrocution and neck breaking.

In the wild, archaic and indiscriminate traps often maim or kill non-target animals—even endangered species and pets.

The fur industry also poses serious environmental threats. Waste from fur factory farms pollutes the soil and waterways. And furriers process pelts in toxic, carcinogenic chemicals, including chromium and formaldehyde, to prevent them from rotting.

HB 1689 would eliminate Hawaii's contribution to these animal abuses and environmental harms by making it illegal to sell or manufacture a new fur product in the state.
