Dear Chair Rhoads, Vice Chair Keohokalole, and Members of the Committee:

SUBJECT: Senate Bill No. 2241 Proposed SD1
Relating to Intoxicating Liquor

The Liquor Commission, City and County of Honolulu (Commission), appreciates the opportunity to submit testimony **opposing as written** the above-referenced measure. As a matter of principle, the Commission fully supports legislation that guides licensee operations so that they responsibly co-exist with members of the public and the community. The Commission respectfully suggests, however, that features in the proposed SD1 would at best be ineffective in increasing regulatory oversight or, worst case scenario, be problematic to implement.

## 1. The Commission Currently Records All Complaints Against All Licensees.

Section 2 of the proposed SD1 proposes to amend Section 281-17(a)(10), Hawaii Revised Statutes (HRS), to impose a requirement to record all complaints against all licensees, regardless of when the complaint is filed. As the Commission keeps hard copy and/or digital copy of *all* complaints filed as a matter of current operating procedure, we do not anticipate any change to said procedure from the proposed requirement.

2. Requiring Investigators To Be Present At Each POS Of An Out-Of-Doors Special License Event Will Be Problematic From Both A Fiscal And Operational Standpoint.

Even if the number of out-of-doors Special license events in any given year can be precisely forecasted, the Commission anticipates that current staffing levels will not permit having investigative staff available to monitor each POS in the licensed area, particularly if there are multiple such events occurring on the same day. If the

Commission needs to increase its investigative staff and plan for paid overtime that *may* be needed in the future, it will need to increase investigative personnel and budgeted salary expense against that possibility at the earliest opportunity. An increase in investigative staff will result in increased salary expense in the Commission's budget, which will be funded by increasing license fees across-the-board for all classes of licenses. It is unlikely that our licensee base will welcome an increase to license fees for this type of contingency expense.

Even with a larger investigator pool, requiring POS coverage by investigative staff for these types of events will necessarily divert enforcement personnel away from other areas with liquor-licensed activities. With no discretion to allocate resources according to type of activity, expected attendance, or location where the event will take place, the Commission would be required, for example, to divert resources to monitor POS activities at the Sony Open or the Craft Beer Festival at the Bishop Museum, while foregoing coverage in other parts of Oahu.

# 3. Restricting Events Involving Temporary Street Closures To Extensions Of An Existing Valid License Could Effectively Ban This Type Of Event.

A Class 10 Special license is a license separate and distinct from a Restaurant or Dispenser license. A Special license could be contiguous to a Restaurant or Dispenser license but could never "extend" or overlap an existing license. As such, this proposed Section 3 amendment to Section 281-31(j), HRS, could effectively ban the number of temporary street closure events because a Special license cannot be used to "temporarily extend" an existing license. That said, in Honolulu County a Restaurant or Dispenser licensee can (and have) temporarily extend the boundaries of its license to accommodate an event, to include temporary street closures. This temporary extension ability, however, is independent of Section 281-31(j), HRS, so this proposed Section 3 amendment would appear to be unnecessary.

Thank you for the opportunity to provide comments on Senate Bill 2241 Proposed SD1.

Aloha e Chair Rhoads, Vice Chair Keohokalole, and Members of the Committee on JDC,

My name is Steve Lohse, I'm a constituent of Sen. Rhoads and a resident of Chinatown Gateway Plaza (CGP), a 200-unit, city-owned, affordable housing project in Chinatown. I'm also a cofounder of the CGP Tenant Association (CGPTA), organized by CGP residents in 2006 to represent our resident voice in matters of concern to our Chinatown community. On behalf of the CGPTA, thank you for this opportunity to submit the following written **Support for SB2241 SD1** with amendments:

- (1) Chinatown Gateway Plaza is located on Hotel between Nuuanu and Bethel, the densely-populated ground zero for Chinatown's entertainment district and its large, loud, liquor-sales street parties. In addition to area crime and grime, a major liquor-related concern of CGP residents is excessive noise emanating from liquor-licensed premises, especially including premises temporarily extended into our public streets. SB2241 SD1 would help with these problems by ensuring that
- (a) all Public Complaint to the Honolulu Liquor Commission (HLC) is recorded, regardless of whether the complaint is filed during or after an event;
- (b) a sufficient number of HLC investigators is available and identified during events, and it would help if investigators also routinely documented decibel levels during street events;
- (c) Hawaii State Constitution, Article XI, Sec. 9, is recognized and enforced, establishing each person's constitutional right in Hawaii to a clean and healthful environment, including control of noise pollution, see <a href="https://www.civilbeat.org/2020/01/noise-pollution-is-making-our-communities-unlivable/">https://www.civilbeat.org/2020/01/noise-pollution-is-making-our-communities-unlivable/</a>.
- (2) The CGPTA also has a long-standing concern with the lack of apparent Public Purpose as required by law for Dept. of Transportation (DTS) non-construction street closure permits, as well as the lack of apparent fundraising required for HLC Class 10 Special Licenses. The truth is that the largest, loudest, drunkest street parties in Chinatown are not fundraisers at all, they are simply large, loud, liquor-sales events with regular Excessive Noise violations as defined and prohibited by Honolulu Liquor Law.

In summary, while **the CGPTA supports SB2241 SD1**, we suggest that the bill would be more effective (1) if HLC investigators were required to document decibel levels during HLC-permitted street events and especially (2) if the HLC were to require Class 10 Special Licenses accurately to document genuine nonprofit fundraising for any temporary permit to repurpose any public streets for any liquor-permitted event.

Dear Chair Rhoads, Vice Chair Keohokalole and esteemed Committee Members:

I'm compelled to write today in opposition to SB2241 related to the further abatement of alcohol sales at street events. I urge you to reconsider its introduction, as its full consequence appears imprecise and its criteria unfairly targets all communities on the island of Oahu, wherein many successful street events are held without incident each year.

As a longtime event planner and former officer of companies run by promoter Tom Moffatt, I'm familiar with the public sale and consumption of alcohol at many types of events including street festivals like those held in Downtown/Chinatown and Waikiki. I believe I have standing to comment from a position of experience and greatly appreciate your consideration of my testimony.

### Proposed Changes to Section 3(j)(1) under SB2241

Cause Shown for Enactment: SB2241, while well-intentioned, is not grounded in fact but in theory: Councilmember Carol Fukunaga writes, in her supporting testimony, that "There is a **range of sentiment** coming from residents, property owners, business owners, and others regarding the **possible** impact of the sale of alcohol at some events on crowd behavior, noise, and other types of nuisance." (emphases mine)

The Committee can also theorize that the largest contributor to "crowd behavior, noise and other types of nuisances" is attendance size. Lacking any provision to address this, SB2241 goes straight to alcohol consumption as a root cause even though the premise is unproven in our particular population. It's my firm belief that our laws are not meant to be so experimental.

Stationed Liquor Commissioner: The Liquor Commission already spot checks events where alcohol consumption occurs, and beer gardens are already in use in both public and private locations. Even if a commissioner were routinely present, that commissioner can't regulate noise levels, trash levels, or the ingress/egress from businesses and residences in affected areas. These remedies already belong to the Department of Health, the bonded security and the special duty police hired, all of whom have performed admirably for at least the forty-some years I've worked in live events. I consider the proposed additional oversight, were there enough manpower to accomplish it, to be superfluous.

Class 10 Liquor Licenses: SB2241 proposes, "...if the event takes place on the premises of a temporary public street closure in any county having a population in excess of 500,000..." This clearly means "Oahu" and places restrictions on off-premises events, some with great distinction, throughout the island. Since the County of Honolulu lacks for venues, and its greater group of communities embrace and behave more admirably than not at these events, it's unreasonable to propose changes meant for "some" events that needlessly affect "all" events based solely on population level, which has little if no bearing on attendance size.

Class 10 versus Class 17 Licenses: SB2241 appears to unwittingly curtail stand-alone ventures receiving their own temporary liquor licenses in favor of extending existing licenses, giving permanent businesses an unfair advantage over non-profit organizations, annual exhibitors, independent promoters and the like whose revenue models use, in whole or in part, street-style events. As the bill doesn't also address the liability sharing between promoters and a chosen licensed establishment, or between a group of licensed establishments working in the same geographic area, this component of the bill appears incomplete.

For these reasons, among others, I respectfully urge you not to pass SB2241 lest it raise more issues than it's intended to resolve.

I am writing in support of SB2241 with the following underlined changes:

- 1. Language in Section 2(a)(10) be amended to read in part "...regardless of whether the complaint is filed during or after the occurrence of the event."
- 2. Language in Section 3(1)(1) be amended to read in part "...in excess of 500,000, a special license shall be granted only to a non-profit organization which is not merely the sponsor of the event but must actively manage, produce, stage and conduct such event. The non-profit shall report all gross and net proceeds from an event staged on public streets or venues including sales of alcohol.

Public streets should not serve as routine event venues for alcohol events staged by promoters and businesses with a non-profit facade. The significant impact that such closures pose for the neighboring community and the county at large with regard to noise, traffic, rerouted and unavailable public transport, and violations, necessitates greater accountability and transparency for the privilege of using such a vital public resource in a populous county.

In her earlier testimony on this bill Council Member Fukunaga referenced a Joint Fact Finding Process which recommended two options in relation to alcohol in public places: (1) beer gardens and (2) not in public rights-of-way (streets and public sidewalks). Perhaps the Judiciary Committee would consider the second option if the first option is deemed too broad.



Aloha Senator Rhoads and Senator Moriwaki:

My name is David M. Jorgensen and I'm with the Wailuku, Maui law firm of Takitani, Agaran, Jorgensen & Wildman. I'm submitting this letter to express strong opposition to SB 2241 Relating to Intoxicating Liquor, at least as currently drafted.

On Maui, we have several big festivals each year that include alcohol and which attract a lot of visitors to the island and significantly benefit local charitable organizations. For example, the Kapalua Wine & Food Festival has made a significant impact on the local non-profit community buy raising substantial funds that are donated to various organizations.

Different portions of the festival are put on at two resort properties in Kapalua, The Montage Kapalua Bay and The Ritz Carlton Kapalua. The two signature events are the Grand Tasting at the Montage and the Seafood Festival at the Ritz. Both events are set up outside and cover large areas. The Grand Tasting, for example, has a 4,000 square foot tent at the center of the event. And other tents surrounding it, each serving wine and Champagne. Requiring these types of festivals to limit the area for consumption of alcohol to a 3,000 square foot area and be enclosed within a solid barrier will significantly and adversely affect the success of the events.

I hereby request that you oppose SB2241 or modify it so that it only applies to festivals conducted on Oahu, if there are problems on Oahu which need to be addressed in this manner. Thank you for your time and consideration on this matter.
