# On the following measure: S.B. 2281, RELATING TO BEHAVIOR ANALYSTS

Chair Baker and Members of the Committee:

My name is Charlene Tamanaha, and I am the Licensing Administrator of the Department of Commerce and Consumer Affairs' (Department) Professional and Vocational Licensing Division. The Department appreciates the intent of and offers comments on this bill.

The purpose of this bill is to make permanent the regulation of behavior analysts. The Department appreciates the bill's intent to continue providing for the licensure of behavior analysts to protect the public from the unqualified practice of behavior analysis and from unprofessional conduct by behavior analysts.

Hawaii Revised Statutes (HRS) section 26H-4 requires that for professional and vocational regulatory programs enacted after January 1, 1994, an auditor shall perform an evaluation of the program, pursuant to section 26H-5, prior to its repeal date. While the Department does not oppose removing the repeal date, the Department respectfully requests that the State Auditor be afforded sufficient time to conduct a sunset analysis

on behavior analysts, consistent with the requirements of HRS 26H-5, prior to the law's repeal date of June 30, 2021. In an analogous situation, the Legislative Auditor issued a sunset analysis of athletic trainers in September 2017, and the Athletic Trainer law was made permanent in the subsequent session (Act 58, Session Laws of Hawaii 2018).

SB 2281 RELATING TO BEHAVIOR ANALYSTS. Title of Bill:

Purpose of Bill: Makes permanent the regulation of behavior analysts.

#### **Department's Position:**

The Department of Education (Department) supports the intent of SB 2281 to continue the regulation and control of the practice of behavior analysts for the purpose of ensuring continued treatment of individuals with autism and protecting the public's health, safety, and welfare.

The Department is committed to providing quality Applied Behavior Analysis services to our students regardless of the continuation of Chapter 465D, Hawaii Revised Statutes. At this time, the Department proposes the following amendments to Chapter 465D, Hawaii Revised Statutes.

#### Modifying Exemption(A)(2)

A licensed classroom teacher or an individual who is working as a classroom teacher and is enrolled in a teacher preparation program working towards licensure who implements but does not design applied behavior analysis services in a school setting in direct collaboration with a licensed behavior analyst, a licensed psychologist, or a special education teacher licensed in severe/profound disabilities or autism. on or before July 1, 2019:

#### Adding Exemption (10)

(10) A special education teacher licensed in severe/profound disabilities or autism and any supervisee of the licensed special education teacher; provided that applied behavior analysis services performed are within the boundaries of the licensed special education teacher's education, training, and competence; provided further that neither the licensed special education teacher nor any supervisee of the licensed special education teacher purports to be a licensed behavior analyst: and provided further that licensed special educators in the severe/profound disabilities or autism may provide training and supervision to direct support workers, paraprofessionals, caregivers, parents and guardians in a manner and to the extent

determined by the supervising licensed special education teacher.

For purposes of this paragraph, "supervisee" means a special education teacher candidate, direct support worker, paraprofessional, caregiver, and parent or guardian who provides applied behavior analysis services.

Thank you for the opportunity to provide testimony on this measure.

HABA would like to thank the Commerce, Consumer Protection, and Health Committee for its diligent efforts in ensuring consumers of behavior analysis services are protected by regulation of the practice.

Since the enactment of the licensure law in 2015, which was passed together with the autism insurance coverage law, licensed behavior analysts have helped many individuals with autism receive the services they need. Chair Baker and Members of the Committee:

The Hawaii State Teachers Association <u>supports SB 2281</u>, relating to behavior analysis. This bill makes permanent the regulation of behavior analysts.

Behavior analysis means the design, implementation, and evaluation of instructional and environmental modifications to produce socially significant improvements in human behavior. The practice of behavior analysis includes the empirical identification of functional relations between behavior and environmental factors, known as functional assessment and analysis, as well as the use of contextual factors, motivating operations, antecedent stimuli, positive reinforcement, and other consequences to help people develop positive behaviors.

Act 199, Session Laws of Hawaii 2015, established the behavior analyst program within the Department of Commerce and Consumer Affairs and created licensing requirements for behavior analysts. Licensing of behavior analysis services was made concurrent with mandated insurance coverage for diagnosis and treatment related to autism disorders, with which nearly 1,500 public school students are currently diagnosed. Act 205 further clarified the licensing qualifications for those who conduct Functional Behavior Assessments (FBAs), and design and monitor Applied Behavior Analysis ABA) Plans in our state.

Our teachers sometimes need the support of other professionals who support our students with other areas of expertise; this area is one of them. Health plans should cover these services and these services should remain regulated and licensed accordingly.

To support access to learning experiences of our most vulnerable keiki, the Hawaii State Teachers Association asks your committee to <u>support</u> this bill.

I write in support of Senate Bill 2281. I support the licensure of behavior analysts working with our children, young adults, and adults with autism, conforming with HRS Chapter 465D. Existing licensure regulations are going to sunset next year; this measure would make these requirements permanent.

The Hawai' State Teachers Association (HSTA) notes in its testimony that nearly 1,500 public school students are currently diagnosed as having autism spectrum disorder. Thank you for allowing me to testify. I am both a special educator and a licensed behavior analyst working in Hawaii. I work in special education teacher preparation, and I also prepare individuals to become behavior analysts. I am knowledgeable of the scope of training and practice in both fields.

I support SB 2281in regards to the licensing of behavior analysts provided the language in 456D Exemption (A)(2) is modified as follows: "A licensed classroom teacher or an individual who is working as a classroom teacher and is enrolled in a teacher preparation program working towards licensure who implements but does not design applied behavior analysis services in a school setting in direct collaboration with a licensed behavior analyst, a licensed psychologist, or a special education teacher licensed in severe/profound disabilities or autism."

In addition, the following language should be substituted for 456D Exemption 10, "(10) A special education teacher licensed in severe/profound disabilities or autism and any supervisee of the licensed special education teacher; provided that applied behavior analysis services performed are within the boundaries of the licensed special education teacher's education, training, and competence; provided further that neither the licensed special education teacher nor any supervisee of the licensed special education teacher purports to be a licensed behavior analyst; and provided further that licensed special educators in the severe/profound disabilities or autism may provide training and supervision to direct support workers, paraprofessionals, caregivers, parents and guardians in a manner and to the extent determined by the supervising licensed special education teacher.

For purposes of this paragraph, "supervisee" means a special education teacher candidate, direct support worker, paraprofessional, caregiver, parent or guardian who provides applied behavior analysis services."


The Special Education Advisory Council (SEAC) **supports** SB 2281 that makes permanent the regulation of behavior analysts under Chapter 465D.

SEAC was an early supporter of the legislation to provide Applied Behavior Analysis as a covered medical service under Hawaii's health insurers. Licensure ensures that children with autism and other developmental disabilities receive evidence-based treatment by a qualified and licensed provider.

While the original licensing law, Act 199 (now Chapter 465D) was not intended to restrict the practice of other licensed or credentialed professionals providing services within the scope of their established training and expertise, it has had to be amended several times to add to the list of those exempted from acquiring licensure as a behavior analyst. SEAC proposes the following additional amendments to ensure that public school students who require behavior analysis to benefit from their education have greater access to practitioners and educators with the appropriate expertise, training and experience.
