The authority and capability to obtain funds for state and city projects for Hawaii must rest solely with the Hawaii State Legislature. Neither the governor, nor any one person or entity, should have an avenue to circumvent the legislature to obtain funding. Decisions regarding financial issues need to be made under public scrutiny and this is accomplished thru the democratically elected legislative process.

If the kind of loopholes such as the certificates of participation are allowed to continue, then there should be caps on the amount of funding accessible thru that process. During the September 2019 city council meeting regarding resolution 19-182, it was astounding to learn the governor could access \$125 million dollars for a project without legislative approval. The funds for this very project had already been turned down by the 2019 legislature. The request was for \$125 million but it could well have been for \$500 million or any other amount.

Once these COPS were issued, the legislature would have no choice but to fund them in the next legislative session as defaulting would not be a possibility due to the threat to the state's good bond rating. In fact, this process is not only a circumvention of the legislative process, it is form of blackmail of the legislature.

TESTIMONY IN SUPPORT OF SB2322

Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Senate Ways and Means Committee:

I write in support of SB2322. I would also like to offer a friendly amendment. This bill prevents the State agencies from issuing a certificate of participation (COP) under Chapter 37D that exceeds \$10 million.

I am an officer in an organization, Protect Our Ala Wai Watersheds, which could directly benefit by passage of this bill. Our organization seeks to promote eco-friendly alternatives to the Army Corps' current flood mitigation project for the Ala Wai Watershed and to encourage the Army Corps to seriously consider those alternatives.

Last year the Governor requested an appropriation of \$125 million to fund the local sponsor's portion of the flood management project's cost (SB77 (2019)). Partially due to significant public opposition, the Legislature declined his request. Undeterred, the Governor instructed the Department of Budget and Finance to fund the project through a financing agreement under Chapter 37D. Specifically, B & F began a process to sell COPs in November of 2019.

Our organization sued to stop the sale. The court agreed with us and enjoined the State from selling the COPs before the state environmental impact statement had been approved. A few days after that October 29 decision, the Mayor of Honolulu informed the Governor that he could not approve the EIS and that certain aspects of it had to be re-done. That stopped the sale.

But we believe that the Governor still intends to finance the project by selling COPs once the Mayor approves the revised EIS. This bill's enactment would help to prevent that.

We have recently received information that the Army Corps has given the City and the State a new deadline of March 15 to find the money and to sign on as a local sponsor of the Project. The State does not appear to have requested an appropriation for the Project this session; therefore, issuing COPs seems to be the only alternative. If the COPs process were started up again, it would not be halted by this bill unless SB2322 were amended to be effective on January 1, 2020.

We are requesting that friendly amendment because you do not want the Governor to be able to fund a \$125 million project without the prior approval of the Ways and Means Committee.

In addition, this bill deserves support for two broader reasons:

1. The Legislature, especially the Ways and Means and Finance Committees need to take back control of the purse strings. As B & F interprets Chapter 37D, it can decide to enter into a financing agreement to sell COPs and then come to the Legislature afterwards for an appropriation. If the Legislature chose not to make the appropriation, the State's bond rating would be negatively impacted. A ten million-dollar limit would allow the

- executive branch access to money for unanticipated contingencies. For anything above that amount, the legislature needs to approve an appropriation.
- 2. The Legislature is the proper vehicle to consider sizable appropriations because public hearings are required. Without public hearings the public could be entirely shut out of the decision-making process.

Aloha Chair Dela Cruz and Senators

My name is Dave Watase, I am a long time resident of Honolulu and a registered voter. I support SB222 SD1. For over a year, I've been opposed to the USACE Ala Wai Flood Risk Management Project. The USACE's Final EIS was done without engaging the community and stakeholders and is deficient in several major ways as stated in Mayor Caldwell's October 2019 letter returning the EIS as it was unacceptable. In October, Protect Our Ala Wai Watersheds (POAWW) won a temporary injunction that prevented the Governor from selling COPS to fund the Ala Wai Flood Risk Management Project until the Final EIS under HEPA was accepted.

The issue was that Governor Ige attempted to bypass the Legislature in funding the \$125 million partner portion for the Ala Wai Flood Risk Management Project through Certificates of Participation. By way of a Memorandum of Agreement between the State and City, the Governor was to provide the Mayor with \$125 million so that the City could partner with the USACE. If not for POAWW winning their lawsuit, the Mayor would have signed the Project Partnership Agreement and thereby attaching the existing unwanted elements of the project to the Federal Funds.

The USACE recently stated verbally that based on their updated modeling the detention basins in Manoa Valley and Makiki did not protect the residents from flooding and that Palolo Valley did not require detention basins. Currently on the table are the removal of at least 5 upstream detention basins and possibly 6. This has forced the USACE to look at alternatives which include conveyance vs detention and pushes the amount of stormwater further down stream and closer to the Ala Wai Canal. Most likely these changes will also trigger major changes to the use of the Ala Wai Golf Course detention basin and changes to the proposed reinforced concrete wall around the Ala Wai Canal. Ultimately, we believe the better alternative and solution is the flood gate and flood pump system.

In any event, the USACE original plan was defective and flawed, the State and City would have illegally spent money without an accepted Final EIS. SB2322 SD1 will prevent the Governor from bypassing the Legislature. Please vote to support SB2322 SD1.




