ON SENATE BILL NO. 2609

### **RELATING TO ELECTIONS**

February 20, 2020

Chair Rhoads and members of the Senate Committee on Judiciary, thank you for the opportunity to provide comments on Senate Bill No. 2609. The purpose of this bill is to include agents of candidates listed on ballots among the persons prohibited from providing voting assistance at voter service centers and in the use of absentee ballots.

This bill ensures the integrity of our elections by identifying agents of candidates as individuals who cannot provide voting assistance. We would propose that this bill also add similar language to HRS § 11-104, which covers envelopes used in elections by mail, as the measure is currently limited to HRS § 15-6 concerning absentee voters. Otherwise, it may be interpreted that this bill only applies to a small subsection of voting by mail in which voters request absentee ballots, as opposed to all voters who are mailed a ballot as part of elections by mail.

Additionally, given the criminal penalties associated with election fraud under HRS § 19-4, it may be beneficial to further define the term "agent of a candidate," so as to distinguish between a supporter of a candidate, a volunteer on a candidate's campaign who performs ministerial functions, and a person associated with a candidate's campaign who is authorized to make decisions or to speak on behalf of the candidate.

Finally, we would note that this bill is effective upon approval which would impact the return envelopes used for the 2020 Elections. Specifically, we are already procuring the envelopes for the Primary Election and the General

Election, and the assembly of the Primary Election mail ballot packets would begin prior to the Governor's signature deadline. Given this, we would propose changing the effective date to after the 2020 Elections.

Common Cause Hawaii provides comments on SB 2609, which includes agents of candidates listed on ballots among the persons prohibited from providing voting assistance at voter service centers and in the use of absentee ballots.

Common Cause Hawaii is a nonprofit, nonpartisan, grassroots organization dedicated to reforming government and strengthening democracy with laws that amplify the voices of everyday Americans.

Agent is defined as "[s]omeone who is authorized to act for or in place of another; a representative". Black's Law Dictionary 10<sup>th</sup> ed. A candidate may have multiple agents and it may not be apparent who is a candidate's agent, especially with large candidate and/or complex campaigns. It may be prudent for SB 2609 to define agent to avoid confusion.
