Dear Chair Baker, Vice Chair Chang, and Committee Members:

RE: SB 2617 Relating to Emergency Services

Ka'u Hospital is a small rural facility serving a very large geographic area. Although the traditional population centers of Pahala and Naalehu are fairly stable, the number of residents in Ocean View have grown enormously (including a large Micronesian population), and so has traffic (and the potential for traffic-related injuries). While Ocean View can be serviced by either Ka'u Hospital or Kona Community Hospital, the need for urgent care in Ka'u is clear.

I know you have limited resources and unlimited priorities, but a year ago this Committee and the full Senate passed a bill, SB 1410, to help Ka'u, recognizing that it would constitute a small investment of funds with life-saving rewards. SB 1410 died in Finance, but we hope you will try again.



### Comments:

My name is Merilyn Harris and I am the Administrator of Ka'u Hospital.

Thank you so very much for hearing this bill. Your support for this bill is very important to our community and we are very grateful for you attention.

Ka'u Hospital is a small critical access hospital located in Pahala on the Big Island. We are part part of the East Hawaii Region of Hawaii Health Systems Corporation. Our entire building is not much larger than one floor of the legislature yet our service area is as large as the entire island of Oahu. We have a four-bed 24/7 emergency department and 21 inpatient beds for acute/rehab and long-term care. We also have a family practice rural health clinic within our hospital that is located right next to the emergency department.

As the only hospital in the district, our job is to provide access to health care. We'd like to help our patients to access the right level of care at the right time. Frequently patients go to the ER for family practice issues because they have been unable to get an appointment with a primary care provider. If we can provide more urgent care options for patients and channel them to the right level of care when they need it, then we will be saving both patients and the health care system money. It will also free up emergency department resources for true emergency care. We see over 3,000 patients in our ER each year and that number is growing about 8% annually.

If we receive the funding identified in SB2617, our hope is to be able to add to the resources in our clinic and ER so that the can routinely take more of those urgent care or "sick" visits and possibly extend our hours to match community need more closely. In addition, we would use these funds to bring behavioral health services to our clinic. Currently, if one of our clinic patients require behavioral health services, they are referred to specialists in Hilo or Kona – both of which are 1.5 hours away by car .There is no public transportation to and from our area.

I know there are many demands for funding so I thank you for considering investing in health care for the people of Ka`u.

## Comments:

I strongly support SB2617. The population living on the southern portions of Kau and Puna District face a long drive to either Hilo or Kona hospitals.

While the Kau Rural Health Clinic provides citizens with some services, lacking an emergency room decreases survivability for those in desperate need of life saving emergency care. Emergent care for someone with a traumatic injury in that first golden hour often means the difference between life or death for the injured person(s). Being rural in nature, sometimes accidents occur in remote places and time is lost just getting to a hospital. I believe it is critical for the Kau Rural Health Clinic to be upgraded to include an emergency room.

Our clinic also lacks adequate outpatient behavioral health services. Facilities in Hilo and Kona are already (it seems) overstressed with long wait times for appointments, not to mention the traveling to Hilo or Kona for support. I think it would benefit our population to have these services and it would help ease the workload burden on the existing facilities on the island.

I strongly urge the passage of this bill. It is sorely needed for the southern half of the Big Island.
