Chair Lee, Vice Chair Buenaventura, and Members of the House Committee on Judiciary:

The Office of Planning (OP) **supports** SB 2701, HD 1 which amends Hawaii Revised Statues, Section 46-88 (c) to allow appropriate county fire and building permit agencies the right to enter exempted agricultural buildings to investigate allegations of violations and compliance with this section. This amendment would allow county agencies to exercise their enforcement powers and help to prevent the misuse of agricultural buildings and structures which sometimes are illegally transformed into residential uses. The amendment would also allow the counties to apply to the district court for a warrant, and to direct a police officer to provide assistance to the department or agency in gaining entry to the property.

This measure was also supported by the stakeholder group convened by OP's Act 278 Study of Subdivision and CPR on Agricultural Lands on Oahu. In discussions late last year, this enforcement measure was deemed needed to bolster county enforcement of illegal structures in the Agricultural District.

Chairperson Lee and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 2701. This measure grants county agencies the right to enter property to investigate agricultural buildings and structures for violations of and compliance with building code exemption qualifications. The Department of Agriculture supports the intent of this measure that promotes active monitoring and enforcement of these exempted structures. In particular, we point out that exempt structures are required to be "...located on a commercial farm or ranch and are used for general agricultural or aquacultural purposes..." (Bill, page 2, lines 5-7). If a commercial farm or ranch does not exist, the structure should not be exempted from the building code. The Department notes that this bill's effective date is 7/1/2050.
