We ask you to support SB 2795 which appropriates funds for one full-time equivalent (1.0 FTE) position, operating costs, and equipment to support the Office of the Lieutenant Governor in administering the Address Confidentiality Program. This critical funding would provide personnel to operate the Address Confidentiality Program, which was established with the creation of Act 115 in 2018. This will enable us to join the 36 other states who have launched address confidentiality programs helping to protect victims of crimes such as sexual assault, domestic violence and stalking.
