Thank you for the opportunity to submit testimony on SB 2814 SD1. The University of Hawai'i at Hilo and the Daniel K. Inouye College of Pharmacy fully **supports** this bill to appropriate funds to the Hilo Medical Center (HMC) for a second cardiac catheterization lab to help improve cardiac care services.

The HMC is the flagship hospital and is a key partner in training our students in both introductory and advanced experiential practice rotations. We place a full time Pharmacy Practice faculty in residence in HMC to teach and mentor our students. Having our students learn about the key components of all aspects of hospital care helps them to better understand the interprofessional complexities of patient care. Since last year, 2019, we went from zero to a group of four permanent cardiologists, including 3 who are certified interventionalists.

We can now provide acute 24/7 cardiology care such as heart attack intervention and pacemaker placement. When a patient presents with an evolving heart attack, we have only 90 minutes to re-establish blood flow to their coronary arteries, "time is muscle". We open up arteries with angioplasty and maintain their patency using stents. We can also use pacemakers/defibrillators to keep the heartbeat regular. This saves cardiac muscle and thus saves lives. It has also saved us from having to transport these critical patients off-island which is costly in time and dollars. It also keeps them near their families while they receive care. So far, we have done nearly 1200 procedures, including 50 evolving heart attacks, 253 stents, and 163 pacemakers/defibrillators. We have done this using a single vascular lab which is shared with interventional radiology.

This single lab is the only one on the Big Island to provide this cardiac acute care for heart attack. In contrast, there are 15 vascular suites (Honolulu County 12, Maui 3) already operating on the other islands.

This single vascular lab is exceeding its schedule allowed for cardiology and is under constant strain. With only one lab, if a scheduled case is in process and an emergency comes in, we will be unable to give the best standard of care which is angioplasty.

If a second lab is operating, our facility could apply for STEMI Center status which requires at least a 2nd lab or hybrid.

There is a definite need for a 2nd Cardiac Catheterization Suite on the Big Island and I fully support this bill.


