SENATE BILL NO. 2824 RELATING TO AGRICULTURE

Chairperson Gabbard, Vice Chair Ruderman and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2824, relating to meat inspection and meat processing. The bill appropriates funds to the Department of Agriculture to support the establishment of three full time equivalent meat inspection positions to perform meat inspection services.

The Department is in support of the bill's intent to provide meat inspection services and promote the state's livestock industries. However, the Department notes that its previous meat inspection program was discontinued in the mid 1990s due to cuts in budget and staffing mandated by the reduction in force directives. The USDA-Food Safety Inspection Service (FSIS) assumed responsibility for those obligations and has been performing meat inspection services statewide in Hawaii since that time. As such, if a meat processing plant were approved for operation in Hawaii, the USDA-FSIS would be the only regulatory agency that can conduct inspections for the plant's meat production activities at this time.
