<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) supports this administration measure that continues the reform of the State's juvenile justice system.

<u>PURPOSE</u>: The purpose of this bill permits individual vocational programs within the purview of the Office of Youth Services to engage in commercial enterprises, including the sale of goods and services, for self-sustainability purposes, for young adults only. Establishes the Office of Youth Services Revolving Fund. Appropriates funds.

Act 201, Session Laws of Hawaii (SLH) 2014, initiated juvenile justice reform in Hawaii to improve and enhance Hawaii's juvenile justice system. Working collaboratively cross-sector, there has been a twenty-six per cent reduction in admissions to the Hawaii Youth Correctional Facility since Act 201 became law.

Act 208, SLH 2018, established the Kawailoa Youth and Family Wellness Center at the campus of the Hawaii Youth Correctional Facility, to provide much needed services for at-risk youth and young adults, including victims of commercial sexual exploitation of children (CSEC).

Innovative programs have commenced at the Wellness Center, and this program will provide skills building, vocational training, and economic programing to prepare young adults for entry into the workforce.

OFFICE'S POSITION: The Office of Youth Services (OYS) supports the measure. It will allow OYS to create and expand career and vocational programs through the establishment of a revolving fund, that would receive proceeds from sales for products and services generated by young adults participating in these programs. The State will save money by lessening dependence on funding from State resources. I ask that you would **strongly support SB 2891** to allow the Office of Youth Services to create commercial enterprises and authorize a revolving fund to allow the programs to be sustainable. In particular we support Kawailoa Youth and Family Wellness Center (former Hawai'i Youth Correctional Facility) to be able to sell its beef and produce on the open market. We have worked with Administrator Mark Patterson and his staff for the past two years on this campus and have found them to be extremely dedicated, accountable and above board in seeking the best solutions for the youth being served.

Kawailoa plans to create Hale Mololani, a residential vocational program on its campus for the at-risk 18-24 year old youth who have aged out of the judicial and foster care systems but lack the means to be self-sufficient. The program will provide valuable services through its experiential learning program including basic life skills, promote work ethic, education, vocational skills and assist them in building community relationships. SB 2891 will enable Kawailoa to improve outcomes for these vulnerable youth and young adults positively impacting the greater community of our island state.

We are always mindful that more than 1,200 of Hawai'i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

Aloha Chair Ruderman, Vice Chair Rhoads and members of the Senate Committee on Human Services, my name is Stephen Morse. I am the Executive Director of Blueprint for Change, and I am here today to support SB 2891 relating to the Office of Youth Services, Office of Youth Services Revolving Fund; Commercial Enterprise Vocational Programs.

Senators, for the record, Blueprint for Change (BFC) is a non-profit organization that develops and supports community driven programs that help develop healthy and productive children and families. We currently oversee 6 Neighborhood Place programs statewide and manage a three-year grant from the U.S. Department of Education's Native Hawaiian Career and Technical Education Program that provides agricultural related classes to formerly incarcerated Native Hawaiians and their family members through a distance learning medium in partnership with Hawaii Community College.

My staff and I have had the opportunity to visit Kawailoa Youth and Family Wellness Center (KTFWC) and are impressed with how OYS and Warden Mark Patterson are converting underutilized facilities into a place where adjudicated and at risk youth can find shelter, healing, and sustainable skills.

SB 2891 is a crucial element in the future of the Kawailoa Youth and Family Wellness Center. The ability for OYS to create commercial enterprises will allow KYFWC to create a residential vocational program for those young adults (18-24) aging out of the Judicial and foster care system. Many of these youth may have no familial structure to fall back on. Vocational training instills a sense of confidence and independence for youth, building skills they are able to then apply to the job market and thrive through a deeper sense of self-determination and improve their chances of economic stability once released.

SB 2891 is part of a great plan to re-invest State resources to help these youth realize their potential and become self-reliant. In the process, they become productive citizens, no longer a burden on the State. We ask for your support. Mahalo.

As a clinical psychologist and Affiliate Faculty member at the University of Hawaii, Social Science Research Center with formal training focused on child and adolescent clinical psychology, and as a researcher, program consultant, and program evaluator with work experiences involving projects at the Hawai'i Youth Correctional Center, Kapolei Juvenile Detention Facility, Hawai'i State Department of Health – Child & Adolescent Mental Health Department, and the Hawaii State Department of Public Safety, I am writing in strong support of S.B. 2891, Relating to Office of Youth Services. Passage of this bill will permit individual vocational programs within the purview of the Office of Youth Services to engage in commercial enterprises, including the sale of goods and services, for self-sustainability purposes, for young adults only.

SB 2891 is a critical component for the future of the Kawailoa Youth and Family Wellness Center (KYFWC) toward becoming an effective and sustainable rehabilitation-focused program for youth transitioning out of the Juvenile Justice system and seeking positive pathways to meaningful work and satisfactory quality of life as a young adult. More specifically, the ability for the Office of Youth Services to create commercial enterprises at KYFWC will support a residential vocational program for those young adults (18-24) aging out of the Juvenile Justice and foster care systems to achieve the level of self-sufficiency and independence necessary to earn a living wage and create a meaningful life outside of criminal behaviors. The ability to engage in commercial enterprises as part of their rehabilitation programs at KYFWC will provide a foundation for youth based on social entrepreneurship, effective life skills, educational achievement, employable skills, and social support networks in the communities they will be reentering. This program is being developed to be self-supporting and managed by the young adults at all levels, serving to enhance their self-esteem, provide a sense of hope, and offer opportunities they might not otherwise have available to them in their rehabilitation process.

In expanding these types of critical and innovative opportunities for youth aging out of our social services systems, we will be creating a positive, health and wellness-focused program, as well as hope and meaningful opportunities for disadvantaged and disconnected youth as they prepare to reenter their communities and reengage with their families and other support systems. I urge the committee to pass S.B. No. 2891. Thank you for this opportunity to testify.

Aloha Chair Ruderman, Vice Chair Rhoads and members of the Senate Committees on Human Services, my name is Lilinoe Kauahikaua, I am a Masters of Social Work Candidate at the University of Hawai'i at Mānoa, and I am here today to support SB 22891 relating to to the Office of Youth Services, Office of Youth Services Revolving Fund; Commercial Enterprise Vocational Programs.

In my current study as a Master's of Social work Candidate, I have focused primarily on the over-representation of Native Hawaiians in the criminal justice system, those currently incarcerated, and those housed in out of state facilities. I am called to this work because of my own experiences with incarceration, and substance abuse, and homelessness.

I have had the opportunity to visit Kawailoa Youth and Family Wellness Center (KTFWC) on multiple occasions. KTFWC is changing the way we approach early predictors and contributing factors to juvenile delinquency. KYFWC instead centers on reframing the narrative, diverting focus away from deficit-based understanding, and instead, developing increased emphasis and interventions that focus on positive youth development that contribute to preferred outcomes.

SB 2891 is a crucial element in the future of the Kawailoa Youth and Family Wellness Center. The ability for OYS to create commercial enterprises will allow KYFWC to create a residential vocational program for those young adults (18-24) aging out of the Judicial and foster care system. Many of these youth may have no familial structure to fall back on. Vocational training instills a sense of confidence and independence for youth, building skills they are able to then apply to the job market and thrive through a deeper sense of self-determination and improve their chances of economic stability once released.

Unlike strictly trade programs, this program will allow youth to gain valuable skills through a wide range of vocational applications based on social entrepreneurship. These applications will allow them to flourish, learning life skills, inspiring further educational aspirations, and building both personal and professional relationships.

SB 2891 would give our youth a fighting chance to show us just how resilient they are.

Thank you for the opportunity to provide testimony in support of SB 2891. This bill is a thoughtful attempt to build on the Legislature's Act 201 which implored the community to improve outcomes for Hawaii's youth in the juvenile justice system and expand community resources.

The programs that comprise the Kawailoa Youth and Family Wellness Center strive for many beneficial outcomes that include: maximizing the use of a beautiful and underutilized property (grounds of the Hawaii Youth Correctional Facility (HYCF), offering a wide range of programming that service providers seek to better respond to the youth and their families, and preventing youth from further juvenile justice involvement and potential incarceration at HYCF.

This is a very progressive and exciting endeavor as it continues to strengthen the vision of the Kawailoa Youth and Family Wellness Center and truly make a difference to some of the most vulnerable young adults.
