<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) appreciates the intent of this bill, offers comments, and suggests an amendment.

<u>PURPOSE</u>: The purposes of this bill authorizes a civil cause of action by a vulnerable adult for financial exploitation of a vulnerable adult. Allows attorney's fees and costs and punitive damages. Establishes degrees and classes of felonies for financial exploitation of an elderly person or disabled adult. Establishes a presumption of financial exploitation.

DHS appreciates the Legislature's recognition of the serious injustice of financial exploitation of Hawaii's elderly and disabled adults which is increasingly prevalent in communities and within families.

We support the intent of the new section adding a civil cause of action by private litigants. However, we respectfully request the new section be added to Chapter 663, Tort Actions, to make certain and clear that the cause of action is available to private litigants and will not be the responsibility of DHS to commence such action. If placed in Chapter 346, we are concerned that the new section may be interpreted as an agency function when AN EQUAL OPPORTUNITY AGENCY

responding to reports of abuse or neglect of a vulnerable adult.

DHS supports the new amendments to establish classes of felonies for financial exploitation of elderly or disabled adults.

Chair Karl Roads and Vice Chair Russell E. Ruderman, thank you for the opprotnuity to provide Testimony on SB 2949.

My name is James H. Pietsch and I am providing testimony on my own behalf and not on behalf of the University of Hawai'i. I strongly support SB 2949. Financial exploitation of older persons in our community is increasing and victims, especially vulnerable victims, have limited remedies they can pursue, and the police are often reluctant to charge a perpetrator of financial exploitation under the current law, especially regarding violations of fiduciary duties. I receive many calls in the University of Hawai'i Elder Law from both victims and family members regarding financial exploitation and it is frustrating that the legal system does not have adequate tools to address this growing problem. SB 2949 would provide additional legal tools. Among other provisions, it gives "vulnerable adults" a civil cause of action for damages, punitive damages and attorney fees and costs when they have been financially exploited, it includes provisions regarding violations of fiduciary duties to elderly or disabled adults by guardians, trustees and agents under powers of attorney for misappropriating, misusing, or transferring without authorization money belonging to an elderly person or disabled adult from an account in which the elderly person or disabled adult placed the funds, owned the funds, and was the sole contributor or payee of the funds before the misappropriation, misuse, or unauthorized transfer and it creates a presumption of exploitation independent of capacity issues with respect to older persons under precise criteria. The state of Florida has these provisions in its laws, and they appear to be working. It is time for our state to enact similar legislation to protect our fast growing vulnerable population from financial exploitation.

Again, thank you for the opportunity to provide my testimony.
