Relating to Campaign Finance Testifying in Support with amendments

Aloha Chair and members of the committee,

The Pono Hawai'i Initiative (PHI) supports with amendments SB2989 SD2 Relating to Campaign Finance, which allows candidates seeking election to use campaign funds for childcare costs.

Running for office is hard. This measure will help to ease the financial burden for those candidates with children. Encouraging more individuals to get involved in politics and elected office is essential for democracy to thrive. Historically women have been the family caregivers, and this has translated to fewer women and low-income individuals from seeking elected office. This measure will help open doors for more women, single parents and other low-income individuals to be a part of the political arena.

Even though many elected positions are considered part-time, being an elected official doesn't always translate to a typical 9-5 workday. For those individuals who represent the neighbor islands in the State legislature it can mean Monday – Friday on a different island all together from where your children are located. We should not limit these individuals from utilizing their campaign funds to offset the unique childcare requirements that holding public office sometimes requires. **PHI requests the measure be amended** to allow funds to be used year-round, whether in an election year or not. A candidate and/or an elected official can use campaign funds to pay for tickets to events, draft and publish newsletters or buy campaign paraphernalia with no date restrictions if those expenditures fall in line with campaign activity. Let's not penalize a candidate because they have childcare needs because of the time commitment running for office and maintaining that office might require year-round. If you restrict the use of funds for childcare, then you should extend that restriction to the use of campaign funds during the same dates to be consistent.

For all these reasons, we urge you to consider amending this measure to continue to help these individuals once they are elected. Let's be honest, deep down it's always an election year.

Regulations that expressly allow campaign funds to be spent on both childcare and dependent care will help keep campaign finance models modernized.

Common Cause Hawaii further suggests lowering the age of the child to under 18, as currently set in SB 2989, SD1. Persons 18 years of age or thereabouts may not need childcare.

Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") appreciates the intent of this bill and offers the following comments.

This bill amends Hawaii Revised Statutes ("HRS") §11-381 by amending subsection (a) to add child care costs as an additional permissible expense of a candidate committee in a new paragraph 9. Since "immediate family" is already defined in HRS §11-302, the definition of "immediate family members" on pages 5 (lines 18-20) to 6 (lines 1-2) is unnecessary and should be deleted. If, however, the Committee only wants to prohibit payment for child care service rendered by immediate family members who live in the candidate's household, rather than all immediate family members, then the Committee should amend paragraph (c) of subsection (9) (page 5, lines 6-7) to read, "The child care services shall not be provided by an immediate family member who resides in the same household of the candidate."
