Dear Chairman Takayama:

On behalf of the members of the National Rifle Association in Hawaii, I would like to communicate our opposition to Senate Bill 3054SD2 (SB 3054).

SB 3054 requires individuals to provide notice of permanent removal of a firearm outside the state with the registering county within five days.

This legislation is rooted in unsound policy and does nothing to address the criminal misuse of firearms. Instead, it will expose otherwise law-abiding citizens to monetary penalties of \$250 per firearm for simply moving out of state. A modest collection could result in thousands of dollars in penalties for failing to report the removal. If passed, this legislation will have an especially detrimental impact on the many military members who are stationed in Hawaii, who may be relocating at a moment's notice. Further, this legislation fails to address the many visitors who come to Hawaii with firearms that are forced into registration for the short duration of their stay or the lack of public notification for persons who have decided to move out of state.

The purpose of the bill as stated in the preface is to maintain an accurate count of firearms in the state, however meaningless state record keeping is hardly a rationale to subject people to monetary penalties. Instead the focus of the state should be public safety and addressing criminal misuse of firearms, not bureaucratic exercises that serve as a complete waste of the state's finite law enforcement resources.

SB3054 requiring notification to HPD of all firearms being moved permanently out of state is just another example of a bill that does nothing to make hawaii safer. This is a bill for data collection only which would require additional manpower and burden the police dept even more.

More concerning is the fact that it makes criminals out of lawful abiding firearms owners and imposes a 250 dollar fine on top of that.

Military members stationed here are required to register their firearms within five days of coming here. Now you want them to "unregister" when they leave, which can be an additional burden to them in an already stressful time when they are trying to pack up the belongings and families for their next assignment.

What happens to Hawaii residents who may have another home besides the one in hawaii. What if they live here half the time and in the other home the other half of the year. They may want to bring their firearms with them during that time. Will that be an issue?

When notifying the County that you are permanently leaving the State, can it be by e-mail or need to be in person. How is verification made that you are moving any particular firearm out of State?

It just seems like another way to restrict our firearms rights, put burden on us and the police just to have data collection.

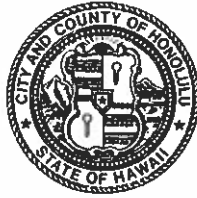

Aloha Members of the House Committees,

The Hawaii Firearms Coalition **OPPOSES SB3054** and **REQUESTS AMENDMENTS**.

Please answer these questions:

- 1. How does this prevent crime?**
- 2. Is the benefit to society worth a \$250 fine to a good citizen?**
- 3. Is this a priority bill to pass during the COVID19 emergency?**

This bill unfairly penalizes good citizens for the sake of keeping administrative statistics on firearms ownership and does nothing to prevent crime. This bill will mainly affect military members who frequently transfer out of Hawaii with firearms. \$250 per firearm is a drastic penalty for an administrative function and is meant to threaten firearm owners.

HIFICO would support this bill with the following amendments:

1. Remove the civil fine.
2. Permanently remove the owner's and firearm's registration data from all government databases (including RAPBACK) when their firearms are permanently moved out of state, sold to another registered owner, or destroyed.

HIFICO constantly receives input from the firearms community asking for their firearms registration data to be permanently deleted when their firearms are taken out of the state, sold to another person, or destroyed. This is all the incentive needed for firearms owners to voluntarily report that their firearms are no longer present in Hawaii.

Comments:

This is an incredible waste of the citizen's of Hawaii's resources for what? If an individual moves away or permanently removes a firearm from Hawaii, several states do not require more than the Federal ATF Form 4473 at time of purchase so there will be no county permitting system to generate the letter required by this proposal; making an otherwise lawful citizen run afoul of the law by legislative caveat.

Another way forward would be that the legislature recognize that law abiding citizens are not children requiring their care, but should have the trust of the government to inform the local police department (or designated entity) their intent to remove firearms. This way the government can annotate those permitted firearms are removed from Hawaii. However, to do so indicates that the present permitting system is a registry scheme which under Federal law the ATF is expressly forbidden for doing. I believe this creates a potential lawsuit against the State for attempting to create such a registry. In the end, once again it will cost the taxpayers of Hawaii to defend the personal agenda of legislators who believe they know better than the electorate.

There are other less intrusive, smarter ways to achieve the desired effects at a significantly reduced cost to the taxpayer; and in light of the effects of COVID-19 and announced budgetary shortfalls the people of Hawaii can ill afford to foot the bill for individual legislator's personal crusades. A responsible legislative body could conclude the first step in closing budgetary shortfalls is not enact additional costs that are not priorities at this time.

I oppose this SB3054 due to the following reasons:

- it is in violation of constitutional limitations on government; as public servants you have taken an oath to uphold and defend the constitution. Passage of this bill into law would mean that you are breaking your oath of office.
- this bill is poorly conceived and poorly written as many people do not know whether they will be leaving the state permanently or not; their firearms are already legally registered. If they move out of state permanently, it would be safe to assume that their firearms will go with them and not need to be registered except in the state to which they are moving if required by law.
- should this bill pass into law it would only punish law-abiding firearms owners; criminals will find a way to get ammo and guns regardless of what laws are in place. Think of the parallel with drugs like meth - meth and the makings of it are illegal however criminals still get it and we still have a terrible drug problem in Hawaii as a result. A more effective solution would be to increase the severity of penalties for people who commit violent crimes with firearms, not punish the people who peacefully and legally own and use their firearms.
- I am a legal firearm owner, enthusiast and licensed hunter. These bills if passed into law will only make my life more difficult and the lives of those like me more difficult and infringe on our rights as guaranteed in the constitution and your oaths to uphold it.
- In Honolulu, current wait time for firearms registration appointment is 11 WEEKS!!! Should this bill pass, firearms owners will be required to register their firearms again when moving out of state or face heavy fines. This is an undue, unjust and severely restrictive requirement for people who want to follow the laws. Criminals who won't follow the law with shorter waiting periods are definitely not going to follow the law with longer waiting periods. It will also criminalize folks who obey the law but aren't able to get an appointment for registration in the time required by law. How does this help solve gun crime and gun violence? The intent is not clear and the effects are clearly going to adversely affect those who just want to live their lives free from excessive and needless government interference and regulation.
- gun crimes in Hawaii are not a huge issue. Why the sudden focus on increasing already onerous and restrictive requirements when Hawaii has many other issues facing us of greater concern? Why not increase severity of penalties and focus on law enforcement rather than adding new laws to the books?

Remember your oaths to uphold the constitution. Remember that the constitution limits government infringement on personal liberties. Know that should bills like these become law you would be facilitating direct infringements on personal liberties guaranteed in the constitution. Don't break your oaths.

It has no affect on crime, does not affect public safety or serve any lawful purpose. It also oversteps the States authority as the State would not have any legal jurisdiction over any person or item that is not within the State boundaries or legal enclave. How would the State prosecute this offense? By what mechanism would it be enforced?

How would said firearm be removed from the roles of registered firearms in the State of Hawaii? How would the record be destroyed as the State would have no legal purview over the firearm? How would the owner of the firearm be notified that the removal is complete? In most instances, the firearms have left the state with the owner. Is the owner duty bound to return to Hawaii to "unregister" the firearms as the firearms must be registered while they are in the State. Who is responsible for the costs incurred to travel back to Hawaii?

If the firearms are transferred via sale, there is already a mechanism under HRS 134-2 and 134-4. Even the firearms are sold to an out of state buyer they go through the transfer process via an FFL and completing the chain of custody for registration.

By creating another burdensome layer, the only thing accomplished by this revised statute would be creating "victimless crimes" and creating a "solution" to a problem that does not exist.

I urge you to OPPOSE SB3054.
