# TESTIMONY ON SENATE BILL 3073, SD1 RELATING TO WORLD WAR II COMMEMORATION

Good morning, Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony **in support** of the concepts in Senate Bill 3073, SD1.

This measure appropriates funds for programs, ceremonies and activities commemorating the 75<sup>th</sup> Anniversary of the End of WWII. After the surprise attack on Pearl Harbor, Hawaii played a prominent role in supporting the war effort directly. One example, the vast majority of the aviators and aircrew headed to the Far East received their tactics and specialized training on airstrips located in Puunene on the island of Maui before entering the lines of battle in the Pacific. Furthermore, despite having to fight on two distinctive battlefields, the heroism and sacrifice of many of our Hawaii Nisei Soldiers is well documented and highlights the incredible determination and loyalty that is truly representative of the "Greatest Generation."

The OVS supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families.

#### Aloha Representatives,

As the Executive Director of the 75<sup>th</sup> WWII Commemoration Committee and a member of our Hawaii community, I am pleased to add my very strong support to SB 3073, the 75<sup>th</sup> WWII Commemoration bill under review.

National legislation was passed creating the 75<sup>th</sup> WWII Commemoration, ensuring that as a nation, we remember and honor veterans and civilians, members of "Our Greatest Generation" who stepped forward to defend freedom. National Honorary Chairpersons, Senator Bob and Elizabeth Dole, and our State Honorary Chairmen, Gov. Ige and ADM Davidson, Commander, U.S. IndoPACOM, have committed their support to this effort.

Pearl Harbor holds the unique distinction of being the only place where people can experience the bookends of WWII – we often forget this historic impact. The Pearl Harbor National Monument stands in tribute to those who perished during the attack that launched our entry into this global conflict and the Battleship Missouri Memorial, now proudly moored in Pearl Harbor, reminds our nation of the end of conflict and the beginning of peace and global friendship that has changed our world.

Hawaii's participation did not just impact the war in the Pacific. As these stories unfold, the role and impact of fighting forces from Hawaii, courageous warriors who at the time faced harsh American racial prejudice, will add substance to the entire commemoration. The commemoration will help bridge the gap between historic tourism that only targets out of state visitors to a historic impact that targets local communities. The advent of the 75th WWII Commemoration opens the door to building local embracement of the very sites that currently serve primarily out of state visitors.

The idea of a Pilgrimage to Pearl Harbor, to Puunene, to Barbers Point, to Honouliuli National Historic Site and other such locations will resonate with our local communities who, during this commemoration effort, assist in building the story and the experience.



This bill will provide financial support for the activities planned for August 29-Sept 2, 2020 to honor the 75<sup>th</sup> anniversary of the End of WWII in Hawaii and to recognize and honor the men and women of the Greatest Generation who fought in that war for the freedom of not just the United States but for all freedom loving peoples of the world. This will likely be the last time that we as a nation can do these veterans this honor because the youngest ones are in the their 90's.

The USS Missouri, one the US Navy's most famous ships, is of course where WWII ended for all the nations of the world on Sept 2, 1945 in Tokyo Bay. Now permanently anchored at Pearl Harbor, just 500 yards from the Arizona Memorial where WWII began for the United States, they both represent the bookends of WWII for Americans. Although she was built for war, the Missouri, within 2 years of her launching, instead became an international symbol of peace and reconciliation- a message we impart to our visitors every day. In 2019, we welcome almost 600,000 visitors and have welcomed over 9 Million since we opened in 1999.

National legislation was passed last year to lend support of these remembrances both in Hawaii and in Washington DC, where the end of WWII in Europe will be recognized in May. The National Co-Chairs and Senators Bob and Elizabeth Dole and in Hawaii the Honorary Chairs are Gov David Ige and ADM Philip Davidson, the CO of INDO PACOM Command. The Dept of Defense is lending logistical and material support to all these activities and we expect many high-level leaders from all the countries who signed the peace document to attend as well.

The programs, events, ceremonies, tributes and exhibits planned will:

- Highlight the role of Hawaii communities during WWII, collecting stories, artifacts, and oral histories that can live on in museums, libraries and other sources of learning;
- Embrace Hawaii's diversity, honoring the role of groups whose impact and contributions to the war effort during the 1940's and after has been overlooked by history;
- Support community-based initiatives that promote local use of and participation in Hawaii's historic treasures;
- Ensure diverse activities/experiences throughout 2020 and beyond;
- Provide unique and authentic Hawai'i experiences that benefit local communities and strengthen the quality of the destination expectations;
- Create high level local engagement with visiting populations who also seek to remember, honor, and participate in the celebration of the end of a global conflict;
- Strengthen awareness for and the significance of the Battleship Missouri Memorial as a learning destination for local, national and international visitors;
- Engage media through streaming to share the Hawaii events statewide, nationally, and globally.

I urge, along with all the members of the 75<sup>th</sup> Commemoration Committee, your support of this important initiative.

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Chamber of Commerce Hawaii ("The Chamber") **supports** SB 3073 SD1, which appropriates funds for programs, ceremonies, and activities commemorating the 75<sup>th</sup> anniversary of the end of World War II.

The Hawaii Military Affairs Council (MAC) was established in 1985 as part of the Chamber, and advocates on behalf of Hawaii's military, and is comprised of business leaders and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region.

The attack on Pearl Harbor on December 7, 1941 resulted in the United States entering World War II. Hawaii played an integral role in the United States' efforts during the war as it served as the central location for the United States in the Pacific and many citizens from the islands served as troops. The most famous being the 442<sup>nd</sup> Regimental Combat Team comprised of Japanese Americans who went on to be the most decorated unit of its size in the history of the US Military.

In December 2019, Governor Ige announced the creation of a committee that would help to oversee this year's commemoration in Hawaii, and both the Chamber and MAC are honored to have a representative on this committee. While the federal government has allocated some funding for these celebrations, the committee is continuing to raise funds in order to support the number of events that are planned for August 29 to September 2, 2020 here in Hawaii. Support from the legislature, will help to ensure that we are able to honor one of the greatest generations in American history, as well as educate our youth about the impact that World War II left on the country and the world.

The Hawai'i Lodging & Tourism Association—nearly 700 members strong, representing more than 50,000 hotel rooms and nearly 40,000 lodging workers—supports Senate Bill 3073 SD1 which seeks to appropriate funds for programs, ceremonies, and activities commemorating the 75th anniversary of the end of World War II.
