In consideration of SENATE BILL 3135 RELATING TO ENVIRONMENT

Senate Bill 3135 proposes to appropriate funds to the Hawaii Invasive Species Council (HISC) to conduct an albizia prevention and control pilot project in the Luluku corridor of Kāne'ohe. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Supplemental Budget request.

The Department is the administrative host of the interagency HISC, which has previously awarded research and control funds related to albizia. Mitigation of albizia along roadways to avoid infrastructure damage is a core concept in the HISC's *Strategic Plan for the Control and Management of Albizia in Hawaii*, adopted in January 2018. As a small coordinating body, the HISC would likely use the funds appropriated by this measure to solicit proposals from qualified government field programs that have expertise in albizia control.

Aloha Chair Gabbard, Vice Chair Ruderman, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports SB 3135, which appropriates funds for the Hawaii invasive species council to conduct an albizia prevention pilot project.

In 2014, Hurricane Iselle devasted areas of Puna by toppling albizia. This only exacerbated the danger that albizzia already posed to Hawaii. Along with other pressing invasive species control initiatives, our farmer and rancher members across the islands could benefit from a well-coordinated and cost-effective effort to manage and remove albizia trees that threaten access to critical emergency services and transportation routes.

HFB strongly supports this measure which seeks to protect the people, environment, and agriculture in Hawaii.
