Title of Bill: SB 3156, SD1 RELATING TO EDUCATION.

**Purpose of Bill:** Establishes a statewide transition success network for high school

students with disabilities starting fiscal year 20212022, with a pilot project to begin in fiscal year 20202021. Appropriates funds. (SD1)

## **Department's Position:**

The Hawaii Department of Education (Department) supports the intent and appreciates the amendments to SB 3156, SD1 requiring the establishment of a statewide transition success network for high school students with disabilities and the establishment of the statewide transition success network. The Department is committed to preparing students with disabilities for success after high school through experiences in post-secondary education, vocational training, and competitive employment. The Department offers the following amendments;

## Page 6 Lines 20-21 and Page 7 Lines 1-7:

(5) Direct the coordinator to explore the option of working with University of Hawaii center on-disability studies to arrange for activities in its complex area to promote the purposes of this part, particularly needs arising from the review of annual needs assessment and common-elements in high school transition plans, for example, creating or expanding customized employment opportunities for students with disabilities; and work with the University of Hawaii Center on Disability Studies (UH CDS), who will be responsible for being the "broker" between the schools and the businesses that will work with students with disabilities. In addition, UH CDS will provide job coaches who will accompany and support students in integrated work sites; and

Dear Senator Dela Cruz and Members of the Committees:

SUBJECT: SB 3156 SD1 - Relating to Education

The State Council on Developmental Disabilities **SUPPORTS** the intent of **SB 3156 SD1**, to establishes a statewide transition success network for high school students with disabilities

The Department of Education and the University of Hawaii, Center on Disability Studies initiative for a pilot project sounds promising and the Council fully supports the effort. However, we noted the absence of reference to already federal and state funded partners in SB 3156 SD1. Such as Department of Human Services Division of Vocational Rehabilitation Pre-Employment Transition Services, Department of Health Developmental Disabilities Division Waiver Program, Department of Labor and Industrial Relations Youth and Disability Employment Initiative funding, as well as Pell Grant funding resources under the Free Application for Federal Student Aid (FAFSA) funding.

FAFSA funding reflects the need for the Department of Education and the Uiversity of Hawaii to identify how they will assist families whose children graduate high school with a certificate and are not part of the Department of Educations's Career Pathways program to access FAFSA funding for college/vocational training other than through the Division of Vocational Rehabilitation which has limited resources. FAFSA funding could be an additional resource, but is not available if the student does not have a General Educational Development (GED), high school diploma, exemption for home schooling under State laws, or enrollment in a recognized career pathway program and the "ability to benefit" from FAFSA funding for obtaining college or career school education.

For this reason we respectfully request a **new section be added to the bill** to assure state and federal funds are maximized. On page 7, line 8, change (6) to (7) and add (6) to read; "Direct the coordinator to explore the option of working with Department of Human Services Division of Vocational Rehabilitation Pre-Employment Transition Services, Department of Health Developmental Disabilities Division Waiver Program, Department of Labor and Industrial Relations WIOA Youth and Disability Employment Initiative funding, as well as Free Application for Federal Student Aid (FAFSA) funding to assure all partners of state and federally funded programs are common elements in high school transition plans, regardless if the student is on a certificate or diploma track; and"

Thank you for the opportunity to submit testimony and recommnedations to strengthen the need for SB 3156 SD1.

Dear Chair Dela Cruz and Members of the Committee,

The Special Education Advisory Council (SEAC) strongly supports SB 3156 SD 1 that establishes a statewide transition success network for high school students with disabilities.

In Hawaii, as on the Mainland, students with disabilities experience lower graduation rates, lower college-going rates, underemployment and significantly lower lifetime earnings than their nondisabled peers. Effective transition planning and appropriate supports are key to more successful postsecondary outcomes.

This bill leverages and builds upon existing resources within the Department of Education--its transition-focused interagency planning group, the Community Childrens Councils and the annual Footsteps to Transition Fair. It partners with the Center on Disability Studies that was responsible for designing evidence-based transition planning tools for use by Hawaii schools as early as the 1990's and continues to provide meaningful demonstration projects like the Jobs Now Partnership. By requiring each high school to design transition supports that meet the unique needs of their student population, this legislation moves the needle from pockets of success to a statewide system capable of preparing some of its most vulnerable students for future success.

SEAC appreciates the opportunity to provide testimony on this important issue, and we stand ready to support the Department in its efforts.

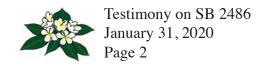

Chairman Dela Cruz:

**Thank you** for this opportunity. My name is Patricia Morrissey, I am director of the Center on Disability Studies, University of Hawai'i, Mānoa. I am speaking today, however, in my **private capacity**. I want to thank **Senator Kim** for introducing SB3156 and you for holding this **critical hearing**.

I support SB3156 SD1 as amended in the Senate Education and Human Services Committees. The legislation is ground-breaking. Based on my review, it is the only legislation in the Nation that proposes an evidenced-based infrastructure that will help the Department of Education, parents, other professionals, and community members offer, in a systematic way, designed by each high school, opportunities for young people with disabilities to prepare for and access postsecondary education and/or employment at a competitive wage in an integrated setting. It's timing, it's structure, and its components, especially the school-based transition plan for all students with disabilities in a high school are things that will create, sustain and expand what is now, only available in a few locations, throughout the state. Students will be offered a wide range of opportunities and training on, such things as – customized employment, soft

skills, internships, apprenticeships, self-determination, independent living, financial and technology literacy, coaching through simulations and real experiences, including job fairs and higher education recruitment events.

The provisions in this legislation grew out of a federally funded project called the Jobs Now Partnership being conducted by the **Center on Disability Studies**. By talking to parents, young people with disabilities, offering training, talking with professionals in the Department of Education and in other agencies, we have learned what is needed and demonstrated what is effective. By having a statewide infrastructure, we can do so much more and touch the lives of every child in high school with a disability and give them more than hope. We can provide skills and experiences that will allow them to enter adulthood successfully and become taxpayers.

Some of the specific benefits of enacting this legislation are:

- Transition plans in Individualized Education Programs will become more specific and effective
- Each high school will design a transition plan for the school and receive
   money to implement it.

Schools, parents, other professionals, and community members including
employers, will have a reason, a structure, and funding, to bring about more
collaboration and positive futures for young people with disabilities.

The amended version of SB3156 includes a pilot project in school year 2020 – 2021, to launch and learn from the evidence-based provisions in this legislation as early as possible and serve as a catalyst for launching the network statewide in school year 2021-2022. I respectfully request that you provide an appropriation, perhaps \$300,000, to initiate the pilot project and allow for the provision of technical assistance to the selected school.

### Comments:

Aloha, my name is Shree Deshpande and I am a graduate student at the University of Hawai'i. I have worked with students, and the families of students with intellectual and developmental disabilities mostly of transition age for the past year and a half.

I support SB3156 SD1. I am enthusiastic about the bill ensuring equal opportunity for jobs and living for students with intellectual and developmental disabilities. I am also excited for its positive economic impact for Hawai'i.

We take opportunity for granted when we don't have a visible or marked disability or a student with a visible or marked disability. These students deserve equal opportunity for jobs and living. The pilot study would fund the basis of a broader network that would see these students having expanded opportunities for job training, workshops for parents, teachers, and students, on topics as diverse from IEP construction to social skills, to employers attending reverse job fairs at high schools.

In turn, the bill will have a positive impact on Hawaiʻi's economy. If we want Hawaiʻi to have a workforce that is not merely confined to tourism and construction and that can withstand the impact of automation, it will need a large trained and skilled workforce. According to a recent fact sheet released by the Department of Labor & Industrial Relations Research & Statistics office on job opportunities in 2026 (<a href="https://www.hiwi.org/admin/gsipub/htmlarea/uploads/BJO-2016-2026-State-Rev.pdf">https://www.hiwi.org/admin/gsipub/htmlarea/uploads/BJO-2016-2026-State-Rev.pdf</a>), the "best" job opportunities for folks without a high school diploma or with only a high school diploma have a high chance of being automated. This bill would help ensure students with intellectual and developmental disabilities are not confined to staying at home, nor relegated to temporary or otherwise precarious jobs. They would be visible and productive members of society working a variety of jobs that require a diversity of skills. Because they were able, ready, and prepared thanks to measures like this bill.
