- **EOA's Position:** The Executive Office on Aging (EOA), an attached agency to the Department 1
- 2 of Health, supports the intent of SB3175.
- **Fiscal Implications:** This measure appropriates \$275,000 for FY20-FY21. 3
- Purpose and Justification: The purpose of this bill is appropriate funds to the state health 4
- insurance assistance program so that it can grow and continue to reach additional senior citizens 5
- in Hawaii with its important services. 6
- 7 Administered in Hawaii by the Executive Office on Aging, the Hawaii State Health Insurance
- Assistance Program (SHIP) is a volunteer-based program whose mission is to empower, educate, 8
- 9 and assist Medicare-eligible individuals, their families, caregivers, and soon-to-be-retirees
- 10 through objective outreach, counseling, and training to make informed health insurance decisions
- that optimize access to care and benefits. 11

1 Hawaii SHIP is recognized as a reliable source in Hawaii for accurate information on health 2 plans and other related topics. The service is local, one-on-one, and unbiased, as Hawaii SHIP is not affiliated with any insurance company or entity. Topics include Medicare eligibility and 3 enrollment, Late enrollment penalty, Medicare Parts A, B, C, D, Medicare Supplement/Medigap, 4 5 medical/drug plan comparison, Extra Help, Medicare Savings Program, Social Security card replacement, Social Security disability, long-term care benefits, Medicaid eligibility and 6 7 disenrollment, dental, vision, hearing plans, durable medical equipment, preventive screenings 8 and services, quality of care monitoring, scams and fraud education, coordination of benefits, 9 claims/appeals, summary notice/billing discrepancies, plan terminations, broker/agent 10 misrepresentation, and Marketplace plans for uninsured or underinsured. The services provided by SHIP has demonstrated at the national level to save beneficiaries hundreds of thousands of 11 dollars. For example, \$110 million dollars saved by beneficiaries in Massachusetts, \$56 million 12 in Michigan, and \$53 million in North Carolina. Medicare beneficiaries who chose the least 13 14 expensive Part D prescription plan available in their region, saved an average of \$368 per year. 15 The state health insurance assistance program has two full-time equivalent (2.0 FTE) staff that train and support over one hundred certified Medicare counselors statewide. In 2019, Hawaii 16 SHIP volunteers and in-kind staff contributed 6,733 hours valued at over \$171,220, based on the 17 national rate of \$25.43 per hour of volunteer work (source:https://independentsector. org/news-18 post/new-value-volunteer-time-2019/). Volunteers provide one-on-one counseling, support 19 20 community outreach events, senior and employer group presentations, administrative support, training, and distribution of information statewide. In 2019, 3,100 inquiries were made to the 21 22 Hawaii SHIP helpline and website. Approximately 2,264 individuals received counseling, and

- 1 14,335 individuals were reached at community events. Hawaii SHIP averaged over twenty
- 2 inquiries and counseling sessions per day.
- 3 In 2018, Hawaii had 262,864 Medicare beneficiaries (Part A or Part B), and that figure continues
- 4 to grow. However, the number of dedicated staffing positions has never changed since the
- 5 inception of the program. The table below shows the number of full-time dedicated staffing of
- 6 other states that have comparable Medicare populations.

- 7 Hawaii SHIP has experienced significant growth during the past three years, however, still falls
- 8 short of the three percent (3%) penetration goal of the total Medicare population, as set by the
- 9 federal funders. Three percent of the Medicare market in Hawaii approximates to seven thousand
- five hundred (7,500) individuals assisted annually. However, further growth is not possible at
- 11 current staffing and funding levels.
- 12 In 2017, President Trump proposed cutting the SHIP program entirely, however, strong
- advocacy resulted in the re-establishment of the original 49 Million(M) budget, which was
- subsequently distributed in population-based awards to 54 grantees nationwide. In 2020, the
- 15 SHIP program is again being challenged by the President with a proposed 30% to 100%
- proposed cut to the SHIP budget for 2020-2021. Due to the instability of SHIP's federal funding,

- the future of Hawaii SHIP is uncertain. For the first time in 28 years since the program began,
- 2 EOA is seeking general funds to support the invaluable counseling and educational services that
- 3 Hawaii SHIP provides to older adults, their families, and soon to be retirees. With additional
- 4 funding, EOA/Hawaii SHIP will expand outreach and Medicare counseling sites to increase
- 5 access to SHIP services, targeting populations with limited income, limited English proficiency,
- 6 or who reside in rural communities across the State.
- 7 **Recommendation**: EOA supports the intent of this measure provided that its enactment does not
- 8 reduce or replace priorities with the Administration's budget request.
- 9 Thank you for the opportunity to testify.

Support for H.B. No. 2452 / S.B. No. 3175, Relating to the State Health Insurance Assistance Program

Dear Senators Dela Cruz and Keith-Agaran;

I am a volunteer Medicare counselor with the State Health Insurance Assistance Program and am also a retired physician who saw patients in the Hilo area and was the East Hawaii Medical Director for the Hawaii Health Systems Corporation from 2010 until 2017. In both my clinical practice and as a hospital medical director, I saw or heard of many patients who did not get the medications, lab tests, x-rays, or follow-up care because they were concerned about the cost. For example, it is estimated that 30% to

50% of patients either never pick up their prescriptions or take them incorrectly, partially due to financial concerns. Their financial concern is often because they made a poor choice of insurance or were not aware of the many programs for low income Hawaii and U.S. residents. I believe that I and the many SHIP volunteers are helping our fellow residents obtain better coverage that will allow them to make medical decisions with less concern about cost. Better ability to pay and health for our residents will also ultimately result in lower costs to our health care system, which is significantly subsidized by the state and the U.S. government.

An example is a resident that I counseled yesterday who is 68 years old and whose's only medical insurance is the free Medicare Part A which only partially covers hospital costs. She has no insurance at all for outpatient care. She had a major injury to her leg, did not seek care until she get much worse because of cost concerns, and now has a much worse situation with thousands of dollars in doctor bills and who may end up with additional thousands of hospital bills if she needs in-patient care. It is very likely that she will not be able to pay for her care. If she had approached a SHIP counselor before this accident, it is very likely that we would have been able to help her obtain cost effective insurance or a subsidy program and would have been able to prevent the worsening of her health and financial situation. Cases like this is the reason why I and other counselors have volunteered. In addition, if she and others like her cannot afford to pay their bills, the State of Hawaii sometimes directly or indirectly end up subsidizing the public hospitals and their clinics for un-reimbursed care.

In my previous role as Medical Director for three hospitals on the Big Island, I have dealt with many staff members and executives of Hawaii State Government. I have found the very small number of staff working at the SHIP program to be among the very best state employees that I have encountered, due to their very hard work ethic due to understaffing, their prompt and helpful responses to my and other volunteers' many questions and suggestions, and their dedication to serving the needs of the SHIP clients. It is clear to me that they need additional staff, and that staff will give them a much better chance of reaching the increased number of clients needed to continue the federal funding for SHIP.

Therefore, I encourage you to pass SB3175 and HB2452 because the cost is low compared to the benefit to the clients and to the State of Hawaii budget through continued federal funding. Thank you.

## Background Information about SHIP

Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families and caregivers, and soon-to-be retirees make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling sessions, answering questions and distributing informative brochures at health fairs, and providing Medicare-related presentations. These services are free to the public who contact Hawaii SHIP through the Help Line and website. Volunteers, who provide these important services, are recruited and trained throughout the year to keep up with the changes or updates to Medicare.

Hence, I strongly support H.B. No. 2452 / S.B. No. 3175, Relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding to build partnerships and increase our volunteer base to inform and educate more people throughout Hawaii about Medicare.

There are 276,478 Medicare beneficiaries statewide as of December 2019. Hawaii SHIP's goal is to assist as many beneficiaries in Hawaii as possible. In 2019, SHIP had 3,100 inquiries to the Help Line and website, 2,264 seniors received counseling, and 14,335 individuals were reached at community events. By 2025, SHIP will need to reach 10,000 Medicare beneficiaries which is a 340% increase from SHIP's current capacity.

With more partnerships and volunteers, Hawaii SHIP could provide more outreach and education to Hawaii's residents. I urge the committee to pass H.B. No. 2452 / S.B. No. 3175. Thank you for this opportunity to testify.

While assisting a disgruntled beneficiary with a complex insurance issue, I derived inexpressible pleasure when his mood did a complete turn-around during our phone counseling session which ended with this declaration, "I'm calling the President to ask that you volunteers get paid for all that you do!" I silently chuckled at the irony of what he said. These lighter moments of humor along with the gratitude, appreciation, & friendly hugs, have given me a meaningful purpose in retirement & immeasurable rewards along with friendships shared with admirable SHIPmates. Moreover, our outstanding staff at the helm deserve our recognition & appreciation during this opportunity to present testimony.

I humbly ask the members of the Ways & Means Committee to favorably consider & support SB 3175 for general funding to expand our on-going journey to provide assistance to Hawaii's aging "tsunami" population, who deserve only smooth sailing in their golden years.
