Testimony of Ku'uhaku Park On Behalf of Matson Support of SB3176 Before the Committee on Transportation February 7, 2020

Dear Chair Nishihara, Chair Inouye, Vice Chair Wakai, Vice Chair Harimoto, and Members of the Committees,

Matson <u>strongly supports</u> SB3716, Relating to Motor Vehicle Registration. This measure requires that any authorization by a county director of finance for electronic motor vehicle registration shall apply to all motor vehicles.

Currently, only personal motor vehicles are able to submit electronically registration documents to the State and the respective county. Registration for all other types of motor vehicles requires submission of paper documents. The means of accepting electronic registration documents are already in place.

Matson requests an amendment on page 1, line 12 to allow the authorization to extend to intermodal equipment as well as all types of vehicles. Intermodal equipment means trailing equipment that is used in the intermodal transportation of containers over roadways, including trailers and shipping container chassis.

Allowing electronic registration for all types of motor vehicles, including shipping container chassis, would enable the State, counties, and companies like Matson to save time and cost.





Aloha Chairs and Committee Members,

I am Verne Santos, President of B & C Trucking Co., Ltd. We have over 20 commercial motor vehicle power units and over 15 commercial motor vehicle trailers.

B&C Trucking Co., Ltd. strongly supports SB3176.

The renewing of a commercial motor vehicle power unit registration is a very time-consuming process. First, we have to obtain a Heavy Weight Vehicle Tax Clearance by faxing proof of payment of federal heavy vehicle use tax to the State of Hawaii Department of Transportation. We then pick up the Heavy Weight Vehicle Certificate from the Department of Transportation office on Ponohana Place in Aiea. Then, we travel to a Satellite City Hall with documents in hand (hopefully the line is not too long) and complete the registration process. Sometimes we have to submit a current validated safety check form, depending on its expiration date.

The registering of a commercial motor vehicle trailer does not require a Heavy Weight Vehicle Certificate. It may require a copy of the current validated safety check, depending on its expiration date.

The ability to register and send supplemental documents in electronic format for all types of motor vehicles will help us save time and money.
