## In consideration of SENATE BILL 364, SENATE DRAFT 1 RELATING TO TOURISM

Senate Bill 364, Senate Draft 1 proposes to establish a professional tour guide certification task force to determine whether it is appropriate to require persons who use various state resources for commercial purposes or apply for various commercial use permits to hold and maintain certification or meet minimum requirements, recommend existing certificates or certification programs that may be appropriate for this purpose, and make recommendations and plans regarding any necessary certification and renewal. The Department of Land and Natural Resources (Department) is in support and agrees with the measure as is currently reflected in the Senate Draft 1.

The Department agrees that insuring optimal quality and authenticity of informational content for the Hawaii tourism industry is a critical goal. In particular—when authorized tour guides transit Department lands the respective Divisions – in addition to insuring patron safety, also prefer that the guides are knowledgeable in both natural and cultural resources information and values.

The Department also agrees with the Senate Committees on Energy, Economic Development, and Tourism, Higher Education, and Water and Land, in which Standing Committee Report 653 states "the convening of a task force to examine all factors surrounding professional tour guide certification is necessary before any statutory or regulator changes are implemented".

In consideration of SENATE BILL NO 364 SD1 RELATING TO TOURISM.

Chairs Dela Cruz and Baker, Vice Chairs Keith-Agaran and Chang, and members of the Committees on Ways and Means and Commerce, Consumer Protection and Health: The Hawai'i Tourism Authority (HTA) **supports** Senate Bill 364 SD1, which establishes a task force to determine whether it is appropriate to require persons who use state resources for commercial purposes or who apply for commercial use permits to hold and maintain certification or meet minimum requirements. The HTA would also submit some amendments for consideration.

As the State agency tasked with strategically managing, marketing and developing Hawai'i's visitor industry, HTA agrees that it is important to ensure that our guests are presented with consistent and accurate information about Hawaiian history and cultural sites. Senate Bill 364 SD1 will help strengthen the tourism industry's efforts, and ultimately the Hawai'i brand, to ensure that Hawaiian culture is portrayed authentically and that the tourism industry and our visitors understand the importance of protecting Hawai'i's natural environment.

- (9) University of Hawaii at Hilo;
- (10) Hawai'i Community College;
- (11) Kapiolani community college;
- (12) Kauai community college;
- (13) Maui college;
- (14) Hawaii green business program;
- (15) Hawaii ecotourism association
- (16) Hawaii transportation association
- (17) Activities and attractions association of Hawaii, Inc.

## In **SUPPORT** of Senate Bill 364 SD 1 **Relating to Tourism**

Aloha Chairs Dela Cruz and Baker, Vice Chairs Keith-Agaran and Chang, and members of the Committees on Ways and Means and Commerce, Consumer Protection and Health:

The Hawaii State Aha Moku (Aha Moku) **Supports** Senate Bill 364 SD1, which establishes a task force to determine whether it is appropriate to require persons who use state resources for commercial purposes or who apply for commercial use permits to hold and maintain certification or meet minimum requirements. **The Aha Moku would also submit amendments for consideration.** 

We recommend striking lines 11-21 on page 3 and lines 1-8 on page 4 and replace the task force members with the following:

- 1. Hawaii Tourism Authority, who shall serve as co-chair;
- 2. State Sustainability Coordinator, who shall serve as co-chair;
- 3. Department of Business, economic development and tourism;
- 4. Public utilities commission,
- 5. State parks administrator;
- 6. Na Ala Hele trails and Access program manager;
- 7. Division of boating and recreation administrator;
- 8. Aha Moku Advisory Council, or its designee;
- 9. University of Hawaii at Hilo;
- 10. Hawaii Community College;
- 11. Kapiolani Community College;
- 12. Kauai community college;
- 13. Maui College;
- 14. Hawaii green business program;
- 15. Hawaii ecotourism association;
- 16. Hawaii transportation association;
- 17. Activities and attractions association of Hawaii, Inc.

One of the most important components of this measure, besides the safety, access and common etiquette education and outreach is the opportunity to educate visitors, tourists and kamaaina who visit these public areas on the accurate and generational unique cultural usage and history of the area or ahupua'a on which each area is located.

Aha Moku believes that requiring sustainable practices and professional tour guide certifications from persons in the tourism industry will advance this goal, in addition to enhancing everyone's experiences in each specific place. We strongly agree with the Legislature as it is stated in SB 364, SD 1 of this measure in Section 1. - "the tourism industry has a prominent role to play in protecting the State's natural resources, <u>perpetuating Hawaii's history</u>, and preserving a high quality of life for Hawaii's residents by switching the focus of the State's tourism industry from marketing Hawaii to helping to manage Hawaii's resources."

Aha Moku has developed an administrative structure that identifies and works with the individual ahupua'a within the State of Hawaii that follows our mandates as instructed by the Hawaii State Legislature. We are capable of bringing the traditional and generational knowledge of the families of each ahupua'a forward and believe that it is essential to include this specific knowledge of each place that tourism impacts. We believe that a task force that is being created through this measure will come up with a process that will benefit all.

The Aha Moku supports Senate Bill 364 SD 1, and we ask that this measure be adopted <u>as amended</u>. Mahalo for the opportunity to give input on this important measure.
