Bill Description: Requires the Department of Education, in collaboration with the Department of Business, Economic Development, and Tourism, the Department of Labor and Industrial Relations, and the University of Hawaii, to develop and implement a K-12 curriculum-to-career-pipeline initiative to ensure that the State's public school students are adequately trained and prepared to enter the State's workforce upon graduation from high school. Appropriates funds for the development and implementation of the program, including for (1.0) FTE

Educational Specialist II staff position.

EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support the Intent

Good afternoon. I am Lauren Moriguchi, Director of the Executive Office on Early Learning (EOEL). EOEL supports the intent of S.B. 373, S.D. 1, and respectfully requests that the Committee consider including other key industries or fields in Hawaii that are greatly lacking a pool of qualified workforce candidates, such as the specialized field of early childhood education, which is based on the science of how children learn and develop.

EOEL is statutorily responsible for the development of the State's early childhood system that shall ensure a spectrum of high-quality development and learning opportunities for children throughout the state, from prenatal care until the time they enter kindergarten, with priority given to underserved or at-risk children.

As we work to increase access to qualified early learning opportunities for our keiki, we must consider the severely limited workforce of qualified early childhood educators (i.e., those with

coursework and background in early childhood, and supported with ongoing professional development, who research shows are most effective).

- Even as the EOEL Public Prekindergarten Program stands now with 26 classrooms across the state, we have difficulty recruiting and turnover is high (when teachers have not completed coursework in early childhood education and their assumptions about pre-K teaching are inconsistent with the knowledge and competencies required of teachers in settings for preschool-aged children).
- Because the Program targets our underserved and at-risk children, it is especially important to have teachers who are able to support preschoolers and families living in difficult circumstances. If not, what may result are increased instances of stress-induced behavior problems and inappropriate referrals to special education. Nationally, suspensions and expulsions occur at a rate 3 times higher in public pre-K than in K-12. When vulnerable children encounter teachers who are unprepared to support their developmental needs, these children who can benefit the most from early learning are rejected at an even earlier age and their families are left without options.

Given the severely limited workforce of qualified early childhood educators in the state, we believe an initiative such as that proposed in this bill would be mutually beneficial for both the community and our students who are interested in entering the field of early childhood education.

Students would work toward a Child Development Associate certificate. We thank you for considering the inclusion of early childhood education if it fits within the parameters of this measure, and/or during implementation if the measure is enacted.

Chairs Johanson and Woodson, Vice Chairs Eli, Hashem and Perruso, and members of the Committee. The Department of Business, Economic Development & Tourism (DBEDT) **supports** SB 373, SD1, which requires the Department of Education, in collaboration with DBEDT, the Department of Labor and Industrial Relations, and the University of Hawaii, to develop and implement a K-12 curriculum-to-career-pipeline initiative to ensure that the State's public school students are adequately trained and prepared to enter the State's workforce upon graduation from high school.

DBEDT supports the bill provided it does not conflict with the priorities identified in the Governor's Biennium Budget request. The percent of Hawaii's labor force with a high school diploma was 28.1% in 2017, higher than the U.S. average at 27.1%. According to a DBEDT study done in September 2018, the top three occupations which added the most jobs to the economy during the 2001-2016 period were Construction Trades Workers, Food and Beverage Serving Workers, and Cooks and Food Preparation Workers. Special training at the high school level would prepare Hawaii's high school graduates to qualify for these jobs upon graduation. DBEDT would be happy to provide the data and analysis for the project.

DBEDT prefers SB 373 over SB365, a bill with similar purpose, but a more complicated implementation process which requires DBEDT to be accountable for bonus incentive payments to DOE schools and public charter schools.

SB 373SD1 proposes to require the Department of Education (DOE) to develop and implement a K-12 curriculum-to-career pipeline initiative to ensure that the State's public-school students are adequately trained and prepared to enter the State's workforce upon graduation from high school and appropriates funds and staffing for the development and implementation of the program. DLIR <u>supports the intent</u> of this measure provided it does not conflict with the priorities identified in the Governor's Biennium Budget request.

As noted in the bill, there are workforce shortages in the technology-based occupations throughout the State. The enactment of this measure would help address the State's immediate workforce needs in the technology industry shortage areas. DLIR, through funding for mini grants provided by the Legislature, has supported technology workforce initiatives statewide.

The Department will continue to work with the DOE, the University of Hawaii and the Department of Business, Economic Development & Tourism (DBEDT) to address technology-based and other workforce shortages in other industries including as agriculture, health and hospitality.

SB 373 SD1 - RELATING TO EDUCATION

Chairs Johanson and Woodson, Vice Chairs Eli, Hashem, and Perruso, and members of the committees:

Thank you for the opportunity to submit testimony on SB 373 SD1. This bill requires the Department of Education to develop and implement a K-12 curriculum-to-career-pipeline initiative to ensure that the State's public school students are adequately trained and prepared to enter the State's workforce upon graduation from high school.

As a result of preparing for a recent DOE grant opportunity around career readiness, there exists a working committee involving the head of the State CTE department, UH and DOE leaders that is still going forward. In addition, the UHCC System Office has developed a sector/labor mapping site that is used as a means to engage the leadership of all major economic sectors in the state of Hawai'i, in a formal, cyclic, and intentional fashion. The University of Hawai'i's new website organizes all the jobs in the state of Hawai'i into sector grouping. Each job in the state has its own landing page and detailed there are the following: current demand, projected demand, salary ranges, degree levels required by industry, skill sets required (soft and hard), and a listing of companies that are hiring. In addition, the web site shows how DOE pathways lead to programs in the University of Hawai'i and then into industry.

The leadership of the banking sector and the chief information officers from all major sectors have already met with UH and the DOE and as a result have established formal relations and specific projects and programs have evolved from this engagement. These sector convenings also include the DOE and as a result there is ongoing work to connect the program pathways in the DOE with UH Associate programs and also direct connection with industry partners. In sum, much of current activity in the DOE and in UHCC system is dedicated to connecting the curriculum directly with workforce opportunities.

The University of Hawai'i Community College supports the intent of SB 373 SD1 and would add that most of what is asked for is already taking place. We defer to the DOE on the legal and technical considerations on this matter.

The Chamber of Commerce Hawaii ("The Chamber") **supports** SB 373 SD1, which requires the Department of Education, in collaboration with DBEDT, DLIR, and the University of Hawaii, to develop and implement a K-12 curriculum-to-career-pipeline initiative to ensure that the State's public school students are adequately trained and prepared to enter the State's workforce upon graduation from high school. This bill would also provide funds for the development and implementation of the program and include funding for a full time Educational Specialist II position.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 2,000+ businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

The Chamber applauds the Legislature's recognition that closing the skills gap is critically important to ensuring our children the opportunities to succeed in the workforce. For the last few years, the Chamber has partnered with the University of Hawaii, the Workforce Development Council, and the Hawaii P-20 Council to help identify high-growth, high-demand occupations to ultimately align curriculum in Hawaii's public schools and post-secondary learning institutions with the specific needs of certain industries. Some of this work has been done through sector partnerships, or industry engagements, to understand skill gaps that may exist and how to prepare the future workforce.

Additionally, the Chamber, with grant support from the Harold K.L. Castle Foundation, has been serving as an intermediary between the business community and Waipahu and Pearl City High Schools to create work-based learning opportunities and sustainable industry partnerships.

Aloha Chairs Johanson and Woodson, Vice Chairs Eli, Hashem, and Perusso, and Members of the Committee,

Founded in 2017, HawaiiKidsCAN is a nonprofit organization committed to ensuring that Hawaii has an excellent and equitable education system that reflects the true voices of our communities and, in turn, has a transformational impact on our children and our state. Last year, our centerpiece campaign sought to increase equity and access for STEM and computer science learning experiences. These opportunities expose students to skills connected with highwage, high-growth industries, giving them more options upon graduation.

Respectfully, HawaiiKidsCAN supports SB 373 SD1 with the following suggested amendments:

- 1. **Amending section 2, subsection (c),** to the following, with new text underlined: "The department shall collaborate and consult with the department of business, economic development, and tourism; the department of labor and industrial relations; and the University of Hawaii to develop and implement the K-12 curriculum-to-career-pipeline initiative, and identify funding incentives and supports to schools for offering internship programs and industry credential opportunities."
- 2. Amending subsection (b) Section 103D-102, Hawaii Revised **Statutes**, to include "internship placements between public high schools and employers" on the list of goods and services exempt from the state procurement process.



SB 373 SD1 represents an important effort to align key partners across the K-12, higher education, and workforce development continuum and better ensure students are graduating from our public schools with a head start on beginning meaningful careers. Today, our students face an uncertain, deeply complex economic future, both globally and locally. The cost of living continues to rise in Hawaii while affordable housing options become more scarce. By forging a strong and thoughtful link between local schools and industry, we can ensure the next generation thrives in that challenging environment; grow our local economy; and address the state's persistent "brain drain" phenomenon, which sees many of our talented students leave for the mainland and stay there due to perceived lack of opportunity.

The suggested amendments add several important elements to SB 373 SD1. Given the many critical and competing needs of our local public schools, our state must ensure that schools have the resources they need to offer and expand innovative educational experiences that prepare students for the jobs of today and tomorrow. This may include costs related to equipment, facilities, credential testing fees, and transportation to off-campus work sites. Similarly, schools rarely respond well to top-down mandates when it comes to rolling out new reforms, so our state should consider developing a strategic approach to funding that incentivizes schools to build out their own internship and industry credential programs related to the K-12 curriculum-to-career-pipeline initiative.

The second suggested amendment seeks to streamline the process of companies offering internships to students, which could boost the aims of the K-12 curriculum-to-career-pipeline initiative. By exempting schools from having to go through the complicated state procurement process, the state would make it less daunting for well-meaning industry partners to support their local public schools.

We believe these amendments will help to make an important and necessary initiative even stronger.
