TESTIMONY OF COUNCIL CHAIR EMERITUS & VICE CHAIR RON MENOR **COUNCIL DISTRICT 9** CITY AND COUNTY OF HONOLULU

Senate Bill 410 RELATING TO THE TRAFFIC CODE



Chair Inouye, Vice Chair Harimoto and Members of the Senate Committee on Transportation:

I am testifying in support of Senate Bill 410.

On January 30th, the Honolulu City Council unanimously approved Council Resolution 18-287 CD1 (see attached):

Urging the Hawaii State Legislature to strengthen the existing governing pedestrian safety at crosswalks by increasing the penalties for violations.

State and City government need to be proactive in addressing the alarming increase in pedestrian accidents and fatalities. For example, the number of pedestrian fatalities increased 180 percent statewide from 2017 to 2018.

It's a growing problem and there is no panacea. Government needs to implement a multifaceted approach that involves a range of solutions including increased penalties for those who violate pedestrian safety laws and installation by the City of more safety improvements at crosswalks and intersections.

I also hope this measure will stimulate further public discussion about ways the State and City can enhance pedestrian safety.

RESOLUTION

URGING THE HAWAII STATE LEGISLATURE TO STRENGTHEN THE EXISTING STATUTE GOVERNING PEDESTRIAN SAFETY AT CROSSWALKS BY INCREASING THE PENALTIES FOR VIOLATIONS.

WHEREAS, pedestrian safety and walkable neighborhoods are priorities for the City and County of Honolulu; and

WHEREAS, each year the State of Hawaii averages 24 pedestrian fatalities and 560 pedestrian injuries from being struck by motorists; and

WHEREAS, according to the Hawaii State Department of Health, Hawaii has the highest pedestrian fatality rate in the nation for older adults; and

WHEREAS, according to the Hawaii State Department of Transportation, 43 pedestrians died in traffic accidents statewide in 2018, with 27 of those deaths occurring in the City and County of Honolulu; and

WHEREAS, in 2017, 15 pedestrians died in traffic accidents statewide, with 12 of those deaths occurring in the City and County of Honolulu; and

WHEREAS, these figures reflect an approximately 180 percent increase in pedestrian traffic deaths from 2017 to 2018 statewide, and 125 percent increase in pedestrian traffic deaths in the City and County of Honolulu; and

WHEREAS, according to the Hawaii State Department of Transportation, one pedestrian has died in a traffic accident in the City and County of Honolulu during the period of January 1, 2019 through January 16, 2019; and

WHEREAS, Hawaii Revised Statutes ("HRS") Section 291C-72(a) requires all vehicles to stop and allow a pedestrian to cross the roadway within a crosswalk when the pedestrian is upon the half of the roadway on which the vehicle is traveling, or when the pedestrian is approaching closely enough from the opposite side of the roadway to be in danger; and

WHEREAS, current monetary penalties for violation of HRS Section 291C-72(a) are a \$150 fine for a first time offense, a \$300 fine for a second offense, and a \$1,000 fine for third and subsequent offenses; and

WHEREAS, the Council of the City and County of Honolulu considers these penalties to be insufficient in deterring risky or dangerous behavior by drivers on our roadways and protecting our pedestrians; now, therefore,

RESOLUTION

BE IT RESOLVED by the Council of the City and County of Honolulu that the State Legislature is strongly urged to strengthen the existing statute governing pedestrian safety at crosswalks by increasing the penalties for violation of this statute; and

BE IT FURTHER RESOLVED by the Council that it suggests increasing the monetary penalties for a first offense from \$150 to \$300, for a second offense from \$300 to \$750, and for third or subsequent offenses from \$1,000 to \$1,500; and

BE IT FINALLY RESOLVED that a copy of this resolution be transmitted to the President of the Hawaii State Senate, the Speaker of the Hawaii State House of Representatives, and the Governor.
