SENATE BILL NO. 519 RELATING TO FOOD SAFETY

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 519 which proposes to require the department to partner with the agricultural community to establish a food safety certification training program to assist small and medium sized farms to be certified by the USDA Good Agricultural Practices certification program. The Department supports the intent of this measure.

The Department currently works in partnership with the University of Hawaii College of Tropical Agriculture and Human Resources (UH-CTAHR), who performs coaching and training with farmers to comply with the U.S. Food and Drug Administration's Produce Safety Rule and the USDA Good Agricultural Practices requirements. Under a cooperative agreement with the United States Department of Agriculture, the Department conducts U.S. Department of Agriculture's Good Agricultural Practices audits at the request of farm businesses and restricts auditors from performing outreach and coaching activity.

The Department requests that the funding in this bill be directed to UH-CTAHR for implementation.

#### SB519-Relating to Food Safety

Chair Gabbard, Vice-chair Rudermen, and members of the committee:

My name is Kevin Kelly and I am the President of North Shore EVP, a regional economic development organization located on the North Shore of Oahu. Our organization strongly supports the establishment a food safety certification training program that will provide direct assistance to small and medium sized farms in obtaining their USDA GAP certification.

In response to our community's desire to build a food hub to assist small farms on the North Shore of Oahu, we initiated a USDA GroupGAP program that allows farmers to work together and share the expense of obtaining good agricultural practices training and subsequent certification. In 2018 we became the 15<sup>th</sup> GroupGAP group in the United States and the only such program in Hawaii.

GAP certification is, in practice, a requirement for small farms that want to comply with the Food Safety & Modernization Act (FSMA) and scale their operations to meet the increasing demand for locally grown fresh produce. When FSMA comes into effect for all farms in January 2020, GAP certification will serve as tangible evidence to produce buyers that a producer is in compliance (or very close to being in compliance) with federal law.

Our work is paying off. It is estimated that there are approximately 50 certified farms in Hawaii. Of the ten farms in our first cohort, 2 have received their certification, one is responding to minor auditor findings and will be re-audited, and one other farm will be audited next month. If these four farms are successful we will have increased the number of certified farms by almost 10%! A second cohort of 9 farms is currently in training.

With your support of this measure, North Shore EVP would look forward to working with the Department of Agriculture to apply what we have learned training farmers on Oahu to help farms statewide with the challenges of compliance with FSMA.

Aloha mai kakou Chair, Vice Chair and Members of the Senate Committee on Agriculture and Environment:

The O`ahu County Committee on Legislative Priorities (OCCLP) of the Democratic Party of Hawai`i (DPH) hereby submits its testimony in **SUPPORT of SB 519 relating to Food Safety.** 

SB 519 requires the department of agriculture to partner with the agriculture community to establish a food safety certification training program to provide assistance to small and medium sized farms to get certified by the United States Department of Agriculture's Good Agricultural Practices certification program. Further, SB 519 appropriates funds for this project.

Agriculture in our state must be preserved and its future strengthened. Sufficient prime agricultural lands must be maintained for the health, economic well-being and sustenance of the people. We believe in an integrated approach to agricultural innovation and sustainability. We encourage the responsible development of ocean resources and aquaculture to achieve sustainability in our State of our marine resources an ensure and improve the health of our reef and marine life.

This approach includes, but is not limited to, the adoption of the Native Hawaiian concept of ahupua'a, an integrated approach to land management. This could also include development of economic, land and ocean use policies that foster sustainable crops both for local consumption and for export, polices to foster agriculture-related infrastructure at shipping points, and increased inspection to protect against invasive species and to encourage reduced holding times. We need to ensure food safety, strive towards food security an strive to set the highest standards for food quality and nutrition. *Democratic Party of Hawai`i Platform (2018), p. 9, In. 5-16.* 

As an island state, securing affordable food for all is a priority. DPH supports healthy, sustainable, and diversified local food production, and "Buy Local" strategies to assure greater food security and <u>food safety</u>. *Democratic Party of Hawai`i Platform (2018), p. 9, In. 26-29*. The establishment of a food safety certification training program would assist in establishing this goal.

For the foregoing reasons, OCCLP supports SB 519 and urges its passage out of the Committee on Agriculture and Environment.

SB 519 - RELATING TO FOOD SAFETY

Chair Gabbard, Vice Chair Ruderman and members of the Senate Committee on Agriculture and Environment:

Thank you for this opportunity to testify in <u>strong support</u> of SB 519. Good Agricultural Practices (GAP) Certification is important, in fact crucial, for assuring both food safety and farm success. The University of Hawai'i at Mānoa (UHM), College of Tropical Agriculture and Human Resources (CTAHR) strongly supports increasing the GAP training that is already offered by Cooperative Extension. By providing safe and high-quality food to the public, Hawai'i agriculture will increase public confidence in Hawai'i products and serve as a model to other associated and supporting businesses resulting in a consistent contribution to the economy in Hawai'i.

The current activities by CTAHR in this area for GAP training and support, in preparation for certification and that apply to this bill include:

- The Website: CTAHR Farm Food Safety: Good Agricultural Practices (Science-based education for Hawai'i growers & handlers (http://manoa.hawaii.edu/ctahr/farmfoodsafety/) This website is a resource of training and includes: Tools and Resources

- 10 extension agents involved in food safety education.
- A Produce Safety Rule Train-the-Trainer held on O'ahu, expanded the training capacity to 38 people.
- 125 consultations and trainings by extension agents that were provided to the Hawai'i Department of Education teachers, faculty, growers, health educators, event coordinators, and Master Gardeners working with farms, school and community gardens, and animal exhibits.
- The CTAHR Farm Food Safety Facebook page and Instagram social media presence that was launched in August 2016.

Even with this level of activity CTAHR has not been able to keep up with the demand, and CTAHR is involved only in education and technical support, which is only part of the certification process. Being able to offer more education leading toward certification is dependent on funding to support the training. This bill addresses that need and additional needs that move the farmer toward certification. UHM/CTAHR is ready to collaborate with the Hawai'i Department of Agriculture and other agencies to support the education process related to GAP certification.

One recommendation is that the goal of this bill should include the development of a one-stop website for all users related to food safety issues, making the information easily accessible to all users.

Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

**HFB supports SB 519,** which requires and appropriates funds to the Department of Agriculture to partner with the Hawaii agriculture community to establish a food safety certification training program to assist small to medium-sized farms to comply with the United States Department of Agriculture Good Agricultural Practices Certification Program.

HFB appreciates the support by the legislature in our past efforts to help Hawaii's farmers achieve compliance with the FDA Food Safety and Modernization Act. As the actual rule has been rolled out by FDA the immensity of the task is becoming evident.
