1 Fiscal Implications: None.

2	<b>Department Testimony:</b> The Department of Health supports this bill because it can increase the
3	capacity to provide mental health services for adolescents who may want to receive counseling
4	without having to have permission from a parent or without disclosing their reason for seeking
5	help to a parent. When the original bill changing the age of consent for mental health services to
6	14 was passed by the legislature in the 2016 session, it was a helpful step forward in ensuring
7	that youth who are suffering emotionally can get help. However, it applied only to services
8	provided by licensed mental health professionals. As you may be aware, most of the readily
9	available and low- or no-cost services in Hawaii are provided – not by licensed professionals –
10	but by unlicensed professionals who are in the process of meeting all the requirements for full
11	licensure under the supervision of a licensed professional. This includes interns, practicum
12	students and newer graduates who have not completed all the requisite hours of experience or
13	passed the examination necessary for licensure. In general licensure as a mental health
14	professional of any kind in Hawaii requires at least a year of full-time supervised practice after
15	graduating with the relevant degree. The purpose of this bill is to authorize these mental health
16	professionals working under the supervision of a licensed mental health professional to provide
17	mental health treatment or counseling services to minors without parental consent when this is
18	clinically indicated.

- 19 This bill is a product of a task force led by the Department of Health (DOH), Child and
- 20 Adolescent Mental Health Division (CAMHD) as mandated by Act 13, SLH 2018. The task

- 1 force was comprised of legislators, representatives of health insurers, state agencies, advocates,
- 2 and community members. A list of task force attendees and a summary of task force findings

- 5 The task force focused primarily on questions regarding counseling practices with lesbian, gay,
- 6 bisexual, transgender, questioning (LGBTQ) youth. As detailed in the report, local Hawaii data
- 7 reveal that homosexual and transgender youth are at significantly heightened risk of substance
- 8 abuse, mental health difficulties and suicide. These youth often feel alienated from their parents
- 9 and other family members or fear revealing their struggles around their sexual orientation and/or
- 10 gender identity to their parents. The ability to find a counselor without having to involve a parent
- can be especially crucial for these youth.
- 12 **Offered Amendment:** We would like to offer a friendly amendment to the wording of the bill
- where it defines "mental health professional," to clarify and ensure all relevant professions are
- included. An edited version of that definition is offered below.
- "Mental health professional" means a person who is working under the supervision of a licensed mental health professional and either: 1) is enrolled in an accredited training program or 2) has completed all licensing requirements except the hours of supervised post-degree experience and/or the examination required for state licensure, for licensed mental health counselors pursuant to chapter 453D, for licensed marriage and family therapists pursuant to chapter 451J, for clinical social workers pursuant to chapter 467E, for psychologists pursuant to chapter 465 or for advanced practice registered nurses

Thank you for hearing **Senate Bill 538**, which amends Section 577-29 of the Hawaii Revised Statutes to allow mental health professionals meeting specified qualifications working under the supervision of a licensed mental health professional to provide mental health treatment or counseling services to minors age fourteen years or older that the minor provides consent to.

Mental Health America of Hawaii (MHAH) is a 501(c)3 organization founded in Hawaii 76 years ago, that serves the community by promoting mental health through advocacy, education and service. We support youth mental health in Hawaii through our Youth Suicide and Bullying Prevention Program and through our advocacy work. In 2016 we provided testimony in support of SB 2886 SD2 HD2 CD1 which became Act 181, allowing minors fourteen years or older to consent to their own mental health treatment. Sometimes youth need to talk to a mental health professional but may not feel safe or comfortable asking their parent for consent for a variety of reasons, which may include family violence, sexual abuse, or substance abuse.

Implementation of Act 181 demonstrated the need for this bill so that the range of professionals able to provide this service is broadened to include mental health professionals that are still in the process of licensure and are supervised by a licensed mental health professional. This will allow more staff of community-based organizations and public and private clinics to serve these youth.

In mental health, access to care is everything and we humbly as you to authorize this change to increase access for youth in these circumstances. The Hawai'i Psychological Association (HPA) supports SB538 with an important recommended amendment. HPA supports this bill because it is consistent with our interest in ensuring access to quality mental health services to the diverse people of Hawai'i. If passed this bill would help increase the capacity of our public and private mental health systems to provide mental health services for adolescents who are seeking counseling, but who do not want to obtain permission from a parent or do not want to disclose their reasons for seeking help to a parent.

When the original bill changing the age of consent for mental health services to 14 was passed by the legislature in the 2016 session, it was a helpful step forward in ensuring that youth who are suffering emotionally can get help. However, the current statute applies only to services provided by licensed mental health professionals. As you may be aware, most of the readily available and low- or no-cost services in Hawai'i are provided – not by licensed professionals – but by unlicensed professionals who are in the process of meeting all the requirements for full licensure under the supervision of a licensed professional. This includes interns, practicum students, and newer graduates who have not completed all the requisite hours of experience or passed the examination necessary for licensure. In general, licensure as a mental health professional of any kind in Hawai'i requires at least a year of full-time supervised practice after graduating with the relevant degree. The purpose of this bill is to authorize these mental health professionals working under the supervision of a fully licensed mental health professional to provide mental health treatment or counseling services to minors without parental consent when this is clinically indicated.

This bill is a product of a task force led by the Department of Health (DOH), Child and Adolescent Mental Health Division (CAMHD) as mandated by Act 13, SLH 2018. The task force focused primarily on questions regarding counseling practices with LGBTQ youth. These youth often feel alienated from their parents and other family members or fear revealing their struggles around their sexual orientation and/or gender identity to their parents. The ability to find a counselor without having to involve a parent can be especially crucial for these youth. In addition, some youth are reluctant to disclose their concerns to their parents for a wide variety of other reasons, such as undisclosed sexual abuse, substance abuse problems, and situations of high family conflict.

HPA would like to support the amendment to the wording of the bill being recommended by the Department of Health to clarify the definition of a "Mental Health Professional" and ensure all relevant professions are included. We are particularly dismayed that Psychologists as a group were omitted from the text of the bill, apparently by an oversight. We request the following amendment to Section 1 on page 4, lines 1 through 9:

"Mental health professional" means a person who is working under the supervision of a licensed mental health professional and either: 1) is enrolled in an accredited training program or 2) has completed all licensing requirements except the hours of supervised post-degree experience and/or the examination required for state licensure, for licensed mental health counselors pursuant to chapter 453D, for licensed marriage and family therapists pursuant to chapter 451J, for clinical social workers pursuant to chapter 467E, for psychologists pursuant to chapter 465, or for advanced practice registered nurses pursuant to chapter 457."

Thank you for the opportunity to provide input into this important bill.
