Chairperson Nishihara, Vice Chair Wakai, and members of the Committee on Public Safety, Intergovernmental, and Military Affairs.

I am Major General Arthur Logan, Adjutant General, Director of the State Emergency Management Agency and Director of Homeland Security. I am providing written testimony for SB 577. The Department of Defense (DOD) **SUPPORTS THE INTENT** of HB 577 and would like to provide comments.

The proposal of SB 577 adds a section to HRS Chapter 88 to provide credit for military service while on State Active Duty (SAD). We defer to the Department of Accounting and General Services for their input on the administrative and financial impacts to the current employee payroll and the current state retirement system.

SB 577 also changes section 121-40: "Pay of enlisted personnel while on Active Duty"; to allow basic allowance of housing to Hawaii National Guard enlisted personnel while on Active Duty. We believe the proposal to change section 121-40 should also apply to section 121-39 "Pay of officers and warrant officers while on active duty." If it is the intent of the bill to extend this benefit to all Hawaii National Guard personnel, the bill should extend this benefit to officers and warrant officers, specifically since SB 577 does propose a change to section 121-42: "No pay without orders" that includes a statement that allows basic allowance for housing to officers and enlisted of the army or air national guard when called to active duty.

RELATING TO ACTIVE DUTY MILITARY ENTITLEMENTS

Senate Bill No. 577 requires the State to pay, without delay, military personnel called to active duty at the same rate as their active duty counterparts; to provide basic housing allowance; and to provide service credit for time on active duty, with service credit counting towards retirement.

The Department of Budget and Finance is concerned about the vagueness of Section 2 of the bill, which provides a service credit for military personnel when called up for State active duty. It is not clear what the intent of the bill is. It is noted that current State and county workers, who are in the National Guard, are members of the retirement system and may benefit from the proposed service credit for State active duty. However, private-sector workers, who are in the National Guard, are not members of the retirement system and would not benefit from a service credit for State active duty.

RELATING TO ACTIVE DUTY MILITARY ENTITLEMENTS

Chair Nishihara, Vice Chair Wakai and Members of the Committee,

The primary purpose of S.B. 577 is to ensure that active employees of the State called to active duty military service will receive the pay and allowances that they are due on a full and timely basis. In addition, S.B. 577 includes a new section to be added to Chapter 88, HRS, for active duty military personnel to receive retirement service credit under the Employees' Retirement System (ERS). As Chapter 88, HRS, already includes provisions for the certification and acquisition of active military service, the ERS has serious concerns about the proposed new section regarding credit for military service under Section 2 of S.B. 577.

Sections 88-132 and 88-132.5 address retirement service credit for eligible periods of membership and pre-membership active military service. Eligibility criteria, verification requirements, limitation periods, member contributions and/or employer contributions and required documentation are clearly specified within these statutes in order that the ERS may certify that these periods are creditable for retirement service. Section 88-132 in particular,



which addresses military leaves without pay during an employee's membership service, has specific guidelines as to when this leave may be allowed service credit and provides limitations on the extent of these leaves. As proposed, Section 2 of S.B. 577 is too vague and ambiguous to be implemented by the ERS.

We respectfully suggest that the existing statutes remain as the basis for ERS service credit for military service under Chapter 88 and request that the periods of active military service addressed by S.B. 577, be evaluated by the same statutory authority.
