Dear Chairs Baker and Dela Cruz, Vice Chairs Chang and Keith-Agaran, and Honorable Members.

The Hawai'i State Commission on the Status of Women supports SB821 SD1, which would require any new or substantially modified establishment to provide equal access to diaper changing stations for all parents. The amended proposal also requires existing establishments for public use that have not been substantially modified to provide baby diaper-changing accommodations by July 1, 2022. This measure is important to ensure that parents have access to public accommodations. It also addresses women's disproportionate responsibility for children's safety and well-being is no longer nourished by law.

American fathers are much more involved in child care than they were fifty years ago and attitudes among men towards gender and family norms are increasingly egalitarian. Public accommodations should reflect the reality of changing gender roles, and enable men to embrace caregiving.

Further, the Commission is troubled by the total absence of diaper changing stations available in state facilities such as at the Hawai'i State Capitol. This discourages parents from engaging the Legislative process and endangers the safety of infants who are made to lie on the public bathroom floor for changing.

To increase equal parenting and public health and safety, the Commission respectfully requests that the Committee pass SB821 SD1.

The Capitol Building is supposed to be a welcoming place that encourages citizen involvement and participation. This includes families with children.

There are many other places of public accommodation where parents and caregivers need facilities to care for their babies' needs. As the bill states, caregivers of both genders need adequate, safe, and sanitary facilities to change diapers.

Some parents have disabilities that make it impossible to kneel on the bathroom floor, so failure to provide a changing station could potentially be a violation of the Americans with Disabilities Act . The floor of the bathroom is not a sanitary or appropriate place to change a baby's diaper but sometimes parents have no other choice.

# TESTIMONY OF TINA YAMAKI PRESIDENT RETAIL MERCHANTS OF HAWAII February 25, 2019

Re: SB 821 SD1 Relating to Gender Equality

Good morning Chairperson Baker and Chairperson Dela Cruz and members of the Senate Committee on Commerce Consumer Protection & Health, and Committee on Ways & Means. I am Tina Yamaki, President of the Retail Merchants of Hawaii and I appreciate this opportunity to testify.

The Retail Merchants of Hawaii (RMH) as founded in 1901 and is a statewide, not for profit trade organization committed to the growth and development of the retail industry in Hawaii. The retail industry is one of the largest employers in the state, employing 25% of the labor force.

While we understand the intent of this measure, we must respectfully oppose SB 821 SD1 Relating to Gender Equality. This measure would require all places of public accommodation constructed or substantially modified after June 30, 2019, to provide baby diaper-changing accommodations that are equally accessible to men and women; and require all existing places of public accommodation that have not been substantially modified to provide baby diaper-changing accommodations that are equally accessible to men and women by July 1, 2022.

Businesses are responding to the wants of the customers that patronize their establishments all the while operating on a very thin profit margin. Some retailers have already installed changing stations or have family changing rooms. Mandating changing tables in all men's or creating family rooms would put a hardship on many retailers, especially small businesses. Older properties restrooms are often limited in space and may have to be reconfigured to accommodate a changing table. Some are already contending with meeting the Americans with Disabilities Act regulations for handicapped stalls.

Many new construction are already including family changing rooms and changing tables in both the men's and women's restrooms, and/or a separate family room. The close proximity of the effective date would be a burden on those businesses who are already in the permitting process, but whose plans have not yet been approved. Adding in changes once a project has been set would add substantial cost to the project if a bathroom needs to be reconfigured and modified to not only accommodate ADA mandates, but also now for the changing tables or to include an entire separate family room.

This measure may encourage retailers to cancel their renovation plans or no longer allow the public access to the restrooms. As a result we may see far fewer public accessible bathrooms.

We also wonder if the government buildings that are accessed by the public are also going to be included in this measure as government should lead by example.

Government mandates like this does drive up the cost of doing business that in turn drives up the cost of living in Hawaii. Policy makers should be focusing on eliminating obstacles to business growth, job creation and economic stability and not adding additional costs that many employers cannot afford. We urge you NOT to impose another government mandate on business and ask that you **DEFER** this measure.

As the father of two daughters, currently aged 2 and 5, I cannot count the number of times around the state that I have been unable to find a suitable place to change their diapers. Sometimes, my partner, who happens to be a woman, was with me and we could then find a place wher she could change the diaper. Sometimes, if I am alone with the children, a park bench or the restroom floor will have to do.

Neither of those options can begin to make up for the lack of options available to men. The first furthers the excessive pressure that women face in society to do all things related to children. The second is demeaning and possibly dangerous.

I was back in my native Sweden this past summer and even I was struck by the difference. Hawai'i can emulate Sweden and in so doing, we can send a signal to our keiki and society at large that we believe in gender equity. This is a small policy change, but its symbolism cannot be overestimated. Mahalo.
