Chairs Gabbard and Kahele, Vice Chairs Ruderman and Keith-Agaran and Members of the Senate Committees on Agriculture and Environment &Water and Land.

The Office of Planning (OP) offers the following comments on SB 828.

- The OP appreciates the over-all concept of this bill as it includes steps to address current and relevant issues threatening coastal areas.
- The development of a framework for a shoreline adaptation e-Permit system would involve the integration of federal, state, and county permitting processes and their respective data systems, commitment amongst all entities for the creation of a successful program. It is unclear what level of commitment, if any, each of these jurisdictions has to such a system.
- It is unclear how the appropriation of \$750,000 should be distributed among the tasks in the proposed measure. Should the Committees advance this measure, the OP seeks further clarification in this regard and requests that a portion of the appropriation be allocated to a position (1.0 FTE), exempt from Hawaii Revised Statutes, Chapter 76, to support this initiative.

OP appreciates the intent of this bill provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget.

Senate Bill No. 828

Relating to Coastal Erosion Proactive Adaptation Plan

The Department of Design and Construction (DDC) respectfully **supports** Senate Bill No. 828, the purpose of which is "...to establish a coastal erosion proactive adaptation plan task force, with the assistance of an advisory group and a consultation team, to develop a coastal erosion proactive adaptation plan to better mitigate impacts to the State's coastal zone caused by sea level rise and erosion." City beach parks comprise a significant portion of the total land area along Oahu's coastline.

The Department of Parks and Recreation (DPR) is responsible for operation and maintenance of the City's parks. DDC works with DPR on matters concerning park facilities and infrastructure, including threats to park land and facilities by shoreline erosion. The proposed legislation would provide a proactive and comprehensive approach to addressing an ongoing problem that is expected to increase due to climate change and the associated sea level rise projected to occur over the coming decades.

The City has begun to address the problem at our shoreline parks, but has not yet formulated plans for all of Oahu's coastal parks. The City contracted with Sea Engineering, Incorporated, to prepare an April 2010 report entitled, *City Beach Parks Erosion Study, Island Of O'ahu, Hawai'i*. This report surveyed the entire island's shoreline with the exception of the Leeward Coast. A Leeward shoreline study by the same firm has been recently completed. The City also has plans to address the protection of City infrastructure and beach resources at Hale'iwa, Punalu'u and Hau'ula Beach Parks. The proposed coastal erosion proactive adaptation plan would complement, but would not duplicate, the City's ongoing efforts in this regard.

The City would welcome the opportunity to participate in the coastal erosion proactive adaptation planning process and would have an implementation role for shoreline areas where the City owns and/or controls public park lands.

Based on the above considerations, DDC respectfully **supports** Senate Bill No. 828.

Chairs Kahele and Gabbard, Vice-Chairs Keith-Agaran and Ruderman, committee members:

The League of Women Voters of Hawaii echoes its testimony previously submitted to various House bills addressing the challenges taken up by the Senate in this hearing.

Hawaii's Climate Change Mitigation and Adaptation Commission, created by Act 32 in 2017, certainly has a lot on its plate, tasked in three of these bills to assist the state and counties with developing and implementing various sea level rise adaptation plans and climate change mitigation efforts; to prioritize nature-based solutions in its climate change mitigation and adaptation efforts and assess risk transfer market mechanisms that promote investments in nature to reduce the risks of climate change; and to determine areas in each county to designate for either armoring or managed retreat. Fortunately, these bills appropriate money, and it's going to take a lot of it.

If there's anything that stands out from a review of the objectives of each of these bills is that everything is inter-related. Climate change is all-encompassing: sea-level rise, coastal erosion, what to do about moving roads and property mauka of the ocean, preserving beach and access – these problems can't be confronted in isolation.

What is needed is an integrated approach to the significant challenges confronting our island state. The League is both gratified and impressed by the number of bills introduced this session by both the Senate and House, recognizing that delay in addressing these challenges is not an option.
