**Purpose of Bill:** 

Requires all public schools in the county of Hawai'i to participate in the safe routes to school program. Appropriates funds to support the safe

routes to school program for schools in the county of Hawai'i.

#### Department's Position:

The Department of Education supports the intent of SB 876 requiring all Hawaii county public schools to participate in the safe routes to school program because the county-based safe routes to school program provides for community infrastructure improvements strategically designed to reduce vehicular traffic and congestion around schools, enhance student pedestrian and cycling safety to and from schools, and promote the physical well-being of school children.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. ## S.B. 876 RELATING TO THE SAFE ROUTES TO SCHOOL PROGRAM.

Senate Committee(s) on Education and Transportation

The Department of Transportation (DOT) **supports with amendments** S.B. 876 to require all public schools in the County of Hawaii to participate in the Safe Routes to School (SRTS) program and appropriates general revenue funds to support the SRTS program in the County of Hawaii.

1. We request SECTION 1. to read as follows:

All public elementary, intermediate, and middle schools in the County of Hawaii shall participate in the safe routes to school program established pursuant to 291C-3, Hawaii Revised Statutes.

Both Chapter 19-109, Hawaii Administrative Rules (HAR) and Section 1404 of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users, which created the federal SRTS program, specify that SRTS funds shall primarily benefit students in grades K-8.

2. We request the second paragraph in SECTION 2. to read as follows:

The sums appropriated shall be expended by the County of Hawaii for the purposes of this act.

The County of Hawaii has established a county-level SRTS program as required by Section 291C-3, Hawaii Revised Statutes and Chapter 19-109, HAR. The DOT distributes funds from the SRTS Program Special Fund to counties annually to support county-level SRTS programs in accordance with Chapter 19-109, HAR. The County of Hawaii has received a total of approximately \$487,000 from the SRTS Program Special fund since 2014, and the County of Hawaii SRTS Coordinator is already working collaboratively with schools to identify and implement SRTS strategies.

Additionally, in most cases, elementary and middle school students walk and bike along county routes to get to and from school. If SRTS improvements along state routes are identified, counties could work with DOT to implement these improvements.

#### Comments:

My name is Tina Clothier and I am the Executive Director of PATH~Peoples Advocacy for Trails Hawaii. Since 2009, PATH has been involved in Safe Routes to School programs and advocacy. In 2014, the County of Hawaii Department of Public Works contracted with PATH to be their Safe Routes to School Coordinator. Hawaii County receives yearly funding from the DOT SRTS Special Fund and we spend the funds in their entirety on SRTS infrastructure improvements. However, there are millions of dollars of potential SRTS infrastructure improvements that we are not able to fund at this time.

Infrastruture improvements (Engineering) are just one of the 6 Es that make a SRTS program at a school. The others are Education, Encouragement, Enforcement and Evaluation. On the Education and Encouragement front, PATH has been offering Hawaii Island schools Bike Ed for 4th graders and Ped Ed for 1st, 2nd and 3rd graders every school year since 2009. Last year we taught over 1,400 students in 22 schools these important safety skills. That said, we are earger to expand these programs to more schools each year. Additional funding and more instructors would make that possible.

In Hawaii County, we also partner with the Blue Zones project. Blue Zones has been very effective in expanding awareness of SRTS through their program.

While there is a conserted effort by PATH, the County of Hawaii and Blue Zones to make sure that every school has the opportunity to engage in SRTS through the 6 E's, there is so much more work to be done to firmly establish SRTS in all K-8 schools around the island.

Mahalo for your consideration of this important program to keep our keiki healthy and safe.
