In consideration of SENATE BILL 934 RELATING TO CONSERVATION DISTRICTS

Senate Bill 934 proposes to amend Section 183C-4, Hawaii Revised Statutes, regarding the rules governing land uses within the Conservation District by inserting language stipulating that no waste or disposal facility shall be located in the Conservation District and define waste or disposal facility. **The Department of Land and Natural Resources (Department) supports this measure.**

Senate Bill 934 would prohibit future waste or disposal facilities from being developed within the State Land Use Conservation District and would render all existing facilities nonconforming uses. The Department notes that this measure refers to "any other facility for the disposal of solid waste that is required by law to obtain a permit from the department of health." This language should not inadvertently apply to facilities or residences that are required to obtain a permit from the Department of Health for sewage/waste disposal.

SUBJECT: SB 934

Relating to Conservation Districts

The Department of Environmental Services (ENV) of the City and County of Honolulu has concerns regarding the implications of S.B. No. 934 which proposes to prohibit any waste or disposal facility from being located in a conservation district and submits the following comments.

ENV is responsible for managing the removal and processing of a significant portion of any waste that would be generated from an environmental hazard or natural disaster such as a hurricane, tornado, tsunami, earthquake, or flood. Managing this waste in a safe and efficient manner that minimizes or eliminates impacts to public safety and health may require the temporary use of strategically located land within a conservation district. While ENV will strive to minimize the use of conservation district land in such an event, we recommend this bill be modified to allow for the use of conservation district land should it become necessary to mitigate risks to public safety and health.

To the Honorable Donovan M. Dela Cruz, Chair; the Honorable Gilbert S.C. Keith-Agaran, Vice Chair; and Members of the Committee on Ways and Means:

My name is Melodie Aduja and I serve as Chair of the O`ahu County Committee on Legislative Priorities of the Democratic Party of Hawai`i ("DPH"). Mahalo for this opportunity to submit testimony on SB 934. The O`ahu County Committee on Legislative Priorities ("OCCLP") hereby submits its testimony in **SUPPORT of SB 934**, **Relating to Conservation Districts**.

SB 934 provides that the department shall adopt rules governing the use of land within the boundaries of the conservation district that are consistent with the conservation of necessary forest growth, the conservation and development of land and natural resources adequate for present and future needs, and the conservation and preservation of open space areas for public use and enjoyment, provided that no waste or disposal facility shall be located in a conservation district. For purposes of this section, "waste or disposal facility" means any transfer station or landfill as defined in section 340A-1, open dump as defined in section 342H-1, solid waste reduction facility or waste reduction facility as defined in section 342G-1, disposal facility, or any other facility for the disposal of solid waste that is required by law to obtain a permit from the department of health.

PROTECTING OUR PUBLIC LANDS AND WATERS

DPH believes in the conservation and collaborative stewardship of our shared natural heritage: the public lands and waterways, the oceans, mountains and all that makes Hawai'i's great outdoors priceless. We need policies and investments that will keep Hawai'i's public lands public, strengthen protections for our natural and cultural resources, increase access to parks

and public lands for all people, protect native species and wildlife, and harness the immense economic and social potential of our public lands and waters.

DPH will approach conservation of our public lands and waters in a way that reflects the diversity of our State, by actively engaging all people in the great outdoors and protecting natural landscapes and cultural sites that tell the story of Hawai'i's complex history. To help meet these goals, we will work to build a diverse workforce in the Department of Land and Natural Resources (DLNR) that manage Hawai'i's public lands, waters, and cultural sites.

Agricultural practices have a significant impact on our water, land, oceans, and climate. Therefore, we believe that in order to be effective in keeping our air and water clean and combating climate change, we must enlist farmers as partners in promoting conservation and stewardship. *Democratic Party of Hawai'i Platform (2018)*, p. 18, In. 36-55.

For the foregoing reasons, to wit, prohibiting waste or disposal facilities from being located in a conservation district is consistent with providing policies and investments that will keep Hawai'i's public lands public, strengthen protections for our natural and cultural resources, increase access to parks and public lands for all people, protect native species and wildlife, and harness the immense economic and social potential of our public lands and waters, OCCLP supports SB 934, and urges its passage out of the Committee on Ways and Mean

SB934 RELATING TO CONSERVATION DISTRICTS Senate Committee on Water and Land

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB934, which would expressly affirm that waste and disposal facilities are an inappropriate use for lands in the conservation district.

The state conservation district is intended to conserve, protect, and preserve our most naturally and culturally significant lands and resources, with land uses accordingly subject to high standards of review and regulation. Containing "important natural resources essential to the preservation of the State's fragile natural ecosystems and the sustainability of the State's water supply," the conservation district is also host to cultural sites and resources essential to the perpetuation of constitutionally protected Native Hawaiian traditional and customary practices. Waste and disposal facilities, in which hazardous and toxic materials may accumulate and be stored indefinitely, can significantly compromise the environmental and cultural integrity of conservation district lands and resources; such facilities would appear to be highly inappropriate uses for lands otherwise subject to the highest standards of protection and care. OHA accordingly supports this measure's clarification that waste and disposal facilities should not be an acceptable use of conservation district lands.

OHA notes that, should a parcel of land in the conservation district be the only available and suitable location for a waste or disposal facility, the land use redistricting process can be utilized to amend the conservation district boundary and thereby accommodate such a facility. Notably, the land use redistricting process includes substantive and procedural mechanisms that can identify and mitigate the impacts of redistricting on important and valued natural and cultural resources, as well as associated Native Hawaiian traditional and customary practices.

Accordingly, OHA urges the Committee to **PASS** SB489. Mahalo nui for the opportunity to testify on this measure.
