SCR 197/SR 155 – REQUESTING THE PREVENT SUICIDE HAWAII TASK FORCE TO RECOMMEND A STRATEGIC PLAN TO REDUCE YOUTH SUICIDES IN HAWAII

Chairs Baker and Ruderman, Vice Chairs Chang and Rhoads, and members of the committees:

Thank you for this opportunity to testify in support of SCR 197/SR 155, which request the Prevent Suicide Hawai'i Task Force to recommend a strategic plan to reduce youth suicides in Hawai'i.

A teen in Hawai'i is nearly twice as likely to attempt suicide as compared to a teen elsewhere in the United States. Roughly, 2,280 teens reported having attempted suicide here in 2007, according to the Centers for Disease Control and Prevention survey in Hawai'i's schools. This data has been confirmed by the Department of Health, which found that Hawai'i has the highest attempted suicide rate in the country for youth ages 10 to 24. For every suicide death in the islands, there are 25 attempted suicides. The neighbor islands have a higher suicide attempt rate among the youth than Oahu. While suicide or suicide attempt is troubling at any age, youth suicide has unique challenges.

In 2017, the Prevent Suicide Hawai'i Task Force released the Hawai'i Suicide Prevention Strategy establishing the goal of reducing Hawai'i suicides by 25% by 2025. Collaboration between the Prevent Suicide Hawai'i Task Force and Youth Suicide Prevention Leadership Council would prove beneficial in evaluating and determining methods to improve education, awareness, support services and outreach, along with recommending a strategic plan to reduce youth suicides in Hawai'i.

Hawaii Youth Services Network, a statewide coalition of youth-serving organizations, supports SCR 197/SR 155 Requesting the Prevent Suicide Hawaii Task Force to Recommend a Strategic Plan to Reduce Youth Suicides in Hawaii.

Suicide prevention was one of the top priorities that youth who attended the Children and Youth Summit in 2018 felt the Hawaii Legislature needs to address.

Nearly a quarter of Hawaii's middle school students and sixteen percent (16%) of Hawaii high school students seriously considered suicide in the last 12 months. Twelve percent (12%) of middle school students and ten percent (10%) of high school students have made a suicide attempt according to the 2017 Youth Risk Behavior Survey.

Early intervention, education, and prevention efforts can save lives.
