### SCR 2/SR 2 STRONGLY URGING THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND THE UNITED STATES CONGRESS TO ALLOW HAWAIIAN HOMESTEADS TO BE DIRECT RECIPIENTS OF FEDERAL NATIVE HAWAIIAN HOUSING BLOCK GRANTS UNDER THE NATIVE AMERICAN HOUSING ASSISTANCE AND SELF-DETERMINATION ACT

Aloha Chair Shimabukuro, Chair Chang, and members of the Committees:

The Department of Hawaiian Home lands (DHHL) submits comments on these resolutions strongly urging the United States Department of Housing and Urban Development (HUD) and the United States Congress to allow Hawaiian homesteads to be direct recipients of federal Native Hawaiian Housing Block Grants (NHHBG) under the Native American Housing Assistance and Self-Determination Act (NAHASDA). DHHL appreciates the first be it resolved clause urging HUD and Congress to provide additional federal funds for the NHHBG under NAHASDA. However, the resolutions proposal to allow individual Hawaiian homesteads to be direct recipients of NHHBG wouldn't necessarily result in expediting the utilization of these funds or expand affordable housing opportunities for low-income families and individuals living on, or desiring to live on Hawaiian homesteads.

Utilization of NHHBG under NAHASDA requires strict compliance with many federal regulations and requirements including but not limited to eligible affordable housing activities in accordance with section 810 of NAHASDA and consistent with the Native Hawaiian Housing Plan as required under section 803 of NAHASDA, labor standards per section 805 of NAHASDA, environmental review as provided in section 806 of NAHASDA, annual performance reports as stipulated in sections 819 and 820 of NAHASDA, and quarterly federal financial reports. These requirements are met by a number of DHHL staff with specific expertise in our fiscal, land development division, and planning office beyond the staff specifically assigned to NAHASDA. It is important to note that DHHL has in the past solicited project and program proposals from eligible entities for NAHASDA funding through the community grant program. The expenditure of funds under this program were smaller in amount and at a slower rate.

Thank you for the opportunity to testify in **support** of this important measure. The purpose of this resolution is to strongly urge the United States Department of Housing and Urban Development and the Congress of the United States to designate individual Hawaiian homesteads as direct recipients of Native Hawaiian Housing Block Grants.

This measure is in the Maui County's Legislative Package; therefore, I offer this testimony on behalf of the Council.

The Maui County Council supports this measure for the following reasons:

- 1. Hawai'i is experiencing a critical affordable-housing shortage and more funding is needed to support infrastructure development, home construction and rehabilitation programs, direct loans, and housing subsidies for Native Hawaiian families.
- 2. Designating individual Hawaiian homesteads in Hawaii to be direct recipients of Native Hawaiian Housing Block Grants, in addition to the Department of Hawaiian Home Lands, could expedite the effective use of these funds and expand affordable-housing opportunities for low-income families and individuals living on, or desiring to live on, Hawaiian homesteads.

For the foregoing reasons, the Maui County Council **supports** this measure.

Aloha Chair Shimabukuro, Vice Chair Kahele and Members of the Committee,

I'm Homelani Schaedel, a beneficiary residing at Malu'ōhai, a homestead leader in the Kapolei region, and an advocate for the Hawaiian Home Lands Trust.

I welcome all opportunities to support funding for the Department of Hawaiian Home Lands (DHHL) that will provide funds to place applicants on the Waitlist onto our trust lands in a timely manner; that is the kuleana of DHHL.

I'm not convinced diverting already limited Native American Housing Assistance and Self-Determination Act (NAHASDA) funding to Hawaiian homesteads could "expedite the effective utilization of these funds and expand affordable housing opportunities..." on the contrary, "allowing Hawaiian homesteads to be direct recipients" would dilute resources and diminish the effectiveness of (NAHASDA).

Based on the language in this resolution, the questions I have are:

1. Does this committee know, of the 50 or more Hawaiian homesteads statewide who would qualify under this resolution; have the capacity, resources, funding, or project that could meet NAHASDA's guidelines, its' fund management and reporting requirements?

2. Shouldn't a potential Hawaiian homestead recipient meet the criteria of a "democratically-elected Hawaiian homestead community self-governance organization as defined in Section 201.6 of the Hawaiian Homes Commission Act of 1920, as amended? (HHCA)

3. Or, in the very least be required to provide evidence of a completed housing or community project they developed and are successfully maintaining in their homestead?

The reason I ask these questions is that, as president of Malu'ōhai Residents' Association while we meet the criteria under Section 201.6 of the HHCA; we do not have the capacity to develop housing, nor would we want to, and I dare say many of our homestead associations would agree.

I truly do not wish to offend any of the leaders of our Hawaiian homestead associations or organizations, but I can think of only a handful that could potentially be a NAHASDA recipient.

I urge you to consider amending this resolution to delete all reference to "designating or designate individual Hawaiian homesteads as direct recipients of Native Hawaiian Housing Block Grants".

I believe the sole purpose of this resolution is to urge the United States Department of Housing and Urban Development and the Congress of the United States to provide additional federal funds for Native Housing Block Grants under NAHASDA. If amended, I would strongly support this resolution.
