#### **Department's Position:**

The Department of Education (Department) supports SCR 007. The Department is committed to ensuring that all public school students are educated in learning environments that are safe, caring, and positive. The Department recognizes the importance and value of the social and emotional well-being of our students and its impact on student success.

The Department continuously works to reduce bullying and cyberbullying by emphasizing the importance of a positive school climate and the effective implementation of an evidence-based social and emotional learning (SEL) program. Statewide Positive Behavior Interventions and Supports (PBIS) training and technical assistance are provided to support schools in addressing, improving, and maintaining a positive school climate.

The Department also understands that student-employee harassment can have grave impacts on students' educational learning and achievement. The Department's Civil Rights Compliance Branch (CRCB) Complex Area Equity Specialists have been valuable in decreasing the time frame for completing such investigations.

In January of 2020, the Department implemented a new behavior management system in Infinite Campus (IC) to capture student behavior incidents and disciplinary actions. The Department reports data on subgroups when the subgroup is greater than ten (10) students. Data is not publicly reported for a subgroup with ten (10) or fewer students. This practice ensures that the personally identifiable information of each student is kept private, while also maintaining alignment with Hawaii's approved Hawaii Consolidated State Plan for the Every Student Succeeds Act.

The CRCB utilizes a manual data collection system to keep track of all on-going protected class

investigations. Such data includes investigation type categorized by protected class, time frames of when complaints were received and the CRCB investigation phase was completed, and statistics regarding investigation totals by schools and complex.

The Hawai'i State Department of Education is committed to delivering on our promises to students, providing an equitable, excellent, and innovative learning environment in every school to engage and elevate our communities. Testimony in Support of SCR 7/SR 8 Requesting the Department of Education to Submit a Report to the Legislature on the Implementation of the Amended Chapers 19 and 89 of Title 8, Hawaii Administrative Rules.

Hawaii Youth Services Network (HYSN), a statewide coalition of youth-serving organizations supports Testimony in Support of SCR 7/SR 8 Requesting the Department of Education to Submit a Report to the Legislature on the Implementation of the Amended Chapers 19 and 89 of Title 8, Hawaii Administrative Rules.

For 9 out of the past 13 years, bullying has been one of the top concerns of the youth who participate in the annual Children and Youth Summit at the State Capitol each October. They tell us that teachers and other school staff do not respond effectively when they witness bullying or bullying is reported by students.

As one concerned grandparent told me, "We are teaching our granddaughter about the issue. Last year she reported 3 kids to teacher because they were taunting a home less girl...{My granddaughter said the teacher just told them not to do again...the kids got nothing out of it."

According to the Hawaii Youth Behavioral Risk Survey, Hawaii has a low rate of youth violence in almost every area except bullying. The number of youth who have stated that they were afraid to go to school or have missed school due to bullying is much higher than the national average. 22.6% of middle school students in Hawaii were cyber-bullied, 40% were bullied on school property, 23.1% seriously considered suicide, and 12.4% attempted suicide during past 12 months (Hawaii Youth Risk Behavior Survey 2017)
