SR 129 REQUESTING THE DEPARTMENT OF HAWAIIAN HOME LANDS TO CONDUCT AN ANALYSIS AND PROVIDE DATA ON THE NUMBER OF DEPARTMENT OF HAWAIIAN HOME LANDS BENEFICIARIES WHO HAVE APPLIED FOR AND NEED HOUSING IN EACH COUNTY, BY INCOME CLASSIFICATION AND UNIT TYPE

Aloha Chair Shimabukuro, Vice Chair Kahele, and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) submits comments on this resolution requesting DHHL conduct an analysis and provide data on DHHL beneficiaries. DHHL appreciates the motivation behind this resolution, but believes the resolution is unnecessary because DHHL conducts beneficiary studies of applicants and lessees approximately every five years. DHHL recently finalized a contract for a beneficiary survey with SMS Research & Marketing Services (SMS), who completed the prior beneficiary studies for DHHL as well as the 2019 Hawaii Housing Planning Study. This resolution has already been shared with SMS as work has just begun to prepare the survey with the goal of completing the survey by the end of the year.

DHHL would like to note the following issues for consideration by this Committee. First, the third whereas clause references that "fewer than one hundred thousand homesteads have been resettled." DHHL is unsure if the author intended to note that fewer than ten thousand homesteads have been resettled. In addition, the 2019 Hawaii Housing Planning Study includes a section on Housing and Native Hawaiians and while the definition of a Native Hawaiian household is broader than the definition of native Hawaiian as defined in the Hawaiian Homes Commission Act (HHCA), there is some information specific to native Hawaiians as defined in the HHCA in the study. The study provides the following information: "Of the Native Hawaiian households surveyed, 11 percent were living on Hawaiian Homestead Land (12,755 households) in 2019, similar to 2016. Also, among Native Hawaiian households, 20 percent had at least one member on the waitlist to receive a DHHL award (23,883 households) on which they intended to reside. Of those households, only about three-quarters (73.0%) were sure that they intend to have a house on that land. An additional 21,399 Native Hawaiian households stated that they have a household member eligible to apply for a Hawaiian Home Lands lease but were not yet a leaseholder nor an applicant."
