
A BILL FOR AN ACT

RELATING TO TRAFFIC VIOLATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-25, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "§291-25 Lights for motor vehicles, motorcycles, motor
4 scooters, motorized bicycles[-], electric foot scooters. (a)
5 [~~From thirty minutes after sunset until thirty minutes before~~
6 ~~sunrise, every]~~ Every motor vehicle moving upon any public
7 highway shall carry at the front thereof at least two lighted
8 head lamps, which shall display white lights of equal candle
9 power[-]:

10 (1) From thirty minutes after sunset until thirty minutes
11 before sunrise; or

12 (2) When visibility is less than five hundred feet.

13 The head lamps shall be securely mounted, not less than
14 twenty-two inches nor more than fifty-four inches above the road
15 surface when measured to the head lamp center, on a rigid part
16 of the vehicle designed specifically for head lamp installation
17 by the manufacturer, and so arranged, adjusted, and constructed



1 that, when the motor vehicle is fully loaded, any pair of
2 headlights under the conditions of use shall produce a light
3 sufficient to reveal any person, vehicle, or substantial object
4 on the highway straight ahead of the motor vehicle for a
5 distance of two hundred feet.

6 The light when measured at a distance of one hundred feet
7 directly in front of the motor vehicle, and at a height of sixty
8 inches above the level surface on which the motor vehicle
9 stands, shall not exceed two thousand four hundred apparent
10 candle power, nor shall this candle power be exceeded at a
11 greater height than sixty inches.

12 When measured at a distance of one hundred feet ahead of
13 the motor vehicle and seven feet or more to the left of the axis
14 of the same, and at a height of sixty inches above the level
15 surface on which the motor vehicle stands, the light shall not
16 exceed eight hundred apparent candle power.

17 (b) [~~During the time specified in subsection (a), every~~]
18 Every motorcycle, motor scooter, electric foot scooter, or
19 motorized bicycle while moving on a public highway shall carry,
20 at the front thereof, at least one lighted headlight which shall
21 give a light of such power and so distributed as provided in



1 subsection (a); provided that any motorcycle, motor scooter,
 2 electric foot scooter, or motorized bicycle with a side car or
 3 similar contrivance attached shall, in addition to the foregoing
 4 required light, carry on the side car or similar contrivance a
 5 lighted lamp visible from a point at least two hundred feet
 6 ahead of the vehicle. Any headlight required by this subsection
 7 shall display white light during the time and under the
 8 circumstances as specified in subsection (a), and shall be
 9 securely mounted, not less than twenty-four inches nor more than
 10 fifty-four inches above the road surface when measured to the
 11 headlight's center on a rigid part of the vehicle designed
 12 specifically for installation of a light by the manufacturer."

13 SECTION 2. Section 291-29, Hawaii Revised Statutes, is
 14 amended to read as follows:

15 "**§291-29 Lights for other vehicles.** All vehicles other
 16 than those specified in section 291-25 shall during the time and
 17 under the circumstances mentioned in that section when upon the
 18 public highway, carry a lighted light on the extreme width of
 19 each side so arranged that a light from the lamps shall be
 20 visible in every direction at least two hundred feet."



1 SECTION 3. Section 291-32, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) The use or operation of any motor vehicle not
4 equipped with lights in conformity with sections 291-25 to
5 291-31 upon the public highways is prohibited during the
6 ~~[period]~~ time and under the circumstances as specified in
7 section 291-25(a)."

8 SECTION 4. Statutory material to be repealed is bracketed
9 and stricken. New statutory material is underscored.

10 SECTION 5. This Act shall take effect upon its approval.
