A BILL FOR AN ACT

RELATING TO TRAFFIC.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 291C, Hawaii Revised Statutes, is
3	amended by adding a new section to part XII to be appropriately
4	designated and to read as follows:
5	"§291C- Motor scooter traffic prohibited; state capitol
6	area. No person shall operate a motor scooter within the
7	pedestrian mall running east to west between Richards Street and
8	Punchbowl Street that abuts the Hawaii state capitol building,
9	Iolani Palace, and the main branch of the Hawaii state library,
10	and upon which there has been erected a statue to honor Queen
11	Liliuokalani."
12	PART II
13	SECTION 2. There is appropriated out of the Oahu
14	transportation management area metropolitan planning
15	organization revolving fund the sum of \$ or so much
16	thereof as may be necessary for fiscal year 2019-2020 and the
17	same sum or so much thereof as may be necessary for fiscal year

- 1 2020-2021 for the expansion and development of the makai paved
- 2 walkway of the pedestrian mall between Richards Street and
- 3 Punchbowl Street that abuts the Hawaii state capitol building,
- 4 Iolani Palace, and the main branch of the Hawaii state library
- 5 to include a designated bicycle lane. The expansion and
- 6 development shall include widening the path no less than an
- 7 additional eight feet; the application of appropriate lane
- 8 markers; and posting of appropriate signage necessary to direct
- 9 cyclists to remain within the designated bicycle lane. Upgrades
- 10 shall visually reflect the historic nature of the capitol
- 11 district.
- 12 The sums appropriated shall be expended by the department
- 13 of transportation for the purposes of this Act.
- 14 PART III
- 15 SECTION 3. The department of accounting and general
- 16 services, department of transportation, and department of land
- 17 and natural resources shall work together to create a long-term
- 18 development plan to improve the pedestrian mall between Richards
- 19 Street and Punchbowl Street that abuts the Hawaii state capitol
- 20 building, Iolani Palace, and the main branch of the Hawaii state
- 21 library to create an attractive and visually impressive

- 1 pedestrian and bicycle mall that reflects the historic nature of
- 2 the state capitol, Iolani Palace, and the capitol district while
- 3 addressing the needs and safety of pedestrians and cyclists who
- 4 use the area.

- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect on July 1, 2050.
