### A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State has been
- 2 going through an affordable housing crisis for decades. Some
- 3 major impediments to the development of housing in Hawaii
- 4 include the lack of reasonably priced lands, high development
- 5 costs, government regulations, community opposition, and much
- 6 more. Act 39, Session Laws of Hawaii 2018, was a step toward
- 7 addressing the affordable housing crisis by appropriating
- 8 \$200,000,000 into and out of the rental housing revolving fund
- 9 and \$10,000,000 into and out of the dwelling unit revolving
- 10 fund. However, more needs to be done in order to create an
- 11 affordable Hawaii.
- 12 The legislature further finds that the special action team
- on affordable rental housing established pursuant to Act 127,
- 14 Session Laws of Hawaii 2016, recommended that the legislature
- 15 commit to appropriating \$100,000,000 to the rental housing
- 16 revolving fund and \$10,000,000 to the dwelling unit revolving

- 1 fund every year for the next ten years in order to increase
- 2 developer interest in affordable rental projects in the State.
- Accordingly, the purpose of this Act is to appropriate
- 4 funds into and out of the rental housing revolving fund and the
- 5 dwelling unit revolving fund to meet the recommendations of the
- 6 special action team on affordable rental housing.
- 7 SECTION 2. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$100,000,000 or so
- 9 much thereof as may be necessary for fiscal year 2020-2021 to be
- 10 deposited into the rental housing revolving fund established
- 11 pursuant to section 201H-202, Hawaii Revised Statutes.
- 12 SECTION 3. There is appropriated out of the rental housing
- 13 revolving fund established pursuant to section 201H-202, Hawaii
- 14 Revised Statutes, the sum of \$100,000,000 or so much thereof as
- 15 may be necessary for fiscal year 2020-2021 for the purposes for
- 16 which the fund is established.
- 17 The sum appropriated shall be expended by the Hawaii
- 18 housing finance and development corporation for the purposes of
- 19 this Act.
- 20 SECTION 4. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$10,000,000 or so

- 1 much thereof as may be necessary for fiscal year 2020-2021 to be
- 2 deposited into the dwelling unit revolving fund established
- 3 pursuant to section 201H-191, Hawaii Revised Statutes.
- 4 SECTION 5. There is appropriated out of the dwelling unit
- 5 revolving fund established pursuant to section 201H-191, Hawaii
- 6 Revised Statutes, the sum of \$10,000,000 or so much thereof as
- 7 may be necessary for fiscal year 2020-2021 for the purposes for
- 8 which the revolving fund is established.
- 9 The sum appropriated shall be expended by the Hawaii
- 10 housing finance and development corporation for the purposes of
- 11 this Act.

12 SECTION 6. This Act shall take effect on July 1, 2020.
