## A BILL FOR AN ACT

RELATING TO CANNABIS FOR MEDICAL USE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that studies have shown

2 the benefits of using cannabis to alleviate certain serious

3 illnesses. The legislature further finds that several states

4 permit the sales of edible cannabis products, either for

5 recreational use or for medical use. These states generally

6 place restrictions on edible cannabis products, such as limiting

7 the amount of psychoactive ingredients per serving, banning

8 manufacturers from making candy-like edibles that might attract

9 children, and requiring proper labeling. Proper labeling and

10 portioning of edible products are especially important, as

edible cannabis products are responsible for the majority of

12 cannabis intoxications.

13 The legislature also finds that some states have imposed

14 additional regulations on cannabis and manufactured cannabis

15 products, including a product recall system and the use of a

universal symbol to clearly identify products containing

18	SECT	TION 2. (a) The department of health shall convene a	
19	working group to propose standards, regulations, protocols and		
20	recommendations for legislation regarding edible medical

3	(1)	Standards, regulations, and protocols for the
4		manufacture and sale of edible medical cannabis

6	(2)	A universal symbol which will readily identify

7		cannabis products to users and which is suitable to be
8		displayed on all edible medical cannabis product
9		packaging;
10	(3)	Quality control procedures for edible medical cannabis
11		products with a particular focus on developing a
12		recall system for retail products; and
13	(4)	Any other pertinent issues relating to edible medical
14		cannabis products that may be sold at medical cannabis
15		dispensaries.
16	(e)	The working group meetings shall be open to the public
17	and shall	include a segment for public comment.
18	(f)	The working group shall submit a report of its
19	findings a	and recommendations, including any proposed
20	legislatio	on, to the legislature no later than twenty days prior

to the convening of the regular session of 2020.

- 2 working group with research, take notes at meetings, provide
- 3 minutes of meetings, and prepare the working group's final
- 4 report.
- 5 (h) The working group shall be dissolved on June 30, 2021.
- 6 SECTION 3. This Act shall take effect upon its approval.
