## SENATE CONCURRENT RESOLUTION

## ENCOURAGING PARTICIPATION IN THE COMMEMORATION OF THE SEVENTY-FIFTH ANNIVERSARY OF THE UNITED NATIONS.

WHEREAS, in 1945, nations were in ruins, World War II was 1 over, and the world wanted peace; fifty-one countries gathered 2 in San Francisco that year on October 24, to sign a Charter, 3 creating a new organization, the United Nations; and 4 5 WHEREAS, for seventy-five years, the United Nations has 6 committed to help build a better world as envisioned by its 7 founders, and serves as a beacon of light for multilateralism, 8 international peace and security, human rights, social and 9 economic well-being, and diplomacy; and 10 11 WHEREAS, the active participation of global civil society, 12 governments, and world leaders is an essential component for the 13 continued inclusiveness, problem-solving, collaborative goal 14 setting, effectiveness, and durability of the United Nations, 15 and fulfillment of the United Nations' Sustainable Development 16 Goals (SGDs) by 2030; and 17 18 WHEREAS, in celebration of the seventy-fifth anniversary, 19 on June 14, 2019, the United Nations General Assembly adopted a 20 Resolution to commemorate the seventy-fifth anniversary of the 21 establishment of the United Nations under the theme, "The future 22 23 we want, the United Nations we need: reaffirming our collective commitment to multilateralism"; and 24 25 WHEREAS, Hawaii enthusiastically supports the United 26 Nations commitment to implementation of major global campaigns 27 from the Paris Agreement and the SGDs by 2030; and 28 29 WHEREAS, Hawaii was proposed as a potential host for the 30 United Nations headquarters to serve as a diplomatic hub for all 31 humanity; and 32 33

1 WHEREAS, in order for Hawaii to continue to serve as a 2 starlight for the rest of the world in setting policies on 3 issues of sustainability and conservation, it is essential that 4 the State demonstrate its full commitment to the goals set on 5 the international stage by United Nations conferences and 6 summits; and 7

8 WHEREAS, the Hawaii State Legislature recognizes its 9 important role in promoting and supporting the principles, 10 unique mission, and indispensable work of the United Nations in 11 order to address the most pressing issues facing humanity both 12 globally and locally; now, therefore,

BE IT RESOLVED by the Senate of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2020, the House of Representatives concurring, that the Legislature encourages the citizens of Hawaii to participate in the commemoration of the seventy-fifth anniversary of the United Nations; and

20 BE IT FURTHER RESOLVED that the Legislature appeals to 21 members of the United States Congress, State and local public 22 officials, civic leaders, educational institutions, the media, 23 and the general public to support the principles and vital work 24 of the United Nations; and

BE IT FURTHER RESOLVED that the Legislature encourages robust participation and continued leadership of the Government of the United States of America as well as local state and county government in fulfillment of United Nations programs and goals to build a better and sustainable world for all peoples locally, nationally, and globally; and

BE IT FURTHER RESOLVED that certified copies of this 33 Concurrent Resolution be transmitted to the Majority Leader of 34 the United States Senate; Speaker of the United States House of 35 Representatives; Hawaii's congressional delegation; Governor of 36 the State of Hawaii; President of the Senate; Speaker of the 37 38 House of Representatives; Comptroller; Chairperson of the Board 39 of Agriculture; Attorney General; Director of Finance; Director of Business, Economic Development, and Tourism; Director of 40 Commerce and Consumer Affairs; Adjutant General; Chairperson of 41 the Board of Education; Superintendent of Education; Chairperson 42



of the Hawaiian Homes Commission; Director of Health; Director 1 of Human Resources Development; Director of Human Services; 2 Director of Labor and Industrial Relations; Chairperson of the 3 Board of Land and Natural Resources; Director of Public Safety; 4 Director of Taxation; Director of Transportation; President of 5 the University of Hawai'i System; Administrator of the State 6 Procurement Office; Mayor of each county; and Chairperson of 7 each county council, who in turn is requested to provide a copy 8 to each neighborhood board chairperson in their respective 9 county; and the Executive Secretary of the Neighborhood 10 Commission Office of the City and County of Honolulu. 11
