## SENATE CONCURRENT RESOLUTION

REQUESTING THE HAWAII TOURISM AUTHORITY TO CONVENE AN INTERDISCIPLINARY TASK FORCE TO DEVELOP A FRAMEWORK FOR A SEA LEVEL ADAPTATION AND RESILIENCE PLAN FOR THE WAIKIKI DISTRICT.

WHEREAS, Hawaii is experiencing the impacts of climate 1 change, including the effects of sea level rise and coastal 2 erosion, which is of particular concern to the State given our 3 4 island topography and substantial coastal exposure; and 5 WHEREAS, the Senate of the Twenty-Ninth Legislature of the 6 7 State of Hawaii, 2017, created the Hawaii Climate Change Mitigation and Adaptation Commission ("Climate Commission"), 8 which published the Hawaii Sea Level Rise Vulnerability and 9 Adaptation Report in 2017 detailing findings and recommendations 10 for mitigating and adapting to sea-level rise; and 11 12 13 WHEREAS, the City and County of Honolulu established the Office of Climate Change, Sustainability and Resiliency 14 ("OCCSR") by City Charter in 2016, to promote community 15 resilience and, among other recommended actions, to preserve 16 natural shorelines and beaches as buffers to protect coastal 17 18 communities; and 19 WHEREAS, OCCSR is tasked with tracking climate change 20 21 science and potential impacts on Oahu's facilities and communities, coordinating actions and policies of the county's 22 departments to increase community preparedness and resilience, 23 supporting resilient infrastructure in response to the impacts 24 of climate change, and integrating sustainable and environmental 25 values into Oahu plans, programs, and policies, in part, through 26 the City's resilience strategy; and 27 28 29 WHEREAS, the Waikiki Special Improvement District is a

30 low-elevation, high-density, urban coastal community and home to
 31 approximately thirty thousand residents, hosts approximately

five million tourists annually, and generates about thirty 1 percent of the gross domestic product of the State and is 2 vitally important for its residents, visitors, public and 3 private property, and for the economic well-being of the entire 4 5 State; and 6 WHEREAS, research has shown that inundation and flooding of 7 Waikiki related to climate change will occur from multiple 8 sources: storm drain backflow, groundwater inundation, wave run-9 up and marine hydrostatic (passive) flooding, heavy 10 precipitation, and watershed flooding associated with extreme 11 weather events; and 12 13 WHEREAS, the City and County of Honolulu established the 14 Waikiki Beach Special Improvement District Association in 2015 15 to improve the coordination and management of the beach systems 16 in Waikiki, and the Association has been engaged in 17 18 comprehensive adaptation planning and actively managing Waikiki's beach systems for resilience to projected climate 19 20 change impacts, including sea-level rise; and 21 22 WHEREAS, Waikiki like so many of the other resort 23 communities in the State, is in a sea level rise exposure area 24 and requires a comprehensive adaptation and resilience plan to deal with projected climate change and sea-level rise; and 25 26 27 WHEREAS, Waikiki can serve as a pilot and demonstration project for other coastal communities that may develop a 28 29 comprehensive sea-level rise adaptation and community resilience plan for the protection of its residents, visitors, critical 30 infrastructure, and public and private property; and 31 32 33 WHEREAS, the Hawaii Tourism Authority is charged with managing tourism for the benefit of the State of Hawaii to 34 35 ensure that the State remains a competitive destination within the global tourism industry, and has the expertise to 36 effectively coordinate the diverse public and private 37 38 stakeholders in preparing a Waikiki resilience plan; and 39 WHEREAS, it is in the best interest not only of the Waikiki 40 District but, as importantly, for other coastal communities, the 41 City and County of Honolulu and the State of Hawaii to support a 42

Waikiki task force in proactively creating a framework for a 1 sea-level rise mitigation and adaptation plan for the Waikiki 2 community; now, therefore, 3 4 BE IT RESOLVED by the Senate of the Thirtieth Legislature 5 of the State of Hawaii, Regular Session of 2020, the House of 6 Representatives concurring, that the Hawaii Tourism Authority is 7 8 requested to convene an interdisciplinary task force to develop 9 a framework for a comprehensive sea level adaptation and resilience plan for the Waikiki Special District; and 10 11 12 BE IT FURTHER RESOLVED that the task force is requested to include the following members: 13 14 The President and Chief Executive Officer of the (1)15 Hawaii Tourism Authority, or the President's designee, 16 who is requested to serve as the chair of the task 17 force; 18 19 (2) The Chairperson of the Board of Land and Natural 20 Resources, or the Chairperson's designee; 21 22 The Director of the Office of Planning, or the 23 (3) Director's designee; 24 25 26 (4) The Deputy Director for Water Resource Management, or the Deputy Director's designee; 27 28 (5) The Coordinator of the State Climate Commission, or 29 the Coordinator's designee; 30 31 The Executive Director of the City and County of (6) 32 33 Honolulu Office of Climate Change, Sustainability and 34 Resilience, or the Executive Director's designee; 35 The President of the Senate, or the President's 36 (7) 37 designee; 38 The Speaker of the House of Representatives, or the 39 (8) Speaker's designee; 40 41
