# SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO PROVIDE A SCHOOL RESOURCE OFFICER OR REGISTERED GUARD AT EACH ELEMENTARY SCHOOL AND STATE PREKINDERGARTEN PROGRAM.

1           WHEREAS; in March 2018 at Kipapa Elementary School, a boy  
2 reported that a man approached him in a school restroom and  
3 tried to grab his hand; and  
4

5           WHEREAS, on December 12, 2019, a manhunt in Waipahu  
6 prompted officials at Waipahu High School and August Ahrens  
7 Elementary School to place those schools on lockdown; and  
8

9           WHEREAS, on February 27, 2020, following a report of a man  
10 armed with a gun in Ewa Beach, Ilima Intermediate School,  
11 Pohakea Elementary School, Kaimiloa Elementary School, and  
12 Campbell High School initiated a lockdown; and

14           WHEREAS, some elementary school students may not be old  
15 enough to properly assess potential dangers and act accordingly;  
16 and

18           WHEREAS, posting dedicated security personnel at elementary  
19 schools and public facilities that provide prekindergarten care  
20 will help to deter the presence of individuals that do not  
21 belong on school campuses, identify potentially dangerous  
22 situations, and ensure that children are protected and can learn  
23 in a safe environment; now, therefore,

25           BE IT RESOLVED by the Senate of the Thirtieth Legislature  
26 of the State of Hawaii, Regular Session of 2020, the House of  
27 Representatives concurring, that the Department of Education is  
28 urged to provide a school resource officer or guard registered  
29 pursuant to Chapter 463, Hawaii Revised Statutes, at each  
30 elementary school and state prekindergarten program during hours  
31 when students are expected to be on campus; and

1 BE IT FURTHER RESOLVED that the Department of Education is  
 2 urged to provide multiple school resource officers or registered  
 3 guards at larger elementary schools and prekindergarten  
 4 programs; and

 6 BE IT FURTHER RESOLVED that if necessary, the Department of  
 7 Education is urged to seek federal grants and county funding for  
 8 the costs of providing school resource officers or registered  
 9 guards; and

 11 BE IT FURTHER RESOLVED that certified copies of this  
 12 Concurrent Resolution be transmitted to the Superintendent of  
 13 Education, Chairperson of the Board of Education, and Mayor of  
 14 each county.
